

#### **Aarhus centers Structure**







# To Assist the Government on Aarhus Convention Compliance Committee Decision implementation

- 4. Invites the Party concerned to take the necessary legislative, regulatory, and administrative measures and practical arrangements to ensure that:
- (a) Thresholds for activities subject to an EIA procedure, including public participation, are set in a clear manner;
  - (b) The public is informed as early as possible in the decision-making procedure, when all options are open, and that reasonable time frames are set for the public to consult and comment on project-related documentation;
    - (c) The responsibilities of different actors (public authorities, local authorities, developer) in the organization of public participation procedures are defined as clearly as possible;
      - (d) A system of prompt notification of the public concerned on final conclusions of environmental expertise is arranged, e.g., through the website of the Ministry of Nature Protection;

However the absence of the necessary legislative, regulatory, and administrative measures to ensure proper public participation remains a challenge. We would like to thank our Secretariat colleagues for their support on promoting implementation of the Aarhus convention by providing opportunity to us to involve more expertise on the subject via Extra-budgetary project on South Caucasus Aarhus Centers.



Hrazdan Aarhus Centre was informed that it was planned to open mine site nearby the city. From the project provided by the mining company it was clear that city is under danger. The Center mobilized public, involved authorities, negotiated with the Government, sets up a special expert group to learn the documentation, involved youth, media, well - known people of art, sport and civic activists. Finally the Government cancelled the mine project.

## **Aparan Aarhus Centre: Good Practice Metal mining industry and community safety**

Tukhmanuk gold mine in the community Melik



Local people from the Meliq village applied to the Aparan Aarhus Center with request to assist them on their struggle against the mining company which plans to build the third tailing ipso facto jeopardies the village existence due to already high pollution and contamination level from the mining operation of the company and the two liking tailings as well as landslide zone. The Aparan Center involved experts, media, organized numerous round-table discussions, briefings and debates from which was clear that Environmental Impact Assessment was conducted not in a proper way. The decision of the Ministry of Nature Protection was to reject the project of the mining company on the third tailing construction.




