Survey pilot to be conducted in November

To generate data and create an evidence base on different forms of violence against women (VAW) to be used for improved policymaking by key actors and international stakeholders.

The study will furthermore explore VAW in conflict and post-conflict situations.

Key facts of the study:

This is a regular update prepared by the OSCE Gender Section Project Team of the project "OSCE Survey on the Well-being and Safety of Women in South East Europe, Eastern Europe and the South Caucasus"¹.

- This is a computer based face-to-face population survey conducted by female interviewers;
- 1,750 women will be interviewed per location (sample size) and female IDP's will be oversampled where relevant:
- Women from 18–74 years will be asked about their experiences of violence since the age of 15, in childhood and within the last 12 months:

- Relevant Statistical Offices are asked for their support and quidance;
- Data will be collected by local research companies under the guidance of Ipsos MORI;
- Qualitative research will be done in order to take the local contexts into account and to explore the situational of minorities and vulnerable groups.
- 1. Proposed coverage: Georgia, Armenia, Ukraine, Moldova, Albania, the former Yugoslav Republic of Macedonia, Serbia, Montenegro, Bosnia and Herzegovina.

 The survey will also be conducted in Kosovo. All references to Kosovo, whether to the territory, institutions or population, in this text should be understood in full compliance with United Nations Security Council resolution 1244.

As a result of the 2nd meeting of the High-Level Advisory Group, increase in sample size and active reach out to relevant Statistical Offices was agreed

On 15th March 2017, the second meeting of the High-Level Advisory Group was held in the margins of the annual meeting of the Commission on the Status of Women (CSW) in New York. The meeting gathered representatives of UN Women, UNFPA, UNDP, EIGE, the Council of Europe's GREVIO Committee and the EU.

It provided an opportunity for the OSCE Project Manager to update the participants about the current status of the project.

As a result, the sample size was increased from originally 1,500 to 1,750 women per location. Furthermore, the Project Team has started actively reaching out to relevant Statistical Offices.

Initial Qualitative Research conducted to ensure the survey data is analysed in the local context

Desk research and Key Expert Interviews were conducted in May and June 2017. Background information was collected on legislative and institutional framework, monitoring data, and prevention and protection mechanisms. The collected information will be used to put the survey findings into the local context of the regions covered by the survey.

Reaching out to key stakeholders to ensure they are aware of the purpose of the study and its benefits

In the past months, the Project Team has reached out to key stakeholders working on gender issues and violence against women in the regions where the survey will be conducted. The goal was to inform all involved actors and raise awareness of the project.

The Project Manager delivered a presentation of the project to key local governmental and non-governmental as well as international stakeholders and received input, feedback and suggestions on the way forward. WebEx meetings were held with the OSCE Mission to Kosovo and stakeholders in Albania and Montenegro.

Furthermore, the Project Manager visited Serbia, Ukraine, Moldova, Bosnia and Herzegovina and Georgia.

Throughout the consultation process the Project Team was strongly supported by colleagues working in the OSCE field operations.

Strengthening the co-operation with relevant Statistical Offices and sharing information and expertise will be crucial for the successful implementation of the project. The Project Team has therefore reached out to relevant Statistical Offices and asked them to appoint focal points for further communication.

Questionnaire is finalised and ready for piloting in all locations

New questions have been tested in May and June 2017 in Ukraine, Bosnia and Herzegovina, Serbia and in Kosovo. Around 20 women were interviewed per location. The conflict related questions intend to examine the prevalence and forms of violence women experience in conflict and post-conflict situations. The aim of the questions on attitudes, norms and disclosure is to explore the reasons behind gender bias and possible low disclosure rates.

As a result of the cognitive testing, the questionnaire was streamlined to avoid re-traumatizing women who have experienced conflict related violence. This will be done by fully integrating the relevant questions into the existing sections asking about different types of violence. The new questions on attitudes, norms and disclosure proved to work very well.

Looking ahead

Until the end of the year the Project Team will work closely with Ipsos MORI to finalize the development of all research materials that will be used during the pilot and the main stage fieldwork phase. The Project Manager will present the project at the Work Session on Gender Statistics, organized by the United Nations Economic Commission for Europe (UNECE), in Belgrade, Serbia from 29 November to 1 December 2017.




