


# Political environment: In which direction is Serbia heading...



Basic indicator of the general mood – assessment of the direction in which Serbia is going – shows an increase of optimism as of the commencement of the campaign for adoption of the new Constitution and calling of general elections




#### Political environment: Confidence in institutions

#### Political environment: Serbia's predominant problems








### Political environment: Personal political convictions

Defining own political convictions is quite confused, and in excess of one third of citizens is incapable of defining their own political convictions



# Awareness of the organisation and manner of operation of the Hague Tribunal


To what extent would you say that you are aware of the organisation and manner of operation of the Hague Tribunal?



In relation to April 2005 a significantly greater percentage of citizens consider themselves informed of the organisation and manner of operation of the Hague Tribunal




Have you heard of the existence of the permanent International Criminal Court that should in future try accused for international crimes?






Could you list any domestic judicial authorities trying the accused for war crimes?



In relation to April 2005 a considerably greater percentage of citizens is capable of listing some domestic judicial authorities trying the accused for war crimes




Are you informed with the work of the War Crimes Prosecutors' Office of the Republic of Serbia?









#### Assessment of the course of war crimes trials to date before domestic courts



In average, assessment of the course of war crimes trials to date have not significantly changed: as in previous years, almost half of those stating some awareness of these trials have given them poor marks




#### Assessment of the course of war crimes trials to date before domestic courts



In average, best marks for the course of war crimes trials to date are given by DS supporters, and the worst by SRS supporters




Should the general public be better informed of the course of the war crimes trials before domestic courts?







From what media do you obtain information on the course of the trials for war crimes?





Opinion regarding the Hague Tribunal: views regarding cooperation, confidence in and perception of the mission of the Hague Tribunal




#### Views on cooperation of Serbia with the Hague Tribunal



Percentage of citizens who consider that there should be more cooperation with the Hague Tribunal has decreased by 15% in relation to 2003

Only 15% of the populace, stable over the last 4 years, consider that there should be cooperation with the Hague Tribunal in order for justice to prevail, while others consider that cooperation should be implemented for utilitarian reasons






The majority of antagonists in respect of cooperation with the Hague Tribunal are among SRS supporters.





To what extent does the position of a particular party (politician) in respect of the Hague Tribunal or war crimes trials before domestic courts impact on your vote in favor of that party or support for that politician?



For almost one half of the citizens the position of a party regarding the Hague Tribunal and war crimes trials before domestic courts are not of importance for their decision to vote for or against such party. The position on these issues in deciding whether to support a party have the greatest significance to DS and SRS supporters.









Majority of citizens (53%) believe the government has done everything in its power to meet the obligations towards the Hague Tribunal, but are most frequently ambivalent as concerns the cooperation with the Hague Tribunal (44%); only 17% gives the government high grades for cooperation with the Hague Tribunal









A high number of citizens has no clear position regarding contribution of the President of Serbia and the Serbian Assembly towards cooperation with the Hague Tribunal (40% and 45%).

Considerably greater number of citizens believe in the contribution of the President of Serbia (40%) than in the contribution of the Assembly (24%)









Supporters of the DSS-NS coalition give highest grades to the government and have the highest confidence in its efforts to meet the obligations towards the Hague Tribunal








Regarding the contribution of the President of Serbia towards cooperation with the Hague Tribunal there are no significant differences between supporters of various political parties, while as regards the contribution of the Assembly the differences are somewhat greater. DS supporters grade the contribution of the President of Serbia somewhat better than others, and worse as regards the contribution of the Serbian Assembly.






Most citizens consider the army and the police unready to renounce individuals from their own ranks who committed war crimes

What is the foremost motive of persons accused by the Hague Tribunal to voluntarily surrender?






The number of persons who believe that the foremost motive for voluntary surrender was pressure from the government has considerably decreased, and the number of those who consider that this is a way to defend oneself from charges has increased.

In relation to the preceding year there is a notable increase in the number of citizens who do not have a position regarding the issue of the motive for voluntary surrender and admission of guilt by the Hague defendants.

What is the foremost motive of persons accused by the Hague Tribunal to voluntarily surrender?




Perception of the motive of defendants for voluntary surrender are perceived differently by supporters of different parties, however there is no consensus among those supporting the same party





Responses of the part of the canvassed citizens who doubt the impartiality of the Hague Tribunal



Confidence that the Hague Tribunal will try defendants of Serbian nationality impartially and only on basis of proven facts




The greatest mistrust in the impartiality of the Hague Tribunal is among SRS and DSS-NS coalition supporters

How do the trials before the Hague Tribunal affect war crime victims and their families?




In comparison to the previous year, the number of citizens who consider that victims and their families perceive the Hague Tribunal as very unjust has decreased


What do you think is the prevalent purpose of trying war crimes before domestic courts?



In comparison with the previous year the number of citizens who consider the purpose of trying war crimes before domestic courts is to show that Serbian society is capable of facing up to war crimes has decreased, and there is an increase in the number of those who believe that the purpose is to put the all the blame for war crimes on Serbs




#### What do you think is the prevalent purpose of trying war crimes before domestic courts?


What had the greatest impact on citizens to form the stated view on the objective of war crimes trials before domestic courts?



In the final outcome, will the war crimes trials achieve the expected objective?






% of the populace who believe that war crimes trials before domestic courts will succeed in achieving the assumed objective



Without notable change in respect to the previous year: although generally low, still the greatest conviction that war crimes trials before domestic courts will succeed in achieving their objective was displayed among citizens who perceive the purpose in showing that Serbian society is capable of facing up to war crimes and guilt of their compatriots.








Most citizens are consistent in thinking that it is better to try war crimes in Serbia than in the Hague, and state the reasons for such thinking that adjudication would be more fair

#### Is it better to try war crimes in Serbia than in the Hague?




SRS and DSS-NS supporters in significantly larger percentage consider it better to conduct war crimes trials in Serbia than in the Hague



Will the War Crimes Prosecutor be independent in proceedings or will he be exposed to political pressures?




Although majority of citizens consider our judicial system ready to adjudicate war crimes, less than half of citizens think that the War Crimes Prosecutor' Office would have the fortitude to initiate all proceedings, and only every fourth citizen (less than in previous years) consider that the Prosecutor would be independent in his decisions

Will the judges of the War Crimes Chamber of the Belgrade District Court resist the public pressure and public opinion during the proceedings in progress or those that are expected to commence Will the security services attempt to obstruct investigation of their officers?




The number of citizens who think that judges will be able to resist public pressure has considerably decreased as compared to previous years. However, also the number of citizens has decreased who consider that security services would attempt to obstruct investigation of their officers. An increased number of citizens hold no views on this issue




## Opinion of the domestic judicial authorities in charge of war crimes

How will the media inform on proceedings before the War Crimes Chamber of the Belgrade District Court?






As compared to previous years a lesser number of citizens expressed conviction of impartial adjudication in respect of the nationality of the accused, while there is a rise in those who doubt the objective of media informing of procedures before the War Crimes Chamber of the Belgrade District Court

Have you heard that some cases currently before the Hague Tribunal will be transferred to the domestic war crimes court?




More than half the citizens are still not aware, even in this year, that some cases will be transferred to the domestic war crimes court.






Is facing up to events in the wars in the former SFRY important for the future of the country?



The trend continues also in this year of the decrease in number of citizens who consider that facing up to the truth and accepting responsibility is important for the future of the country as the only road towards a better future and good relations with neighbors and the international community



Is facing up to events in the wars in the former SFRY important for the future of the country?




As regards the viewpoint on the importance of facing the truth for the future of Serbia the biggest contrast is between DS and SRS supporters

What would be the public effect of trials before domestic courts if shown that indicted Serbs are guilty of war crimes?



As compared to previous years, there is a significant decrease of the number of citizens who consider that trials before domestic courts would contribute to awareness of the truth, as well as in the number of citizens who believe that the general public would fully accept any truth uncovered before domestic courts.


On the other hand, there is a continued trend of increase in the number of citizens who think that the actual truth will never be uncovered




#### Facing the truth and the role of the Hague Tribunal and domestic judicial authorities in its acceptance

Would you be willing to testify before the domestic court?






As in previous years a considerably larger percentage of citizens expressed readiness to testify before domestic courts than to give statements to Hague Tribunal investigators. However, the readiness to testify before either court is consistently decreasing from year to year.



## Facing the truth and the role of the Hague Tribunal and domestic judicial authorities in its acceptance




An even smaller number of citizens would testify before courts in Croatia, BiH and Kosovo. However, as compared to the previous year due to less readiness to testify before the Hague Tribunal, this difference is considerably smaller.

In your opinion, will trials before domestic courts contribute to the process of reconcilliation?




Will enactment of the new Constitution in Serbia promote establishing good neighborly relations between ethnic communities in the region?



More than 40% of citizens expect that enactment of the new Constitution will contribute to establishing good neighborly relations




Will enactment of the new Constitution in Serbia promote establishing good neighbourly relations between ethnic communities in the region?



Only just over one third of citizens expect that the new government will cooperate with the Hague Tribunal more successfully and will have more success in resolving the problems of wartime heritage

Most citizens are of the opinion that the government should continue with diplomatic relations with countries that recognise Kosovo as an independent state. Such views are least represented among SRS supporters
