

**OSCE Extracurricular Workshop in  
International Criminal Law and Transitional Justice  
CALL FOR APPLICATIONS**

The OSCE Mission to Bosnia and Herzegovina is organizing an extracurricular Workshop on International Criminal Law and Transitional Justice.

The workshop is designed as an advanced, skill-based training program for senior law students, as well as students of criminalistics and criminology at Bosnian-Herzegovinian universities, with the goal of equipping future practitioners with crucial legal capacities which will enable them to enter positions relating to transitional justice and international criminal law, including the justice sector, prepared to tackle the specific issues arising in and related to war crimes cases.

In addition, the Workshop will serve as a forum for discussion on contemporary issues in this field, with the aim of promoting legality and acceptance of International Criminal Law and its application in Bosnia and Herzegovina, as well as discussing its role within a broader Transitional Justice approach, as an overreaching mechanism for dealing with the past.

The Workshop provides law students with a hands-on opportunity to build knowledge and skills on technical topics with eminent legal practitioners and other transitional justice professionals in the country. The Workshop will also introduce students to the mechanics of trial monitoring and its importance for ensuring the impartiality, transparency, and fairness of war crimes processing in BiH and beyond.

Finally, the workshop will be an opportunity for students to learn about the important work of the OSCE Mission to BiH and its central role in building a stronger judiciary system in Bosnia and Herzegovina, as well as ensuring that war crimes cases are processed fairly and in accordance with international standards.

## **STRUCTURE**

The Workshop consists of 12 weekly sessions, each three hours in length, to be held between October and December 2016. Students will be provided with complex fact patterns prior to the beginning of the Workshop and topic-specific materials prior to individual classes, which they will be expected to read and prepare to discuss in advance. A typical session will consist of a short theoretical component, led by a practitioner or expert, which will be followed by a simulated exercise in small groups of students, which will require students to apply the knowledge they have gained through the readings and the theoretical component of the sessions. Finally, students will convene once more with the practitioner to engage in interactive discussion regarding the outcomes of the simulated exercise. In the last session the participants will demonstrate the knowledge and skills they have gained by participating in a moot court exercise.

A certificate of completion and highlighted achievement will be awarded to students who successfully complete the program.

## WHO CAN APPLY

The program will take place in Sarajevo and is aimed at students in their third year of legal studies and beyond, including master's students. Students of all universities in Bosnia and Herzegovina are encouraged to apply, with no fee to attend, but unfortunately at this time the Mission is unable to cover travel and/or accommodation expenses of students outside the Sarajevo area. Please note that the working languages will be BCS and English, and working command of each language is required for participation in the Workshop. Since the workshop's format is intensive and based primarily on student interaction and participation, **attendance is required at every session for successful completion of the course.** Therefore, students who anticipate that they will not be able to attend one or more sessions due to other commitments need not apply.

## HOW TO APPLY

Applications must be submitted in the English language only.

The personal statement should contain a maximum of 500 words and provide answers to the following questions:

- 1) Why do you consider yourself to be a good candidate for this programme?
- 2) How do your past experience and future goals relate to the programme?
- 3) How do you believe the programme will help you in your intended career path?

On the basis of submitted applications the Mission will select up to 20 participants.
