Conference focus

The focus of this conference will be on the Albanian parliamentary system in a comparative and inter-disciplinary perspective. Within an international community of parliamentary researchers, the development and memory of Parliament, as well as parliamentary procedures and the main functions of Parliament will be discussed. Reflections on the role of women and transparency through involvement of civil society and academia will also be part of the work carried out by parliamentary scholars, experts and practitioners, who will unite in discussion and reflections on the concept and the reality of parliamentarianism. These reflections will also include thoughts on the future development of the parliamentary system.

Background

When the Albanian Parliament, then called the National Assembly, came into being in 1920, one of its first acts was to adopt a set of rules of procedure, thus recognizing that parliamentary procedure distinguishes itself from other decision-making processes by following a high regulatory standard. Only if the formal rules of procedure are adhered to, the outcome of the legislative process may and will acquire the legitimacy that it needs, to gain the wide public acceptance required to make the laws an effective instrument to govern institutional and individual behaviour and interaction in the public sphere.
