(ii) Prices shall be quoted in USD, CIP Tashkent and as per Section I, Quotation Submission Form and Section II, Technical Specifications and Requirements.

(iii) Prices shall be quoted excluding taxes.

(iv) Your quotation shall be valid for a period of 20 calendar days from the deadline for receipt of quotation.

- (v) Your quotation shall bear the RFQ Reference Number and Title.
- 7. Quotation determined to be substantially responsive to the requirements specified in this RFQ will be evaluated by comparison of their prices.
