The first day of the conference will take place at the Hotel Odessa. The second and third day of the conference will take place on board of a high-speed vessel "Kryms'ka Strila" which will cruise to Vylkove, Mykolayiv and Ochakiv. The participants will be brought back to the hotel for the overnights.

1. Participation

Representatives of OSCE participating States, OSCE institutions and field presences, representatives of International Organizations and representatives of business community, Non-Governmental Organizations and academic community will participate in the Conference. The Partners for co-operation and the Mediterranean Partners for co-operation are also invited to attend the Conference.

The Conference should stimulate a free-flowing discussion out of which recommendations to the OSCE and its participating States should emerge. *To this end, no formal interventions in the form of prepared statements are envisaged.* However, written materials may be submitted in advance for circulation by the OSCE Secretariat. **No fee for participation is requested.**

2. WORKING MODUS OF THE SESSIONS

The **Plenary Sessions** will have presentations of expert speakers followed by discussions. A moderator will facilitate the discussion and a Rapporteur will summarize the key issues discussed.

Nationals of the rest of the OSCE countries and Partners for Co-operation are exempted from visa.

Participants must be in possession of the appropriate identity documents for travel to Ukraine

B.1. TRANSPORTATION FROM THE AIRPORT TO THE HOTEL ODESSA:
