Supply and Delivery of 4WD Light Motor Vehicles and Provision of Related Services to the OSCE

The Secretariat of the Organization for Security and Co-operation in Europe (hereinafter called "the OSCE") invites sealed bids from qualified suppliers for the supply and delivery of 4WD light motor vehicles, accessories and service parts (hereinafter called "the Goods") and the provision of related services (hereinafter called "the Related Services").

The objective of this tender is to obtain competitive bids and enter into corporate window contract(s) with the successful bidder(s).

The OSCE Secretariat located in Vienna and/or the OSCE missions/institutions will be issuing the individual Purchase Orders to the selected supplier(s) on an "as and when" required basis that shall constitute the basis for the supply and delivery of the Goods and/or the provision of Related Services by the supplier(s) to the locations specified in such Purchase Orders.

It is expected that the contract duration shall be twelve (12) months from the date of contract signature with possibility of two annual extensions. An aggregate duration of the contract placed as a result of this tender shall not exceed three (3) years. Throughout the term of the contract, the OSCE shall be under no obligation to buy any or all of the Goods specified in the bidding documents (hereinafter called "the Bidding Documents") from the contractor on the basis of the terms and conditions of the corporate window contract(s).

The estimated quantity of purchases for the first year of the proposed contract(s) is up to 50 vehicles. Please note that this is an indicative quantity which can vary significantly depending on the OSCE operational requirements. The OSCE cannot confirm to the successful company any minimum level of business and reserves the right to purchase the vehicles, accessories and service parts from other companies at any time during the contract duration.

Lot 2: On/Off Road 4x4 Station Wagon, HEAVY

The OSCE reserves the right to accept or reject any Bid, and to annul, in whole or in part, or to suspend the bidding process and reject all Bids at any time and without reason prior to award, without thereby incurring any liability to the affected Bidder or Bidders.
