CIRCULAR NOTE No. 7

SUPPLEMENTARY INFORMATION ON REGISTRATION, HOTELS AND BILATERAL MEETING ROOMS

The Ministry of Foreign Affairs of the Republic of Lithuania presents its compliments to the Missions and Delegations accredited to the Organization for Security and Co-operation in Europe, the Mediterranean Partners for Co-operation, the Asian Partners for Co-operation, the OSCE Secretariat and International Organizations, and has the honor to inform on the following.

1. VENUE

The 18th Meeting of the OSCE Ministerial Council will be held in Vilnius on 6 and 7 December 2011. The venue will be the Lithuanian Exhibition and Congress Centre (Litexpo Complex), located at Laisves Avenue No. 5, LT-04215 Vilnius, Lithuania. The official website of the Litexpo Complex is www.litexpo.lt/en. Meetings of the Preparatory Committee are scheduled in the same location on 4 and 5 December 2011.

2. FACILITIES

Litexpo Complex offers all facilities required for the Ministerial Council. All delegations (including participating States, partners for co-operation and international organizations) will be provided with a furnished office equipped with: telephone, computer, printer, internet access, and stationary. Photocopiers and fax machines will be available near offices, meeting rooms and bilateral meeting rooms.

Regular meeting and bilateral meeting rooms will be in close proximity to one another.

The media will be provided with a fully equipped press center at the Litexpo Complex. The press center will have a separate entrance.

The entire compound will be a secured area. Access to the buildings will only be possible with a badge, which will be issued at the accreditation.

2.1 BILATERAL MEETING ROOMS

There will be 15 bilateral meeting rooms, with seats for 10+16 persons. Because of a huge demand, duration for each meeting is scheduled for a maximum of 30 minutes.

Bilateral rooms' reservations are to be made in advance. The rooms will be distributed on the first come first served basis. A booking form is available on the MC website: <http://www.osce-ministerial2011.mfa.lt>. The completed booking form must be sent to bilateral-meetings@mfa.lt or submitted in person at the bilateral desk, which will be in close proximity to the meeting rooms.

Bilateral meeting rooms on 6 and 7 December are only for use for bilateral meetings between the Heads of Delegations.

3. ACCREDITATION

3.1 ACCREDITATION OF DELEGATES

As of 14 October, accreditation takes place on the basis of a special accreditation form which is available online www.osce-ministerial2011.mfa.lt. All personal data sent to the organizer of the event will be treated in accordance with the highest security standards.

In addition, a Note Verbale from the Mission/Delegation to the OSCE in Vienna with the names and titles of the delegation members, including the Head of Delegation, **in protocol order**, should be sent to the Ministry of Foreign Affairs of the Republic of Lithuania, Ms. Ruta Vaiciuniene, Tel: +370 5 236 2832, Fax: +370 5 236 2462, E-mail: ruta.vaiciuniene@urm.lt, **by 07.11.2011**, to ensure that all delegates who have applied for accreditation, have been permitted by their authorities to attend the Ministerial Council.

Should there be any changes in the list of delegates; an updated list with the Note Verbale is required to submit as soon as possible. The accreditation will not be granted for persons who do not appear on the list of members of the delegation in the Note Verbale.

3.2 ACCREDITATION OF HEADS OF DELEGATION

Heads of Delegations shall submit their registration form online. A pin will be issued for each Head of the Delegation. The Heads of Delegations will be requested to wear the pin while in the conference premises during the MC meeting.

3.3 ACCREDITATION OF SECURITY PERSONNEL

If the Minister of Foreign Affairs is accompanied by a national security officer/s, the delegation will be requested to complete and submit a special accreditation form online for security personnel, accompanied by a color photo for each security officer. Security officers should be listed in a separate Note Verbale from the Mission/Delegation in Vienna to the Ministry of Foreign Affairs of the Republic of Lithuania.

The same accreditation procedure as outlined above applies. All the forms mentioned in this section are available online at www.osce-ministerial2011.mfa.lt.

Weapons and Radiofrequencies

An application for a user permit for weapons and radio equipment used during the visit is necessary. An alternative frequency should also be indicated in the application for frequency permits. Permits for weapons and frequencies are applied, using a diplomatic note, from the Ministry of Foreign Affairs. The Ministry of Foreign Affairs of the Republic of Lithuania will inform each Delegation on permits granted and frequencies to be used.

If security officers intend to carry firearms during the Ministerial Council Meeting (only one armed officer per delegation is allowed), the Mission/Delegation should send an application for approval by the Note Verbale to the Lithuanian OSCE Chairmanship Task Force in Vilnius, **by 07.11.2011**, stating the following: (1) type and serial number of the firearm; (2) quantity of ammunition; (3) additional security equipment; (4) name, date and place of birth, passport number of the person who will carry the firearm; (5) date, time, and flight numbers of arrival and departure.

The application to carry firearms will be forwarded to the Lithuanian Police Authorities for approval. The delegation will be informed about eventual approval prior to the arrival. Permission will be given upon the arrival to Vilnius International Airport.

3.4 ACCREDITATION OF DRIVERS

Litexpo Complex compound will be a secured area. If the delegation is also to be accompanied by an embassy driver(s), the delegations will be requested: (1) to complete and submit a special accreditation form online for drivers and vehicles; (2) to submit a color photo for each driver; 3) to submit a license number of the vehicle; (4) to send to the Ministry of Foreign Affairs of Lithuania a separate Note Verbale listing all drivers to be accredited and all vehicles to be used (please include brand, model, license number for each vehicle).

The same accreditation procedure as outlined above will apply.

4. HOTEL RESERVATIONS

Arrangements have been made with a Hotel Reservation Bureau that provides a choice of hotels in several price categories. The bookings have to be made through the Hotel Reservation Bureau.

Hotel rooms and suites will be allocated on a first come and first served basis. Hotel reservations will be made by a separate hotel room booking form that is available online at www.osce-ministerial2011.mfa.lt.

In accordance with the OSCE standards, the Lithuanian Chairmanship will cover accommodation expenses only for those Heads of Delegations who will submit their hotel room booking forms. Accommodation expenses will be covered 5-7 December 2011, two (2) nights only.

Other hotel charges should be paid directly to the hotel by delegations and/or their respective Embassies in Lithuania.

The Lithuanian Chairmanship strongly recommends that Heads of Delegations reside in Hotels that are listed in Annex 2 and are integrated in the security and transportation plan.

5. TRANSPORT

The OSCE Heads of Delegations will be offered a chauffeur-driven limousine, exclusively for use at the Ministerial Council. The limousine service will be available from the time of arrival (but not prior to 5 December) at Vilnius International Airport (<http://www.vilnius-airport.lt/en/>) until departure (no later than 7 December). The limousine service is exclusive for the use of the Head of Delegation and can be accompanied by one person at most.

Upon the arrival (prior to the 6 December) all delegations will be picked up by shuttle busses at Vilnius International Airport.

Each delegation of more than three persons will have a chauffeur-driven mini-van. The mini-van is to be exclusively used for the OSCE Ministerial Council purposes only, from the morning of 6 December until the evening of 7 December. The mini-van will offer seven seats per delegation including the security personnel. The Chairmanship will not provide transportation for any extra delegation and/or security personnel.

As of 4 December a shuttle service will also be available between Vilnius International Airport, hotels, Litexpo Complex and side events taking place elsewhere.

A waiting room/area will be established for all accredited drivers at the Litexpo Complex.

6. SECURITY AT THE LITEXPO COMPLEX, VILNIUS

To gain entry permission to the Litexpo Complex center and while inside the building, a valid personal badge must be visible at all times. In addition, delegates are requested to cooperate in security check points. Security staff will ensure that visitors only enter areas they are entitled to enter. Heads of Delegations are kindly requested to wear pins in clear and visible manner at all times.

7. VISAS

Visa requirements must be met before arrival in Lithuania. In order to be able to arrive on time, it is advisable to apply for visas at the earliest possible opportunity. Please note that **only in exceptional cases** it will be possible to have visa issued at the Vilnius International Airport upon arrival and only when the applicant arrives to Vilnius directly from outside the Schengen area. Participants must be in a possession of the appropriate identity documents for travel to Lithuania.

Participants requiring visa to enter the Schengen area are requested to make their own arrangements to secure a visa entry to Lithuania. The application for the Schengen visa may take up to three weeks.

Please refer to Annex 1 for a detailed list of countries requiring visa for Lithuania in each of the three different passport categories.

Visa Procedures

Please contact the Lithuanian Consular authority which serves your country in a timely manner and inquire about free-of-charge visa. Please find a list of countries/cities with Lithuanian embassies/consulates in charge and their contact information: <http://www.urm.lt/index.php?1366094069>.

The following documents are usually required (please refer to consular authorities websites for more precise information):

For the members of the official delegations:

- A completed application in the prescribed form;
- A valid travel document (its period of validity must exceed the validity period of the requested visa by at least three months);
- One 35 x 45 mm color photograph;
- An invitation from the organizers of the conference;
- A Note Verbale from the Ministry of Foreign Affairs of the respective state, received through the diplomatic channels;
- A valid health insurance policy (only for holders of non-diplomatic passports);
- The requirement of personal attendance is lifted for the members of official delegations listed in the Note Verbale.

Participants, bearing a valid multiple-entry Schengen visa, do not have to apply for a single-entry Schengen visa to Lithuania.

8. AIRCRAFT

Vilnius can be reached by daily regular flights from a large number of European capitals. Delegations are advised to arrange their arrivals to Vilnius International Airport by regular commercial flights.

Heads of Delegations traveling by the government or private aircraft may use the facilities at Vilnius International Airport. Flight clearance may be obtained following the usual procedure. This means that a request in the form of a Note Verbale must be submitted to the Ministry of Foreign Affairs of Lithuania no later than 7 days before arrival. The flight clearance requests must be submitted to the Protocol Department at the Ministry of Foreign Affairs. 
