INTRODUCTION/BACKGROUND

Over the last 20 years, the Central Asia Media Conference (CAMC), organized by the OSCE Representative on Freedom of the Media, has been and continues to be a unique event for the exchange of information and experiences on media freedom developments among all five countries in the region.

The main theme of this year's edition will be media freedom and pluralism in times of digital transformation. The discussion will include conditions for establishing an open and secure Internet nationally and throughout the OSCE region, as well as media for minorities and self-regulation.

Recalling the OSCE 2018 Ministerial Decision on Safety of Journalists, which acknowledges that journalism and technology are evolving and that this contributes to the public debate, while it may also expand the range

of risks that undermine the safety of journalists, the conference will focus on various aspects of digital transformation of the media, from access to the Internet to vulnerability of journalists.

The conference will gather over 100 participants from Kazakhstan, Kyrgyzstan, Tajikistan, Turkmenistan, Uzbekistan, as well as Mongolia, representing the public authorities, media, journalists' associations, civil society and academia, to exchange views and best practices on the issue.

The event will offer plenary sessions, parallel working groups for an in-depth discussion of relevant issues, as well as side events to showcase media projects prepared and implemented in the region. The working languages will be English and Russian with simultaneous interpretation.

10.00 – 11.15 SESSION I: Impact of digital development on media pluralism

The new and still-evolving media ecosystem is much more complex than anything we have seen before. Internet, social media and mobile telephony have enabled growing numbers of people to express themselves and reach (potentially) the whole connected world with their individual messages.

New technologies are driving the creation of new forms of media, the way people interact with media (instant mobile access) and how they are inter-mixing different channels of communication (TV, radio, internet, press, blogs, social media). New technology brings about new forms of content distribution and content sharing, to support and enhance quality journalism against the pressure of dwindling resources.

The public is aware of the benefits that new media technologies have brought to media pluralism and media freedom: many new forms of journalism and media services have emerged. The Internet also opens opportunities and lowers barriers of entry for new media organisations and individuals.

Yet, despite an abundance of available sources and opinions, consumers view the quality of the media as lower than in the pre-digital era: citizens find material from non-traditional sources, including social media, less trustworthy and less rigorously checked than on traditional media. New business models are called for to finance quality media in the future.

This session will focus on possibilities and challenges for the media arising from global digital distribution platforms, protection of the public interest, and access to an open, stable and affordable internet for public and media alike.

Many governments are considering imposing regulation on online content and social media platforms, often blamed for facilitating illegal conduct, enabling abuse and manipulating democratic processes. There is a trend in legislation of many countries to impose fines, blocking access to websites, and imposing liability on internet intermediaries for failing to limit the distribution of harmful content.

As Internet platforms in general have become central players and facilitators of online speech, their own Terms of Service have become the rules on freedom of expression on these platforms. These rules have a clear impact on the way freedom of expression is exercised in the online world.

It is essential to protect public interest from attacks, corporate interests, or norms which are unilateral. A secure and open internet needs an order based on rules and the rule of law to survive.

This session will look at the different models of online regulation and discuss ways to include international human rights standards in any such model.

Prompted by UNHCR, in 2008, the Italian National Council of the Order of Journalists and the National Federation of the Italian Press signed the Charter of Rome. The Charter is a code of conduct for journalists on migrants, refugees, asylum seekers and victims of human trafficking that promotes an accurate and balanced representation of the migration phenomenon and related issues. Three years later, in 2011, media representatives – together with a network of 14 civil society organizations – founded the Charter of Rome

The Institute for War and Peace Reporting conducted a research on identifying patterns of news consumption through new media in four Central Asian countries - Kazakhstan, Kyrgyzstan, Uzbekistan, and Tajikistan. The research results demonstrate the information consumption path of the Central Asia residents, what platforms they prefer, what language the news materials are available in, how much the consumption

channels have changed, how popular alternative messaging platforms are (WhatsApp, Telegram or Facebook Messenger), and the level of information sources' credibility.
