**STATEMENT BY
THE DELEGATION OF THE UNITED KINGDOM**

The United Kingdom continues to take its responsibilities under the Dayton Peace Agreement with the utmost seriousness. We remain an active and engaged member of the Peace Implementation Council Steering Board and fully support the territorial integrity and the Dayton-endorsed constitutional structure of Bosnia and Herzegovina as a single, sovereign State.

We wish to underscore that the Dayton Agreement remains a cornerstone document, vital not only for peace and security but also for the broader stability of the Western Balkans region.

The United Kingdom stands firmly with the international community in supporting the General Framework Agreement for Peace and the successful implementation of this landmark peace accord, which remains essential to fostering long-term peace and stability.

We also reaffirm our strong commitment to the mandate of the OSCE Mission to Bosnia and Herzegovina, which has played a crucial role in securing and sustaining peace.

Finally, the United Kingdom has consistently supported the implementation of Dayton Article IV inspection activities through the provision of arms control inspectors from our arms control agency, the Joint Arms Control Implementation Group (JACIG). The JACIG has contributed to at least two inspections annually. This year, we provided one inspector to support a Croatian inspection of Serbia, and another to support Bosnia and Herzegovina during an inspection conducted by Croatia. In each case, the inspections were successful, treaty-compliant, and conducted in a highly professional and constructive manner.

Thank you once again, and I respectfully request that this statement be entered into the Annex of the Agreement on Sub-Regional Arms Control (Article IV Annex 1-B of the General Framework Agreement for Peace in Bosnia and Herzegovina).
