STATEMENT BY THE CHAIRPERSON

Following the FSC Decision No. 12/11 on an Annual Discussion on the Implementation of the Code of Conduct on Politico-Military Aspects of Security, Bulgaria, in its capacity as holder of the Chairpersonship in the second session in 2023, has undertaken the measures and efforts necessary to carry out the tasking contained in the decision. As stated in the FSC Chairperson's opening statement at the beginning of the current session, Bulgaria has also consulted the participating States by inviting them to share their views on the organization of the Annual Discussion on the Implementation of the Code of Conduct in 2023.

Since our consultations have indicated that no reasonable basis for consensus is emerging, the Bulgarian FSC Chairpersonship has decided not to put forward a draft decision on the agenda, timetable and modalities of an Annual Discussion on the Implementation of the Code of Conduct.

Remaining firmly committed to the principles inherent in the Code of Conduct and sincerely dedicated to the pursuit of the relevant tasking and discussions, the Bulgarian FSC Chairpersonship, in accordance with its declared intentions at the opening meeting, will take steps necessary to ensure the visibility of this important document during the current session. Following this, it will organize a Security Dialogue on the subject of the Code of Conduct.

In my capacity as Chairperson, I will attach this statement to the journal of today's meeting.
