In journalism since 1993, currently on the position of executive producer N1 in Serbia, where he was from the beginning. N1 is regional news channel (CNN's affiliation) launched 2014, covering news and current affairs program in Adriatic region. Previously Igor was News Director of Radio TV Vojvodina, public broadcaster for Vojvodina region, and before that executive editor in daily Blic, owned by Ringier-Axel Springer company. The biggest experiences he made in RTV B92 where I spent 13 years - from reporter, anchor of current affairs program to editor, and chief in editor of B92 specialised 24 hours news program.
