**Monday, 02 October**

Title: Self-Regulation in the OSCE region  
Convenor: OSCE Office of the Representative on Freedom of the Media  
Working languages: English, Russian

Summary: The side-event will highlight the Representative on Freedom of the Media's focus on supporting media self-regulation, through assisting OSCE participating States to create or enhance self-regulation mechanisms. The invited experts will explore the merits of self-regulation for developing quality of the media while maintaining editorial freedom. They will analyze some of the typical challenges encountered when establishing journalists' self-regulation bodies. In new democracies, self-regulatory bodies emerged after 1989, often following the model of Western countries. This trend fostered a consensus around the essential role that media accountability systems play in guaranteeing freedom of the media. Unfortunately, many of these new self-regulatory mechanisms are still striving to overcome initial shortcomings. In some OSCE participating States, self-regulatory systems are not in place.

Title: Building Coalitions among Roma Representatives to Formalize Informal Settlements  
Convenor: ODIHR CPRSI; UN Habitat, Warsaw Office; Council of Europe; UNDP (Bratislava)  
Working languages: English, Romani

Summary: The framework of the side event is given by the OSCE Roma and Sinti Action Plan, namely by its provisions under the Chapter IV. Addressing socio-economic issues /Housing and living conditions, respectively the art. 43-47, addressed to OSCE participating States and to OSCE Institutions.

*Art. 43: Put in place mechanisms and institutional procedures to clarify property rights, resolve questions of ownership and regularize the legal status of Roma and Sinti people living in circumstances of unsettled legality (e.g. Roma neighbourhoods lacking land rights or which are not included in the urban plans of the main locality; families and houses without legal residence status in settlements where the people have been living de facto for decades)."*

The side event will address the issue of urban upgrading and legalizing informal settlements of Roma and Sinti in order to review the implementation of the OSCE Action Plan on Roma and Sinti. The event will host

presentations of good practices and initiatives, as implemented in various countries throughout OSCE area, and discussions about follow up actions needed to address the issue of housing and living conditions.

Title: Recent developments in the protection and assistance to trafficked persons, including children  
Convenor: Anti-Slavery International; Terre des Hommes; ECPAT; La Strada International; ODIHR Anti-Trafficking  
Working language: English

Summary: The protection of and assistance to trafficked persons is not negotiable. States need to ensure that police, workers in shelters and others likely to come into contact with persons who have been trafficked (including children) are aware and sensitised as to their needs. Also they need to ensure that the appropriate support is always available. The ODIHR supports establishment of multi-agency structures, in the form of national referral mechanisms to achieve these aims. This event provides a number of leading NGO's with a forum to present recent project activity and lessons learnt on identification and protection of trafficked persons for both labour and sexual exploitation. The event will highlight good practices in ensuring protection of trafficked persons rights alongside continuing challenges in this work. It will also contribute to developing a number of recommendations for future action on the issues raised.

Title: Political abuse of Juridical System in Moldova: Valery Pasat Trail  
Convenor: Infomost Communications  
Working language: English

Summary: Valery Pasat, Moldova former Minister of Defense was arrested in 2005 and sentenced early in 2006 for 10 years in hard labor penal camp for selling, back in 1997, at too low price Moldova's 21 MiG-29 nuclear capable fighter planes to the USA instead of selling them to intermediary who was believed to represent Iran. A Moldovan Court appears to have violated Pasat's basic human rights, refusing to hear evidence favorable to the accused, particularly depositions made with U.S. Government approval by Mr. E. Wayne Merry and the US Ambassador to Moldova at the time of the sale, John Todd Stewart. Mr. Merry, the US official responsible for the purchase of MIG-29s under the Nunn-Lugar program, makes serious allegations in a letter to the Financial

Times of 04/02/2006. He clearly states in his letter that the transaction was entirely fair, that the competing tender for \$55 million was phantom and that the final decision to sell was made by the then Moldovan President Petru Lucinschi who has faced no charges to date. This matter has been raised by MEPs several times; addressed by European Commission officials; the OSCE PA included the Pasat case in its report on human rights in Moldova; and PACE commissioned a special report on the Pasat trial. An appeal has been launched, but it must pass through two higher appeal courts in Moldova before reaching the European Court of Human Rights. Mr. Pasat's lawyers have alleged that the hearings are being delayed by bureaucratic means. Given the poor conditions of his imprisonment, Mr. Pasat may suffer irreparable damage to his health before the final verdict is reached.

Title: Combating sexual exploitation of children  
Convenor: Belgian OSCE Chairmanship; France; United States  
Working language: English

Summary: The sexual exploitation of children is a grave and large-scale problem throughout the OSCE region and beyond, with multiple and interlinked manifestations, including prostitution, pornography, trafficking, sex tourism and forced early marriages. Sexual exploitation of children constitutes a serious human rights abuse, as well as a crime –potentially involving organized crime networks- which severely impacts on the well-being of children. Whereas the problem of sexual exploitation of children is widespread, the OSCE has not made it a major focus to date. The Belgian OSCE Chairmanship, France and the United States therefore wish to draw attention to this problem and call for more action. Mr Theo Noten, European representative on the board of ECPAT International, Mr Philippe Kaspi, Deputy Chief of Staff of the French Ministry of Tourism and Ms Leila Ben Debba, Manager of ICMEC Europe, will inform the participants of this side-event of the extent of sexual exploitation of children in the OSCE region and suggest which policy response could be appropriate. A subsequent discussion will allow for an informal look at the issues, exchange of experiences, and consideration of policy answers. Delegations, non-governmental organizations and all those caring for the well-being of children are warmly invited to attend this side-event, which promises to generate a lively and fruitful discussion.

Title: Charter on Freedom of Expression and Journalistic Ethics in Relation to Respect for Religion or Belief  
Convenor: Institute on Religion and Public Policy  
Working language: English

Summary: The institute on Religion and Public Policy has been working in close cooperation and interactive partnership with religious communities, non-governmental organizations, diplomats and members of the media to draft, develop and advance a **Charter on Freedom of Expression and Journalistic Ethics in Relation to respect for Religion or Belief**. This charter was created by studying over 40 national journalistic ethics codes, more than 300 professional journalistic codes, and relevant documents articulating OSCE, Council of Europe and UN standards. We also incorporated suggestions and concerns articulated by NGOs and diplomats in public discussions we held to discuss the Charter. The purpose of our Charter is to provide a framework and establish standards to evaluate ethical media behaviour in matters relating to religion or belief. The charter takes into account the paramount principles of freedom of expression and freedom of religion or belief and attempts to strike an appropriate balance that preserves both of these fundamental freedoms. We encourage not only the media but all segments of society to use the Charter to assist the media in maintaining ethical scrutiny when it depicts, reports or comments on matters relating to religion or belief. No universal set of principles, rules or standards in this critical area regarding the depiction of religion or belief by the media currently exists. Without such principles and standards, there are no effective means to gauge whether news reports, comments or other depictions through cartoons, pictures or satire go over the line and engender discrimination, or even violence, targeting individuals due to their association with a religion or belief. We believe this Charter provides the guidelines to make that possible.

Title: Violence against Women, Domestic Violence – Threats to Security  
Convenor: Geneva Centre for Democratic Control of Armed Forces (DCAF)  
Working language: English

Summary: The side event will focus on the connection between violation of women’s rights and security, more specifically human security. The event will provide an opportunity to further elaborate our understanding of 'security' and examine what practical implications violations of women’s rights have on security and how violence against women occurs in varying contexts – at the domestic and community levels. Security must include the ability or inability of the State to ensure the protection of its citizens - whether they are in their homes, in private, or in public spaces. This includes protection of women from domestic violence. While threats to women's human security during times of war represent grave dangers, even in times of peace, millions of women and girls daily confront threats to their security in both the public and private sphere. Security promotion, including peace building and conflict resolution should include promotion of gender equality and combating of violence against women. This has recently been elaborated further through the compiling of a comprehensive overview of the scope and magnitude of violence experienced by women in daily life, during armed conflict and in post-conflict situations. Through contributions made by numerous authors, representing the major international organizations, governments and NGOs involved in gender related work, the Geneva Centre for Democratic Control of Armed Forces, DCAF, has compiled the study 'Women in an Insecure World'. It provides analytical data and statistics, legal documents and policy recommendations, as well as feature stories and illustrations regarding violence against women in different contexts. One of the specific areas of concern is domestic violence. Based on the above study, with specific focus on domestic violence, the side event is to offer a closer examination of how violations of women’s rights constitute a threat to security.

Title: The Gender Dimension of the Roma and Sinti affairs: including situation of Roma Women as refugees  
Convenor: Open Society Institute – Roma Participation Program (OSI RPP); OSI Joint Roma Women’s Initiative; Romani CRISS; ODIHR CPRSI  
Working language: English, Romani

Summary: The side event will address the issue of gender dimension of the Roma and Sinti affairs. Romani men and women activists belonging to different groups and ideological orientations will discuss the subject of collective minority rights versus/and individual rights. In addition, discussions will focus on clarifying terms such as “patriarchal”, “hierarchic traditions”, “gender equality”, “collective and individual human rights”, gender & public and political participation and gender issues in crisis and post-crisis situations. It is hoped that the event will contribute to the establishment of a “Contact group on gender equality within Romani affairs”. The Council of Europe’s Report on the Situation of Roma/Gypsy women in Europe (1999) raised the challenging issue of gender equality within Romani movement and communities. Meanwhile, due to the lack of local initiatives and expertise at that time, no in-depth discussions or concrete initiatives took place. As recent as June 2006, the European Parliament adopted a resolution on the Romani women in the European Union.

Summary: There have been increasing reports of the exploitation of migrant workers in Western countries. More recently new EU member state nationals have been the subject of news reports of exploitation in different industries but in particular agriculture, construction, food processing and packaging, and domestic work. Often the migrants do not speak the host country language and are isolated from the wider community. A law enforcement response has been pursued in some of these cases of labour exploitation with differing results. However law enforcement cannot tackle the policy issues that create and sustain vulnerability to exploitation for many migrants, which also require urgent attention. This event brings together expertise from law enforcement and migrants rights protection agencies to consider current responses to the problem of labour exploitation and consider ways forward.

Title: Putting theory into Practice: Lessons from the First States to Ratify the Optional Protocol to the UN Convention against Torture

Summary: On 22.06. 2006 the Optional Protocol to the UN Convention against Torture (OPCAT) entered into force, after several decades of discussion and procrastination. The UN Special Rapporteur, Manfred Nowak, captured the significance of this event by stating: "the OPCAT is the most important development for the effective prevention of torture at the universal level". The greatest challenge ahead lies in the effective implementation of the instrument at both the national and international level and putting in place a system of independent monitoring of places of detention. This side-event will discuss this issue, drawing on the experiences of national actors from a range of countries which have ratified OPCAT and are now in the process of implementation.

Summary: The Delegation of the European Commission is inviting the Kyrgyz NGO "Public Association of Soldiers' Mothers" (PASM) to make a presentation on its activities concerning human rights promotion and protection in the armed forces. PASM's main mission is to protect human rights among recruits and young soldiers and to help them in case of infringements of their rights. It organizes explanatory talks, meetings and round tables on the soldiers' juridical rights, operates “trust telephones” and frequently attends military units, disciplinary battalions and guardhouses. Furthermore, PASM provides training under the topic “your rights, soldier” and is issuing information material and the magazine “Army Pedagogical Council”. This side event is also to be seen in the context of ongoing discussions on the OSCE Code of Conduct as well as on security sector reform, notably as concerns the contribution of civil society in translating relevant OSCE commitments into concrete action.

Discussions will also focus on follow up actions and measures that the responsible authorities need to undertake to improve the situation of RAE communities in the societies in which they live.

Summary: The framework of the side event is given by the OSCE Roma and Sinti Action Plan, namely by its provisions under Chapter IV - Addressing socio-economic issues. Provisions 53 – 57 are addressed to OSCE participating States and to OSCE Institutions, and specifically provision 53 which states:

*“At the request of participating States, the OCEEA, together with relevant international organizations, will contribute to developing approaches designed to overcome obstacles and discrimination that prevent Roma and Sinti people from fulfilling their potential in the economic sphere.”*

The side event will address the issue of employment and education, with the purpose of reviewing the implementation of the OSCE Action Plan on Roma and Sinti. As a follow up to the Bucharest conference (May 2006), the ODIHR CPRSI and OCEEA will facilitate interaction between business companies and representatives of Roma and Sinti communities in view of developing initiatives and programmes to increase access of Roma and Sinti communities to the labour market. Speakers will include those that have been involved in initiatives that bring vulnerable groups, such as the Roma, into fellowship programs in various business industries. The event will host presentations of good practices and initiatives, as implemented in various countries throughout OSCE area, and follow up needed in order to addressing integration issues.

Summary: The Center for International Peace Operations (ZIF) was founded in 2002 by the German Government as an important step towards improving Germany's capabilities for the deployment of civilian personnel for crisis prevention, conflict resolution and peace consolidation. Its mandate is to train, provide and support personnel for international operations mandated and conducted by the UN, OSCE, EU and other international organisations. Since election observation missions are an essential element of democratization processes and crisis prevention, the training and deployment of election observers is an integral part of ZIF's mandate. Training is conducted both for short-term and long-term election observers, offering a realistic preparation for mission assignments which is closely tailored to the needs in the field. Particular emphasis is given to the code of conduct and security of election observers. Within the frame of the Human Dimension Implementation Meeting, ZIF looks forward to present and discuss its lessons learned on four years of election observer training.

Summary: In the Vienna Convention (1989) OSCE member states undertook to  
“(16.1) – take effective measures to prevent and eliminate discrimination against individuals or communities on the grounds of religion or belief in the recognition, exercise and enjoyment of human rights and fundamental freedoms in all fields of civil, political, economic, social and cultural life, and to ensure the effective equality between believers and non-believers;

(16.2) – foster a climate of mutual tolerance and respect between believers of different communities as well as between believers and non-believers;”

No definite figures exist as to the number of believers or of non-believers but most reliable sources indicate that between 35 and 50% (or more) of the European population are either indifferent to religion or declared humanists, atheists, agnostics or freethinkers. Nevertheless, this large part of the population and their non – religious beliefs are rarely recognised and are commonly ignored by national and international institutions in discussions about discrimination and dialogues to promote mutual understanding. This constitutes a flaw in the effective implementation of the rule of law. The EHF/FHE delegation wishes to discuss with government and NGO representatives as well as with ODIHR officers how to implement the Vienna commitment in order to defuse a potential source of tension in our societies.

Summary: The International Network Against Cyber Hate (INACH) has been founded in 2002 as a federation of online complaints bureaus monitoring cyber hate, tackling racist content and educating users. Since then INACH has become a cross-national network with nodes from 14 OSCE participating States. INACH created a durable co-operation between national complaints bureaus in order to share knowledge, exchange experience and best practice and last but not least coordinate and improve measures against hate speech. Furthermore, the new INACH report and the outcome of the annual INACH conference, which takes place on October 7 & 8 in Warsaw, will be presented.

As a result of numerous irregularities during the preliminary investigation and obvious bias of the judges

during the trial, a complicated operation of abduction and triple homicide, performed with the involvement of the national security service officers, was labeled as a murder based on personal enmity.

Title: Assessing the needs of the Serbian Community in Kosovo: Why decentralization process is important for finding interethnic accommodation

Summary: The project *Research on the Needs of the Serbian Community in Kosovo and Metohija* which, together with a group of associates, was conducted by the non-governmental organization the Centre of Non-violent Resistance (CNR) from Belgrade, was created as an expression of the need to better understand the state of conditions of the Serbian community in Kosovo, as well as to work out the strategy of future actions, built on the foundations of the obtained results, by civil society and donors both in Serbia and Kosovo itself.

The associates of the CNR have noticed a specific imbalance in the extent of development, quality and efficiency between the Serbian and Albanian non-governmental organizations. Unequal development is reflected primarily in the fact that Serbian non-governmental organizations mainly operate on an *ad hoc* bases, are mainly guided by the targeted aims of donors, as well as that they do not frequently succeed in recognizing the key problems of their community nor work on resolving them. Further, the research team had a common double aim: *a) to define and determine the differences amongst enclaves, and based on this to prepare recommendations to be used by civil society in working out future projects for specific local areas, and b) to define similarities, common grounds and similar problems that are characteristic for all Serbian areas in Kosovo, as well as to prepare a catalogue of the needs that can be successfully serviced by Serbian civil society and donors.*

We believe that the logic we followed opens the door towards strengthening Serbian civil society efficiently and quickly and thus Serbian communities in Kosovo as well. A well-organized Serbian civil society is a prerequisite for co-operation with representatives of the Albanian civil sector because a good and meaningful dialogue can only occur if both sides are equal.

Secondly, the topic of extremism (specifically “religious extremism”) has been extensively used in public discourse as an issue correlated with “terrorism” in order to unlawfully limit civil rights and freedoms including religious beliefs. Neither independent political activity nor opposition candidates are allowed. The official Democratic Party of Turkmenistan (DPT) is the only legal political party. Political gatherings are illegal unless government sanctioned. There is no press freedom and no freedom of religion. In schools, children are obliged to learn by heart the Ruhnama, a collection of President Niyazov’s writings and ideas. On 14 September, RFE/RL’s Turkmen Service correspondent Ogulsapar Muradova died in custody. As of today, the Turkmen government has not given any explanation of what happened. Questions abound about the cause of her death and whether the regime was involved. This panel will examine the current human rights situation in Turkmenistan in the light of the Muradova tragedy and the prospects for change.

It has been the

experience of the HCNM that police can be both a contributor and in some instances a threat to stability in states which are home to a number of ethnic groups. As a result, the police have considerable power to shape the attitudes and public perception of persons belonging to national minorities about the rule of law in the state and its capacity to act in a just, legitimate and accountable way. The *Recommendations* attempt at establishing a detailed ‘road map’ for building trust and confidence between police services and persons belonging to national minorities and provide states with practical guidance for policy makers, police, national minority communities and NGOs on how to approach policing and address the issue of police-minority interaction in multiethnic contexts across the OSCE region. The *Recommendations* are expected to become yet another tool for the High Commissioner on National Minorities for the effective implementation of his conflict-prevention mandate. The question how to achieve all these objectives is probably the best invitation and encouragement to a lively debate during the side-event.

Furthermore, in Uzbekistan, the tragic events of Andijan in May 2005 have given the authorities an extra pretext for further muzzling civil society, mostly in a violent manner.

In Kazakhstan, some laws were adopted restricting freedoms of assembly and expression and NGOs have been the victims of illegal searches.

This trend has continued in 2006 with a deterioration of the situation of defenders in particular in Uzbekistan, Belarus and the Russian Federation.

Homosexuality became one of the main issues in a heated debate on norms and values within a modern secular society with a growing immigrant population with more traditional religious traditions and convictions. Involving people with different backgrounds in intercultural dialogues will bring them into close contact with each other. LGBT people get the opportunity to be visible and to weaken prejudices concerning homo-, bisexual and lesbian lifestyles. On the other hand, LGBT people’s prejudices and fears concerning religions or cultural attitudes can be challenged in these dialogues. **Education** provides important means to share values or learn to debate them with people with different backgrounds and cultural traditions. **Empowerment Lifestyle Services** presents good practices on the implementation of policies to make schools a safe place for people of all kind of backgrounds, including LGBT pupils and teachers, in close co-operation with our Education Ministry and the Educational Inspection.

The first option consists in the establishment of a rotating monitoring field mission. The second option proposes the strengthening of the existing mechanism through a questionnaire-based reporting system. As a third option, the enhancement of the monitoring function of the Third General Committee of the Parliamentary Assembly is suggested. Finally the establishment of a two-tiered OSCE Human Dimension Council with a secondary structure for a combined expert- and peer-review is designed. Summary: Discussion about the situation of Muslim minority communities ranks highly on the political agenda of many OSCE participating States, within the European Union (EU) in particular. The purpose of this side-event is to present available EU data and information on the situation of Muslim communities. Secondly, the side-event aims at discussing existing ‘good practices’ at national or local level that work against discrimination of members of Muslim communities in employment, education and housing, as well as against violence and crime fuelled by Islamophobia.

This side event will take the form of a panel discussion. The panel will include Mohammed Aziz, Director of Faithwise Ltd. and co-author of the EUMC’s forthcoming report on the situation of Muslims in the EU, an expert from the European Monitoring Centre on Racism and Xenophobia, a representative of Finland’s oldest Muslim community and the Personal Representative of the OSCE Chairman-in-Office on Combating Intolerance and Discrimination against Muslims. The panel will be moderated by Ambassador Aleksi Harkonen, Head of the Permanent Mission of Finland to the OSCE.
