The Policy of State Terrorism of Georgia Against the Republic of South Ossetia in 2004 to 2010

In November 2003 Mikhail Saakashvili came to power in Georgia as a result of the so-called revolution of roses. His principal slogan during the election campaign was based on the thesis aimed at fast and ultimate promotion of Georgian jurisdiction in South Ossetia and Abkhazia. In 2004 Tbilisi started to "defreeze" the conflict between Georgia and South Ossetia in order to break the status quo provided by the 1992 agreements.

With this aim in view Saakashvili opted for provocations based on the policy of state terrorism as a legal form to settle political problems and special operations protracted by appropriate services.

Georgia deliberately started to violate all the previously signed agreements and ignore every basic document on human rights. In so doing it occupied its place among other terrorist organizations internationally.

In 2005 Vano Mirabishvili, Georgian Minister of Internal Affairs, made public a list of South Ossetian citizens sentenced to physical elimination. The list comprised the names of representatives of executive power, members of Parliament and officers of military structures. Georgian special services elaborated a plan which envisaged murder of people who had been included in Merabishvili's list.

In 2005-2009 36 terrorist attacks were launched in South Ossetia. As a result, 26 people were killed and 56 wounded.

According to the South Ossetian internal services, all the terrorist attacks were plotted and accomplished by officers of the Counter-Intelligence Department of the Ministry of Internal Affairs of Georgia and the Department of Military Police of the Georgian Ministry of Defense.

The general scheme of the attacks was as follows. First they were sanctioned by Vano Mirabishvili, Minister of Internal Affairs of Georgia, in person. His deputy, Amiran Meskheli, who controlled the activity of counterintelligence task forces of the Ministry of Internal Affairs, was responsible for preparation and fulfillment of attacks. Their immediate execution was entrusted to the Counter-Intelligence Department headed by Shalva Zhghenti, Main Counter-Intelligence Directorate of the Ministry of Internal Affairs supervised by Major Levan Tabidze, particularly its structural unit dubbed a section of group of officers on security and deep cipher issues headed by Captain Levan Akhobadze, as well as the Regional Directorate of the Counter-Intelligence Department of Shida Kartli and Mtianeti headed by Vice Colonel Zaza Didberuashvili in May 2007 and Vive Colonel Ghiya Chitashvili in August 2008.

Bjazrov Ludwig – is killed.

3. 17.07.2005

In territory of South Ossetian Republic in district of settlement of Avnev, in a zone of the Georgian-Ossetian conflict, subunits of the Ministry of Internal Affairs of Georgia as a result of the carried out special action detained three citizens of South Ossetia who early have been declared «the enemies of Georgia».

Are detained:

Gija Valiev,

Georgii Zaseev,

Soslan Kochiev.

All three are now in the Georgian prisons.

4. 20.09.2005

Mortar bombardment of Tshinval from the side of settlement of Nicozi (Georgia)

10 persons were wounded:

5. 08. 05. 2006

Explosion of a mine-surprise (cellular telephone) in Tshinval on Telman street, $N_{2}6$

6. On June, 11th, 2006 in 01 h. 40 minutes under windows of a building of one of subunit of Ministry of Internal Affairs South Ossetian Republic, the explosive has been blown up. As a result of explosion the south wall and glasses of windows of a building has been damaged, to building of the Department of Internal Affairs the material damage is beaten out.

7. June, 2006

Attempt of carrying out **Diversion and terrorist activity** in a warehouse of ammunition of Ministry of defence of South Ossetian Republic in the region of Cherepichnii in the city of Tshinval. Act of terrorism is prevented by law enforcement bodies of South Ossetian Republic.

8. June, 2006

Attempt of carrying out act of terrorism in a warehouse of fuel of Ministry of defence of South Ossetian Republic located on street of Mirotvortsev. Act of terrorism is prevented by law enforcement bodies South Ossetian Republic.

9. 09.07 2006

Act of terrorism concerning the secretary of Security Council of South Ossetian Republic RJUO

1 person was lost:

The secretary of Security council of South Ossetian Republic Oleg Alborov.

10. 14.07.2006

Act of terrorism concerning the deputy of Parliament of South Ossetian Republic B.Bestauta

2 persons were lost:

Gazaev Ibragim – is killed

Tedeev Arthur – is killed 4 persons were wounded: Gazaev Radion, was born in 1987 Dzukaev Vadim, was born in 1991 Kotolova Valentina, was born in 1952 Dzhioev Pavel, was born in 1945

11. April, 2006

Explosion of the car of General prosecutor South Ossetian Republic Victims aren't present

12. 23.11. 2006

Mine-surprise explosion in Tshinval

1 person is seriously wounded

The citizen of Georgia, Shartava Deniza, was born in 1954, living in the city of Gori.

13. December, 2006

Attempt of fulfillment of act of terrorism concerning the leader of Republican polical party «Edinstvo» Kokoev Z.R. Act of terrorism was prevented by law enforcement bodies South Ossetian Republic.

14. 15.01.2007

Blasting of an armoured car of a battalion of peacekeeping forces of the Russian Federation to the north of height "Pauc".

2 persons were wounded:

The lieutenant Chistjakov P. I.

Private soldier Sinjakov S.J.

15. 25.01.2007

Attempt of fulfillment of act of terrorism against the Russian peacemakers. During work of the investigation team investigating circumstances of blasting of an armoured car of the Russian peacemakers on January, 15th, group of engineering investigation SSPM has discovered around blasting armoured car an anti-tank mine with hot scents of its equipment.

16. 28.05.2007

Explosion in apartment of law enforcement officer South Ossetian Republic

1 person was lost:

Kozaev Valery.

17. 09.06.2007

Attack of intelligance-diversionary group of the Ministry of Internal Affairs of Georgia on citizens South Ossetian Republic near cettlement Tsnelis

1 person was lost:

Tedeev Georgii

1 person is wounded:

Dzeranov Arcady

18. 31.07.2007

Attempt of the organization of an act of terrorism. Employees of law enforcement organs of South Ossetian Republic in Tshinval from waste ground at a crossroads of street Mirotvortsev and Nartovsko lane have removed two Improvised explosive devices on the basis of the antipersonnel mines MOH-100 disguised as pieces of concrete. Explosives could be put in action, both by means of wires, and by means of a radio signal.

Victims aren't present.

19. 07.09. 2007

Act of terrorism with use of an explosive disguised as a mobile phone in Tshinval, BAM microdistrict.

1 person is wounded

Kokoev Igor, was born in 1983

20. September, 2007

Attempt of carrying out of an act of terrorism concerning delegates of VI congress of the Ossettinian people in Tshinval in hotel "Alan". Act of terrorism is prevented thanks to the accepted security measures.

21. 10.11.2007

Explosion of radio control improvised explosive device in Tshinval, Stalin street № 102. Victims aren't present.

22. 25.12.2007

Tshinval, Stalin's street, 45 is found out an extension with use of grenade RGD-5

Victims aren't present.

23. 16.12.2007

Act of terrorism concerning employees of Ministry of Defence South Ossetian Republic. Blasting of mined car.

Huriev Mairbeg - was killed

2 persons were wounded:

Dudaev Eric,

Bolataev Felix.

24. January 2008

Attack of Investigation-diversionary group of the Ministry of Internal Affairs of Georgia on a post of Ministry of defense of South Ossetian Republic

in southern suburb of Tshinval.

3 persons were wounded,

1 person has died later.

25. Act of terrorism in a warehouse of ammunition of Ministry of defence and Emergency situation of South Ossetian Republic in settlement Hetagurovo. Explosion has occurred partially that has allowed to avoid victims. Victims aren't present.

26. 28.02.2008

Act of terrorism in settlement Dnemis of Tshinvalsky region of South Ossetian Republic

Alborov Walter – is killed

Maldzigov Sevastir – was killed

17 persons were wounded.

27. 23.03.2008

Act of terrorism in settlement Okona of Znaursky region of to r thow South Ossetian Republic, with application explosive unit, disguised as capacity with wine.

2 persons were wouded:

Koliev Inal,

Doguzov Vladislav.

28. 27.03.2008 Explosion of the car of State Office of Public Prosecutor South Ossetian Republic

Tedeeva Alana – was killed

1 person was wounded:

Valiev Vissarion, was born in 1983

- **29. 13.04.2008** Explosion in apartment of law enforcement officer South Ossetian Republic
 - . Victims aren't present.
- **30. 14.04.2008** To the addres: Tshinval, Stalin's street, 45 was found out an extension with use of granate RPG-5. Victims aren't present.

31. 29.05.2008

Car explosion in a locating of Special policy group of Ministry of Internal Affairs of South Ossetian Republic

.Explosive unit was put in action by means of a mobile phone the call on which has arrived from territory of Georgia.

6 persons were wounded:

Dzhagaev Zelim

Medoev David

Beteev Alexey

Dzeranov Arthur

Tedeev Inal

Naniev Igor

32. 27.06.2008

Act of terrorism on a post of Ministry of Internal Affairs of South Ossetian Republic near settlement Kohat. The Explosive unit has been placed in automobile wheels which the citizen of Georgia tried to spend through border into territory of South Ossetian Republic for the subsequent realization. Victims aren't present.

33. 03.07.2008

Blasting of a controlled explosive unit in settlement Dmenis.

1 person was killed:

Chief of Department of internal affairs of Ministry of Internal Affairs of South Ossetian Republic Bibilov Nodar, was born in 1964

34. 03.10.2008

Blasting of the car detained in territory of Georgia and filled with explosive, in PPD of Peacemakers forces of Russia and Republic of Noth Assetian -Alanii.

9 persons were lost, 6 have got wounds. In a death toll – the chief of united staff of forces for maintenance of peace in a zone of the conflict - colonel Ivan Petrik.

35. 04.05.2009

Law enforcement officers of South Ossetian Republic

on Sauth Assetian part of the Transcaucasian highway have revealed and decontaminated Powerful explosive unit with power about 800gram in a trotyl equivalent.

36. 30.05.2009

On the eve of parliamentary elections of South Ossetia by employees of Law enforcement organs of republic on the address: Tshinval, street Gafeza in hause N_2 9 was revealed the explosive unit consisting from 2 kg of trotyl, strengthened with two manual granates with radio control for actuating by means of a radio signal. The explosive unit has been put under a basic wall of a building. By estimations of experts, device blasting could lead to distruction of buildings and cause appreciated human victim.

37. 26.08.2009

In the celebratory actions devoted to anniversary of a recognition of independence of South Ossetia and commissioning of a gas pipeline "Dzuarikau - Tshinval", from the back side of Musical school in Tshinval is made blasting radio controlled explosive unit. As a result of explosion nobody on-suffered.

Total: Victims 82 persons 26 persons were killed, Wounded 56 persons were wounded.
