CASE: May Nguyen

Identified in Poland
during a detention procedure
as an alleged victim of human trafficking

OSCE 17th Alliance Conference Vienna 3–4 April 2017

Ilegal crossing EU border in Terespol dated on 31rd October, 2012

- 3 citizens of Vietnam(2 men and one woman) stopped by the officers of the Border Guard
- Transported in spare weels of a truck-trailors across Polish - Bielarusian border, without any travel or ID documents (passports, visas)
- Not registered in identification system of the Border Guard

The Border Guard generally use fingerprints to identify persons

- Brought to court for the detention proceeding
 - Illegal border crossing is one of the presumptions of putting foreigner in Guarded Centre for Foreigners



May's short history

Sexually abused by her step father

Sent by her mother and cousin to Berlin to work (never completed her way)

Forced to work in Moscow, sexually abused

Transported to Poland via Belarus, in a spare wheel of a truck-trailer, arrested by the Border Guard

Court Proceedings in Biała Podlaska dated on 2nd and 3rd November, 2012

- May's first hearing in court during detention proceeding:
 - She said that her name was not true, and she was 16 years old
 - She started telling her story about her working in Moscow in a sewing company (without payment and documents), about her journey to Berlin (escape from Moscow) and also said that she had been raped by her employer and two policemen.....

 Judge phoned "La Strada - Foundation against Trafficking in Persons and Slavery" (NGO) and informed about the girl in the Guarded Centre for Foreigners in Biala Podlaska

Practical Difficulties

Age

- May has one document issued by the Embassy of the Socialist Republic of Vietnam in Moscow with false identity data: name, family name and the date of birth (Kim Oanh Nguen Thi, born on the 03 of November 1990 in Nghe An).
- Generally it is possible to detain only a person aged 17 years old

Time

- 24 hours for all activities for the court to cognisize the application for detention
- Expert's stratement determining the age of a person can be prepared in about one month (expertise on the basis of a teeth and a bone criterion)

Testimony

- I was not sure of credibility of the girl testimony but I decided to place her in the Guarded Centre for Foreigners in Biała Podlaska
- The credibility of Vietnamese translator (I was not sure if he had proper qualification). A certified translator was unavailable.

CASE: MAY NGUYEN TIME PERIOD 31.10.2012 – 26.10.2016



May's first assessment by La Strada dated on Nov, Dec 2012

- Born 16.05.1997; Citizenship: Vietnamese
- Height: 150cm; Weight: 39 kg
- Very emotional with suicidal thoughts followed by suicidal attempt
- Relatives:
 - o orphan,
 - o aunt in Vietnam,
 - having stepfather who abused her sexually,
 - o a10-years-old stepsister,
 - o cousin in Berlin,
- Included within Support and Protection Program for Victims and Witnesses of Human Trafficking

LA STRADA ACTIONS

May N. in Guarder Center for Foreigners • Monitoring May N. (from 3.11.2012 until 18.12.2012) and remaining in constant contact via translator and cultural mediator.

May N. as a client of La Strada

- Supervising and taking care of (from 18.12.2012 until 01.03.2015)
- Providing housing
- Providing psychological support
- Providing access to education
- Preparing and coordinating legal aspects testimonies, granting ID documents and residence permits

May N. under the custody of a guardian

• Establishing a foster family and a legal guardian – representative of La Strada

Criminal Proceedings

- Art. 13 § 1, Art. 264 § 2 of Polish Criminal Code illegal crossing of a border
 - discontinued due to insignificant social noxiousness of the act
- Art. 189a § 1 of Polish Criminal Code human trafficking for forced labor
 - discontinued due to non-Polish citizenship of offender (art. 17 § 1 p. 8 CPC)
- Art. 197 § 1 of Polish Criminal Code sexual abuse with use of force (raping)
 - discontinued due to non-Polish citizenship of offender (art. 17 § 1 p. 8 CPC)
