VISA REQUIREMENTS

Visas shall be issued to Conference participants upon their request to the respective Embassies/Consulates of Uzbekistan abroad.

Exempted from visa:

- Nationals of the following CIS countries: Azerbaijan, Armenia, Belarus, Georgia, Kazakhstan, Moldova, Russia and Ukraine *need no visa* to enter Uzbekistan.
- Holders of diplomatic passports from Hungary, Romania, Slovakia, Tajikistan, Kyrgyzstan and Turkmenistan *are also exempted* from a visa.

A visa is required for nationals of ALL other countries and we recommend timely application.

The cost of one-entry Uzbek visa that is issued for 10 days or less is 50 USD.

2 Steps procedure for visa application:

STEP 1:

All travellers will need to get a <u>telex number</u> from the Ministry of Foreign Affairs in Uzbekistan <u>before</u> applying for the actual visa at the Consulate of Uzbekistan.

Please note that once the visa request is submitted and processed, no changes will be accepted (like period of stay, place of issue etc.). Please note that this "Stept 1" process might take up to 1 week.

<u>To get the telex number</u> kindly submit the following information package to Ms. Polina Pomogalova (<u>Polina.Pomogalova@osce.org</u>) <u>the latest 2 weeks ahead of travel</u>:

- 1. Passport copy
- 2. Exact position of the applicant and the place of work.
- 3. Period for which visa is required/number of entries.
- 4. Place of visa issue (consulate in your country of residence or airport in Tashkent).

You will receive the telex number (given by the MFA) from Ms. Pomogalova **and only then**, you can apply for a visa and proceed as indicated in "Step 2":

The <u>telex number</u> from the Ministry of Foreign Affairs in Uzbekistan will also speed up the visa issuance process at the Embassy.

c) Airport of Tashkent at arrival:

Only participants from countries WITHOUT a diplomatic representation of the Republic of Uzbekistan in their country of residence may obtain a visa upon entry at the airport of Tashkent. In case the place of visa issue is Tashkent Airport, prior to his departure the applicant will receive via e-mail a scanned copy of his application (done by our side) with a governmental stamp confirming allowance of entrance to Uzbekistan. This letter will be **the only** necessary document for the trip. Upon the arrival to Tashkent Airport the letter should be submitted to the Airport Visa Section, where the visa will be issued.

For all types of visa applications, following documents have to be submitted:

- telex number for visa issuance given by the Uzbek MFA
- copy of the letter of invitation issued by OSCE or the Registration Form for the Conference
- filled in and signed visa application form see **ANNEX 5**
- copy of passport
- and 2 pictures.

It is highly recommended to apply as soon as possible and no later than 14 calendar days before the arrival date in Tashkent

CUSTOMS REGULATIONS - IMPORT AND EXPORT OF CASH FOREIGN CURRENCY AND GOODS IN UZBEKISTAN

The import of cash foreign currency is freely allowed to natural persons. The traveller will have to obligatory fill in the customs declarations.

The export of cash foreign currency is allowed:

- to the residents within the limits of the sum equivalent \$1500. Amounts over \$1500 equivalent up to \$5000, including traveller's cheques will require an authorization of NBU.
- to non-residents within the limits of imported currency, according to the customs declaration. All export cash foreign currency, irrespective of the sum, should be indicated in the customs declaration.

The goods forbidden to export are:

- grain, wheat, rye, barley, rice, corn, buckwheat, bakery product, cattle, bird, meat, tea, spirit, flour, groats, dry milk, sugar, vegetable oils;
- antiquities (by decision of the Ministry of cultural affairs);
- tanning, fur, including astrakhan raw material;
- breakage and waste of non-ferrous metal, cocoons of silkworm, filoselle, silk waste;

The goods forbidden to import are:

Products of press, manuscripts, cliche, drawings, photosnapshots, films, negatives, film-, video-and audio production, recordings, sound materials, directed on having undermined of the state and social order, transgression of territorial integrity, political independence and state sovereignty, propagandizing of war, terrorism, violence, national exclusiveness and religious hatred, racism and also obscene material.

GENERAL INFORMATION:

Currency: The national currency is **Uzbek soum UZS** (1 USD = UZS 1274.31; 1 EUR = UZS 1764.05 - rate September 2007).

Bank facilities: Bank services and exchange operations can be done at exchange offices situated throughout the city. Some hotels and other locations have ATMs accepting foreign credit cards.

Electric current: The standard voltage in Tashkent is 220 V. Electric plugs may not correspond to plugs of your electric appliance; therefore the use of an adapter might be necessary.

Insurance: The Organizing Committee is not responsible for the loss of property and personal injury, including insurance certificates for such cases.

Time: Tashkent time differs from Greenwich time by +5 hours.

Weather: The weather in Tashkent in October is expected to be cloudy (with possibility of rain), the daily temperature is usually between 15 - 24^oC, but the actual weather conditions should be checked before departure.
