## **HEAD OF PRESENCE'S REMARKS AT GRADUATION CEREMONY OF MAGISTRATES' SCHOOL (14 November 2012)**

Applying human rights in your daily work as judges and prosecutors is a paramount task.

It is a practical contribution to improving the human rights situation in your country and strengthening the rule of law.

You, the graduates, are now at the threshold to be part of the judicial system at an even more elevated level. This is a heavy responsibility. I am confident that you are well prepared for it. And it is a noble duty.

So, let me congratulate you again and wish you all the best in your future work and in your still young careers.
