1. Account of measures to prevent and combat terrorism

1.1 To which agreements and arrangements (universal, regional, sub regional and bilateral) related to preventing and combating terrorism is your State a party?

1.2 What national legislation has been adopted in your State to implement the above-mentioned agreements and arrangements?

The Republic of Albania has adopted the legal framework, on the fight against terrorism, in accordance with the recommendations of "Council Europe of Framework Decision, on the Fight Against Terrorism", Luxembourg, 13.06.2002, which requires the defining of the terrorist crimes in line with all Member States, including those group crimes, related to criminal groups.

Criminal Code, adopted by Law no. 7895, dated on 27.01.1995, amended, added provisions and sanctions with the aim to condemn the terrorist acts perpetrators and their supporters. The amendments in the Criminal Code are made:

- Law Nr.98/2014 for the following offenses:
 - a) Participation in military action in a foreign country "article 265/a";
 - b) Organization for participation in military action in a foreign country "article 265/b";
 - c) Call for participation in violent military action in a foreign country "article 265/c";
 - d) Law No. 157/2013 "For the measures against financing of terrorism";
 - e) Inter-sectoral strategy against Organized Crime, Illegal Trafficking and Terrorism 2013 2020 and the Action Plan 2013-2016, adopted by Council of Ministers Decision (CMD) No. 663, dated 17.07.2013;
 - f) National Action Plan for the 5 priorities (Roadmap 5), for 2014 and 2015 and the measures defined in the Priority 4 "Fight against Organized Crime";
 - g) Action Plan of State Police Director "For the measures to be taken and to be implemented by State Police structures for the prevention of terrorist acts, as well as the efficient response to these acts" dated 23.11.2015;
- Law no. 9086, dated on 19.6.2003, "On the law amendment No. 7895, dated 27.01.1995, is added Article 230/a, "Financing of Terrorism". The financing of terrorism or support in any of its form it is convicted with imprisonment of not less than fifteen years or with life imprisonment and with fine 5 million All to 10 million All (37.862 Euro-75.723 Euro);
- Law no. 9275, dated 16.09.2004, "On amendment on Law no. 7895, dated on 27.01.1995 of Republic of Albania Criminal Code", amended, where it has been amended the article 28, in which there are foreseen the special means of cooperation of the members of criminal organizations and terrorist;
- Law no. 9686, dated on 26.02.2007, "On the law amendment No. 7895, dated on

- 27.01.1995 "Republic of Albania Criminal Code", amended, there have been made the necessary amendments.
- National Strategy for the fight against violent extremism and the action plan 2016-2020, adopted by CMD no. 930 dated 18.11.2015.

"National Security Strategy of the Republic of Albania", adopted by Law no. 103, dated on 31.07.2014, and represents the totality of means and instruments that ensure the protection of citizens, society and the Albanian state from external and internal threats.

"Fight against Organized Crime, Trafficking and Terrorism Inter-sectoral Strategy, adopted with CMD no.1140, dated on 30.07.2008, amended, and the Action Plan for the implementation of this strategy.

The National Strategic Document "On Financial Crime Investigation", which was adopted by CMD no.1077, dated 27.10.2009.

Law No. 9258 dated 15.07.2004 "On the measures against financing terrorism", "On the prevention of money laundering and financing terrorism". These laws are in conformity with the requests of resolution 1373 (2001) of the UN Security Council. This law is implemented by FIU; meanwhile the administration of accounts and frozen/seized/confiscated assets is done by AASCA.

Law No. 9917, dated 19.05.2008 "On the prevention of money laundering and financing terrorism, amended, regulates the prevention of money laundering and proceeds derived from criminal offences, foresees rules and procedures of reporting at the responsible structures on the surveillance and implementation of this law as well as their relevant competences.

Law No. 10192, dated 03.12.2009 "On the prevention and combating organized crime and trafficking, through preventive measures against property", are implemented also for the properties of the persons, on who exist a reasonable suspicion, based on indicia also for participation in terrorist organizations or armed bands.

The Decision No. 44 of Surveillance Council of the Bank of Albania, dated 10.06.2009, "on the approval of the regulation "On the prevention of money laundering and financing terrorism". Its aim is the prevention of use by the subjects of the law no. 9917, dated 19.05.2008, which are licensed and/or observed by the Bank of Albania for money laundering and/or financing terrorism.

DCM no. 140, dated 13.02.2008, "On the way of management of seized immovable properties, in the framework of the measures against financing terrorism".

Framework Decision Recommendation of EC Article 5, Condemnations - "Punishment and condemnation measures of terrorists", or its art. 2, on crime related to terroristic groups.

By the Law no. 9110, dated 24.07.2003 "On the organization and functioning of Serious Crimes Courts", it was established the Serious Crimes Court and Prosecutor Office for Serious Crimes, which has in its competence also the investigation of criminal offences in the field against terrorism.

Law No. 10173, dated 22.10.2009 "On witness protection and justice collaborators".

Law No. 9959, dated 17.7.2008 "On foreigners" regulates the entry, stay, employment, treatment and exit regime of foreigners in/from the Republic of Albania.

Law no. 10193, dated 03.12.2009, "On Jurisdictional relations with foreign authorities in criminal matters":

1.3 What are the roles and missions of military, paramilitary and security forces and the police in preventing and combating terrorism in your State?

War on terrorism directly engages specialized structures of State Police, State Intelligence Service and the Armed Forces.

- Police Forces

The mission of the State Police Antiterrorism Structures is to detect, prevent and fight possible terrorist acts as well as every activity related to terrorist phenomena inside the country. Police intelligence is the main component of antiterrorism structures in the prevention of terrorism. This process includes collection, assessment, analyses and use of information on extremist trends. It is carried out to accomplish national needs for public security as well as in the framework of prevention and detection of criminal offences with

terrorist intent. All activities are carried out in line with relevant laws and bylaws.

In the General Directorate of State Police there is a new Directory of Counter Terrorism. The mission of antiterrorism structure is detection, prevention and the combat of potential terrorist acts and any other activities related to terrorist phenomenon.

Counter terrorism Directory is organized as follows: Directory of Counter Terrorism with 72 Officers of different ranks was created by Internal affairs Ministry Order Nr. 548/7 date 17.10.2014, In the State Police Directory.

The Anti-Terror Directorate is organized as follows: The directorate against terrorism is established by Order of the Minister of Interior No. 548/7, dated 17.10.2014, at State Police Directorate. The staff recruitment is made in compliance with the new structure. By Order of the Minister of Interior no. 672 dated 31.12.2015 it has been adopted the new staff limit for the Anti Terror Directorate. 2 persons have been additionally adopted with the new structure of 2015.

To implement the obligations those derives from the legislations into force in the field of the fight against terrorism, the Directory of Counter Terrorism acts and cooperate with:

- State Informative Service (SIS).
- Prosecution for Serious Crimes.
- Office of the Fight against Terrorism on the Defense Intelligence Agency (DIA), subordinate to the Minister of Defense is another structure that has as its object, the fight against terrorism.
- With the Inter Maritime Operations Centre (IMOC), which provides Albanian management and border control and interaction of state institutions that have liability and interest in the Albanian maritime space.
- General Directorate for Prevention of Money Laundering (GDPML), subordinate to the Minister of Finance.

- The General Directorate of Border and Migration in the State Police

Pursuant to the Law on the State Police (no. 108/2014, dated 31.07.2014) the The General Directorate of Border and Migration in the State Police monitors internally all the border line and Border Crossing Points (BCP) of the Republic of Albania. This department has human and logistic resources, which make possible the monitoring and the control of the green and blue border.

- Intelligence Service

It performs an important role in the fight against terrorism. Although it does not have executive powers the Intelligence Service, through its regional contact points, closely cooperates and exchanges sensitive information on terrorism-related activities with Albania's law enforcement agencies and general prosecutor's office etc.

- Albanian Armed Forces

According to the national legislation of the Republic of Albania, the Armed Forces of the Republic of Albania (AAF) do not have direct responsibility and accountability in preventing and combating terrorism. However, the Military Intelligence Service (MIS) of the AAF performs important support tasks in the prevention of terrorist acts. In particular, the MIS collects, analyses and submits information on activities that relate to terrorism. In compliance with the provisions of Albania's constitution and relevant laws the AAF may assist the State Police in guarding sensitive national institutions within the territory of the country.

1.4 Provide any additional relevant information on national efforts to prevent and combat terrorism, e.g., those pertaining inter alia to:

In the framework of measures for the prevention and fight against terrorist and extremism/religious radicalism/ethnic one that is under process, there have been planned and are being executed the following measures:

- Implementation of the national strategy related to extremism / radicalism (cooperating with all institutions and actors affecting this case), including also the cooperation at regional and international level;
- Cooperation and institutional support for religious communes of the country in order to intensify the inter-religious communication, of the religious harmony and isolation of the efforts to radicalize the religious people or other groups;
- Establishment of the national register for NGOs and increase of inter-institutional cooperation;
- Monitoring and controlling of financial transactions among NGOs related to terrorist networks and their audit;
- Finding of forms to stop the activity of the organizations that indoctrinate the citizens, pupils and the students with extremism and religious intolerance;
- The control of private dormitories organized by religious NGOs;
- Establishment of capacities with human and logistic resources, well trained against terrorism in order to prevent and fight these trends in Albania;
- Stop of entries in the territory of Albania for the individuals, who, uninvited from any organization want to entry in Albania to develop their terrorist activity, at the different religious post;
- Cooperation with religious organizations in order not to leave individuals and organizations to act uncontrolled in their fields of competences.

✓ Financing of terrorism

The first measures aimed at fighting the financing of terrorism in Albania were adopted back in 2004 (Law no. 9258, dated 15.7.2004 on the "Measures to fight the Financing of Terrorism). To implement the provisions of this law, the CMDs no. 718 and 767, dated 14.11.2007 on the "List of financers of terrorism" was approved. The law determines the measures against financing of terrorism, competences and cooperation among relevant structures charged with the control and the implementation of these measures. The purpose of this law is to prevent and fight against terrorist subjects and those who facilitate and finance terrorism, confiscating and seizing their funds and assets.

Later on, the Parliament of Albania passed Law no. 9917, dated 19.5.2008, "For the Prevention of Money Laundering and the Financing of Terrorism", which laid the ground for the approval of specific bylaws and regulations, especially CMD no. 1077, dated 27 October 2009 on "Approving the National Strategic Document", on "Financial Crime Investigation" and the Ministry of Finance's Guidance no. 15, dated 16.02.2009 on "Preventing Money Laundering and Fight against the Financing of Terrorism in the Customs System".

In the fight against financing of terrorism in 2013 Albania has adopted and is implementing the Law No. 157/2013 "For the measures against financing of terrorism".

The aim of this law is prevention and defeat of terrorist activity and they who support and finance terrorism, or to them, that are suspected that have committed or are committing or intend to commit such activities, through blocking, sequestration of the funds and their assets, in the implementation of the respective resolutions of the UN Council of Security, acts of

other international organizations or international agreements, where Republic of Albania is a party.

This law is implemented to the persons declared wanted and to the persons to whom started such a procedure, who are suspected to be part of any form of terrorism and its financing, committed in or outside the territory of the Republic of Albania.

State Police in the implementation of the DCM "For the list of persons declared wanted as financers of terrorism", respectively, with the information for the individuals included in these lists and made the notifications at the border for the monitoring of entries and exits in the Republic of Albania. In the implementation of the CMDs there have been:

- **Put in check list the** Albanian citizens involved in the conflict Syria/Iraq as well as the suspects, who plan to travel towards the Syrian conflict;
- **Interviewing of the returnees** by specialized structures of the fight against terrorism at the time of entry into Albanian territory, with the aim of providing evidence of the presence in the conflict zones and participating in military activities /training.
- **Put in the check list the foreign citizens,** included ethnic Albanians from the region, participants in the conflict, suspected of being affiliated with extremist organizations / terrorists or their financiers.
- **Update of lists of Security Council** for individuals & groups supporting financing of terrorism and to 49 individuals of which 34 located in the new checklist and 15 control list derecognized by the BCPs.
- Verification, identification and blocking of assets, accounts, transactions that
 operate in our country financial transactions or conduct business activities listed
 entities on the lists promulgated by the UNSC.

In order to implement the above-mentioned legislation and to effectively prevent money laundering and the financing of terrorism the GoA has set up the General Directorate for the Prevention of Money Laundering (hereinafter GDPML) at the Ministry of Finance. GDPML was first set up in 2001, and since then has served as the Financial Intelligence Unit of Albania. In line with the existing legislation the GDPML has, *inter alia*, the following mandate:

- To prevent money laundering and fight the financing of terrorism by means of gathering, verifying, assessing and controlling information provided by financial services providers, non-financial services providers and others;
- To prevent money laundering and fight the financing of terrorism by means of suspending or freezing any transaction in order to prevent the transfer or disposal of assets originating from criminal activities;
- Coordinate its activity with other law enforcement and intelligence agencies, such as the Ministry of Interior, General Prosecutor, the Intelligence Service of Albania, as well as other international agencies.

The GoA has also set up a special Inter-Departmental Committee to Coordinate the Fight against Money Laundering and the Financing of Terrorism. The committee is chaired by the Prime Minister and consists of the Ministers of Interior, Treasury, Foreign Affairs, Defence, Justice as well as the General Prosecutor, the President of the National Bank and the Director of the Intelligence Service. The Committee convenes at least once a year and has approved its regulations. It provides strategic guidance to Albania's national policy in the areas of money laundering and financing of terrorism.

In compliance with the EU recommendations, the State Police is continuously strengthening the fight against money laundering and terrorism financing. Interagency cooperation has been consolidated. Currently there are 7 Joint Interagency Investigation Units (Tiranë, Durrës, Vlorë, Fier, Shkodër, Korçë and Gjirokastër), consisting in 30 police officers, and experts of financial crime investigation structures.

In line with law no. 9284, dated 30.09.2004 "On Prevention and fighting of organized crime" and law no. 10192, dated 03.12.2009 "On prevention and fighting of organized crime and trafficking through preventive measures against criminal assets", the fight against organized crime is a strategic priority of the GoA and Albania's State Police. This objective has been reflected in the seven years strategy of State Police. Taking into account the trends and features of organized crime the application of sequestration and seizure methods of assets derived by criminal activities was evaluated as necessary.

The investigation of the criminal assets falls under the responsibility of the Section of Investigation of Criminal Assets, which is a special structure within the State Police.

Regarding the measures related to confiscated assets, law no. 10192 dated 03.12.2009 "On prevention and combating of organized crime and trafficking through preventive measures against criminal assets", clearly defines that incomes derived from seizure of criminal assets will serve to set up a special fund on prevention of criminality and legal education.

Specifically, this fund serves to:

- Improve Criminal Justice functions, by sending the assets into the administration of General Prosecutor and Ministry of Justice;
- Improve pre-investigations of organized crime and development of witnesses protection programs as well as the collaborators of justice by sending these assets into administration of the relevant ministry;
- Assist victims of organized crime, violence as well as stimulate social programs for these categories by sending these assets into administration of the relevant ministry.

Furthermore, CMD no. 1077, dated 27.10.2009, "On the Investigation of Financial Crime" has been approved. It aims to fight actively and continuously economic-financial crime, money laundering and terrorism financing; offences that seriously damage political and economical stability of the country, national security, and in general democracy and rule of law. This document aims at creating a long term platform as well as balancing effective prevention and investigation of crimes in economical and financial field, too.

CMD no. 44, dated 10.06.2009, on the approval of the regulation "On the prevention of money laundering and financing terrorism" aims at preventing the use of subjects listed in Law No. 9917, dated 19.05.2008, (for example, banks of second level) which are monitored and/or licensed by the National Bank of Albania on money laundering and/or financing terrorism.

✓ Border controls

Interpol System ASF2 is since 2010 integrated into TIMS and is not used only when needed, but accessed automatically in real time in any search or registration person, document or instrument the same easy access is also available in case of verifications nationals convert or category of deported citizens who are verified as suspects.

Despite that there is not a development of 2014, but previous, should be added that ASF2 Interpol system is already integrated into TIMS and it is not used only when needed but

questioned in real-time in every search or registration on any person, document or instrument as in the 2012 report stated that Interpol is enable for verification if it is necessary.

Also, should be added that in all stations of BMP where occurs deportations is associated the AFIS system of fingerprints, as in the 2012 report I is not mentioned, though, even this have been previously realized and not in 2013.

The online applications for permits of stay for the foreigners' citizens and their verification and approval have begun.

To ensure European standards border control and to meet the challenges of security, it has been prepared a new draft law on border control, which will be in full compliance with EU legislation in general and specifically with the Code of Border Schengen amended. The draft opinion was sent to all ministries and institutions concerned and it is expected that within the first 6 months of 2016 is approved. On completion of the entire legal framework in this regard have also been established working groups to draft bylaws for border control. In preparing the draft of this law are taken into account on ongoing measures to prevent and fight terrorist activities.

The new draft of the new "border control" brings in the prevention of terrorism, it is a provision that provides for refusal of exit of persons for whom there is suspicion that they are involved in crimes related to terror. This element is taken from the German legislation and seeks to prevent the movement of foreign terrorist fighters.

In the context of updating and improving the legislation for foreigners, it is designed the Decree of the Minister of Interior "On the procedures of treatment of foreign nationals staying irregularly in the territory of the Republic of Albania", approved by No. 293, dated 04.06.2015. In this guidance it is anticipated that the process of selection of foreigners, participate and anti-terrorism structure. Thus increasing the identification ability of law enforcement agencies to detect persons who may be linked to terrorist activities, taking actions that in the early stages of dealing with illegal aliens.

Currently, the Border and Migration Police (BMP) have increased the level of awareness and preparedness in relation to terrorism at all levels of its structure. Interviews frontline and second line during border crossings have terrorist activity by targeting a key. PKM conducted a survey of this nature as well as the entry exit. For all suspected cases BMP announces anti terror specialists to attend interviews and actions.

For the drafting of the new law on border control is working in constant cooperation with long-term expert Pameca 4 Integrated Border Management. Each element of the bill in question was faced with EU legislation in this field. At the design phase of each article it is in full compliance with the acquis communautaire. It is following the same line and work on the draft Decision of Council of Ministers and the draft Guidelines on implementation of the new draft law, while maintaining compliance with EU legislation.

Despite that the draft law provides for the preparation of bylaws to 6 months after the entry into force of the law, by-laws for its implementation are being prepared in parallel with the

process of adoption. With the adoption and entry into force of the law will be developed and appropriate training on how to implement it.

Practical activity of PKM in the field for interviews and checks carried out on persons suspected of involvement in terrorist activities carried out on the basis of information gathered by the BMP, the exchange between the agencies involved and on the basis of risk analysis on this issue. BMP implement Standard Operating Procedures, rogatory letters and the attractions of central attention in matters of terror. Primarily, as a model of refusals at the exit of persons suspected foreign terrorist fighters, it has been the model applied by Germany.

BMP proposed in 2015 the new structure of its restructuring within the State Police. The proposed structure of the BMP is approved and is being implemented.

- In this structure is enhanced the structure of the investigation and risk analysis that BMP. Sections of crime investigation in RDBM sector were raised and depend directly by the Director of RDBM. Also, the Investigation Section at the Directorate General of CPM has passed under direct subordinates of the Director General, aiming to boost the quantity and quality of information and investigations, both in terms of border control, as well as the management of migration. Structure Previous investigating BMP included within the Directorate of Operational Services, which was the main focus of border control.
- In all RDBM was appointed a specialist dedicated to risk analysis. Previous structure at regional level, the risk analysis included within structures investigation, where a specialist investigation, in addition to preparing the investigative work of risk analysis. Already dedicated specialist will collect and process information and data in a broader plan, preparing full analytical materials and more targeted.

Use of non intrusive technology (non intrusive) persons applied systematically in Tirana's international airport, where every citizen spends on the respective detectors and their baggage is also screened. At other points Crossing applied radiation detectors, mainly for tools, as well as the generation detectors (Pager) for identification of radioactive materials to persons, baggage and vehicles. All these checks are performed without stopping the movement of people and vehicles, without causing delays at the border crossing. BMP is permanently in cooperation with partners and donors for providing such kind of equipment and the extent of their use throughout the Republic of Albania BCP and along the border line.

For vehicles and baggage to the point explanation is given above.

BMP is in constant cooperation with commercial entities as regards checks of persons and vehicles that may be involved in various criminal activities, including terrorism.

- Regarding the airlines international airport, currently a daily cooperation. Carrier send Rinas Airport in advance of their passenger lists, which are accessed by the BMP before the arrival of the aircraft. These lists vetted selection regarding persons who may pose a risk. In 2015 it signed a Memorandum of Understanding and Cooperation between the State Police and KPS Tirana International Airport Operations at Tirana International Airport "Mother Teresa";
- Passenger lists carriers in maritime BCP, also accessed in advance by the BMP;
- BMP cooperate consistently with international partners. This cooperation is based on exchange of information on border and migration issues, including cross-border crime issues in the drafting of various international agreements, the development of joint

operations, the provision of technical equipment and providing training.

It is noteworthy exchange of information between BMP and liaison Germany, UK, Belgium, Greece, etc. A high level of cooperation between BMP and presented the Department of International Cooperation and Coordination, which supplies the information from liaison officers of the State Police attached to various European countries.

- ➤ In the framework of cooperation they were prepared in 2015 and approved:
 - Protocol between the Ministry of Internal Affairs of the Republic of Kosovo and the Ministry of Internal Affairs of the Republic of Albania "For the immediate prosecution of cross-border", adopted by the Council of Ministers on 23 March 2015.
 - Protocol between the Ministry of Internal Affairs of the Republic of Kosovo and the Ministry of Internal Affairs of the Republic of Albania "On joint use of equipment for border control", adopted by the Council of Ministers on 23 March 2015.
- In the framework of cooperation they were prepared in 2015 and are in the process of approval:
 - The Protocol to the Agreement between the Government of the Republic of Albania and the Government of Montenegro for the Common Ground Grabo-Zatrijebacka Crossing Cijena.
 - Protocol between the Ministry of Internal Affairs of the Republic of Albania, the Ministry of Internal Affairs of Montenegro and the Ministry of Internal Affairs of the Republic of Kosovo on the establishment and operation of a joint center for police cooperation in Pljevlja Montenegro .
 - Protocol between the Ministry of Internal Affairs of the Republic of Montenegro and the Ministry of Internal Affairs of the Republic of Albania "For the immediate prosecution of cross-border"
 - Protocol between the Ministry of Internal Affairs of the Republic of Macedonia and the Ministry of Internal Affairs of the Republic of Albania "For the immediate prosecution of cross-border".
 - a. During 2015, employees of the structures of BMP were active in joint operations organized by FRONTEX. Within these operations, it is a combination of Border Police officers Albania in EU countries and experts from the EU countries decided in our country. In 2015, settled 8 Albanian employees at airports / BCPs terrestrial / Center Coordinator International Maritime and Local EU countries and 9 EU experts who respectively settled in BCP Rinas, Murriqan and Hani Hoti and contribute through their experience and best practices of their countries in various fields such as: control of the second line, counterfeit documents, the discovery of stolen vehicles etc.
 - b. Also, in the framework of cooperation in the Western Balkans with the organization of DCAF, developed 2 joint operations and 2 coordinated operations in 2014. During the joint operations in the BCP and green border to border officers have been exchanged the participating countries, which have worked during the operations in the border areas where the operation was conducted. During coordinated operations statistics exchanged between the BCP participating in the operation of the countries involved, in terms of control of persons, vehicles, documents and cross-border crime.
 - c. During 2015 there have been conducted:
 - With Kosovo police 169 joint patrolling;

- With the police of Montenegro 233 joint patrolling;
- With the police of Macedonia 114 joint patrolling.
- With Guardia di Finanzia 166 joint patrolling.
- With Greece 3 joint operations against the trafficking of narcotics and vehicles stolen through the border.
- d. During 2015 it has been cooperated with the Federal Police of Germany, which has supported BMP experience, knowledge and best practices in the prevention and detection of illegal immigration and the prevention and impact of cross-border crime by means of surveillance and border control. To support this association it has been signed a Memorandum of Cooperation between the State Police and German Federal Police. The joint event was held at border control Kapshticë BCP and BCP of Kakavija with the German Federal Police personnel who consisted of 12 employees, divided by 6 in each BCP. German police officers began activity on 16.07.2015 and finished it in November 2015.
- e. During 2015, employees of the structures of the General Directorate of Border and Migration have performed a total of 60 trainings and are trained 734 police officers, while there have been held 2 (two) and one month from 20 employees to the basic role of newly appointed operational structures of Border and Migration. Trainings were conducted in accordance with the Thematic Plan 2015 in cooperation with EXBS, PAMECA IV Mission, OSCE, Hanss Seidel Foundation, missions of UNHCR, UNODC, IOM, German and French experts etc.
- f. During this period, working in cooperation with international partners to increase the number of equipment, maintenance and extension of coverage to the border with technological equipment. In this context, perform maintenance and repair of equipment for second-line control, like endoscopes, buster, etc. It increased the number of devices that are used in green border control, as Smartdec, GPS, binoculars day and night, etc. These devices are mainly provided by cooperation with EXBS and the state budget. In the framework of the added equipment and coverage of borderline with technological equipment, they were identified by the CPM some of the needs of projects that will be developed during 2016.

Border control at entry and exit of RA, all persons crossing the border are subject to various checks and interviews. In case of doubt on the first line controls persons may be subject to detailed checks. Frontline controls consist in verifying the identity of the person, the authenticity of the document, the consultation system for different notes about people and things.

Besides interviews routine, from where the result that the person may be involved in terrorist activities in the TIMS system currently has integrated a list of concrete persons, suspected to be involved in these activities, which are subject to controls and actions other BMP and other structures of the State Police. Exchange of information with the structures responsible for counterterrorism is permanent and updated information in this regard.

Green border patrols supervised by BMP with appropriate equipment for effective supervision and policing based on risk analysis and information.

In case of issuance of visas and in the case of issuance of residence permits continued cooperation between the MFA, BMP and SIS, as provided by law. In 2015 continued to

function normally electronic register of foreigners, which is reflected in the electronic device foreign nationals with residence permits, addresses, contacts and other data. The exchange of information is carried out based center in real time.

One of the most important in evaluating the issuance of a visa or residence permit to a foreigner is its involvement in activities related to terror. In cases of foreigners who seek asylum in the Republic, or who are subject to the return and readmission by the BMP are interviewed and the selection of a foreigner. As explained above, during interviews attend anti-terror structures of the State Police and SIS.

To conduct maritime security, RA has under its subordination IOMC, including 7 Ministers with specific duties in border security. Maritime Operational Centre, in cooperation with the Regional Border and Migration Durres and Vlora and the Mobile Operations Unit (Delta Force) during the year were conducted 172 checks for control of maritime space, 54 rescue operations and giving support in the sea, 56 operations for the prevention and defeat of the illegal activities in the sea. It has been cooperated with the Customs, Coastal Guard, etc. The result of these operations is the sizure of 2 vessels and 122 kg narcotics kanabis sativa.

Regarding air security, despite BCP controlling the activities, there have been included also TIA (together the ICTS), Civil Aviation, ANTA and other responsible agencies. Cooperation is ongoing. The Agreement of Understanding and Cooperation is signed in 2015, as abovementioned.

✓ Travel document security

As of 1 March 2012 biometric passports are the only travel document of Albanian citizens. All BCPs use biometric passport readers and equipment for fingerprint verification. The use of biometric electronic documents has facilitated registration at BCPs because most of the data is processed in a shorter time. Reading of electronic documents via scanners that are used by Border and Migration Police is simpler. It is also possible the automatic reading of the image of the holder of the document. Real-time registration into TIMS system of documents and their reading during entry/exit at border crossing points, gives the possibility of comparison with the existing data reducing the possibility of abuse.

Additionally, border notifications with different features reflected into TIMS in real-time increases the quality of border control. At the same time TIMS system generates in real-time also the alerts on persons sought nationally or internationally. Alerts are generated also for suspected persons on different criminal events.

Implementing the Ordinance of Police General Director no. 503 dated 02. 06. 2008, Interpol Tirana records continuously the lost/stolen documents into Interpol Databases System. During 2011 into IPSG ASF2 System have been registered 3154 passports.

The IT directorate web page has PRADO's link, enabling every employee in consultation with the specimen of documents of various countries in BCP. In terms of security documents of the country, in addition to direct TIMS data, and the data integrated to the National Civil Registry that help to consult in case of need of verifying the identity of an Albanian citizen with a biometric document.

✓ Container and supply chain security

The port of Durres receives approximately 80% of the 1,500 sea containers entering Albania each month, the bulk from the People's Republic of China and South America via feeder routes from Greece, Cyprus and Italy. The remaining 20% of the container traffic arrives overland via two border points with Greece - Kakavija and Kapshtica from different points of origin including Turkey.

The Customs Service of the Republic of Albania operates in compliance with the provisions of the Customs' Code. Control procedures at the crossing points are carried out in keeping with the stipulations of Section 2 of the Code (articles 11 and 12) "On Control, Supervision and Competences of Customs Service".

With reference to the equipment used to screen containers, Custom Service currently has one Nuctech mobile scanner in the port of Durres. Other four scanners have been installed since 2010; each of them is used at the border crossings of Kakavija and Kapshtica, as well as at the smaller port of Vlora.

Customs uses "ASYCUDA World" for their basic risk analysis system which is based upon the nature of goods, country of origin, the history of the importing company and any other intelligence. Meanwhile, the Border Police have their own, separate risk analysis system, but it is envisaged that in due course the systems in use will be common, thus enabling better targeting of illegal activities to include all aspects of trans-national crime.

Border and Migration Police closely cooperate with the Custom Service based on the provision of the relevant Memorandum of Understanding. Although Border and Migration Police deals primarily with the control passengers and vehicles, it closely cooperates with the Customs in cases of detections of illegal activities, which are processed jointly.

The effectiveness of the Cooperation has increased as a result of the implementation of Albania's Integrated Border Management plan. Customs have undertaken joint training at the police academy and are currently drafting a joint training plan with the police. They have several joint teams who share equipment, vehicles and accommodation.

✓ Security of radioactive sources

Protection from radiation in the Republic of Albania and the safety and security of sources of ionizing radiation is provided for by Law no. 8025, dated 9.11.1995 "On protection from ionizing radiation", amended in July 2008. Albania's legislation is in compliance with EU directive 96/29 and BSS No.11. The law also ensures the effective independence of the regulatory Body, reinforced through the 2008 amendments. The Radiation Protection Commission (RPC) members are nominated by the Council of Ministers without conflict of interest with users.

The above mentioned law includes provisions on security and safety of radiation sources, on duties and functions of the Regulatory body, regulatory responsibilities, the way of completion of legislation in the field of radiation protection and duties of the Office for Radiation Protection (ORP). This law also provides for the licensing of all activities and practices related to ionizing radiation as defined in relevant regulations. The Law also opens

the way to full inspection process and sanctions. Basically, our legislation is founded on four basic pillars, namely legislation, licensing, inspection and sanctions.

The 2008 amendments took into consideration other elements such as security of source, increasing the independence of the regulatory body, increasing the level of adoption of relevant regulations through relevant CMD, national inventory of ionizing radiation near the ORP. Since 2004 RPC is working toward implementation of "Code of Conduct on Safety and

Security of Radioactive Sources" IAEA. It has adopted and approved a set of regulations in the radiation protection field, safety and security.

The Council of Minister of Albania has further approved:

- The Regulation "On the physical security of the radioactive materials in the Republic of Albania", Decision No 344, date 29 April 2011;
- The Regulation on "Categorization of radioactive sources in the Republic of Albania", Decision No. 09, date 07 January 2010 of Council of Ministers;
- The Regulation "On the treatment of radioactive waste", Decision No. 08, date 07 January 2010 of Council of Ministers.

The RPC has approved and implements the Guidance on import-export and transit of radioactive sources of category 1 and 2 in the Republic of Albania (no. 134, date 12.4.2011). RPC adopted a declaration in support of "Code of Conduct on Safety and Security of Radioactive Sources" IAEA Nr. 1388 14/04/2004 and a letter was sent and the Director General of ANEA stressing the fact that Albania is working towards the implementation of this Code.

Implementation of relevant international standards, for example, compliance with IAEA Regulations

The above documents are in compliance with IAEA documents related to security of radioactive sources. They also take into account elements of security during the transport.

Changes in institutional arrangements

Strategy development

The RPC is currently working to draft the National Policy and Strategy for the treatment of radioactive waste in Albania.

Measures to prevent the illegal storage, circulation or use of CBRN weapons and related materials

The RPC is a part of the system mainly related with prevention of trafficking and search of any orphan source.

Measures to regulate laboratories and other premises involved in the production, storage or use of the above

Albania already has a consolidated system on procedures for licensing inspection and enforcement. There is no production of radioactive sources in Albania

Awareness raising with relevant trade bodies (laboratories, regulatory bodies etc)

The Center of Applied Nuclear Physics works as a supporting team in the case of orphan sources.

International co-operation/technical assistance activities (for example, participation in NATO CBRN training)

RPC has been working with the US Government on that issue.

✓ Use of the Internet and other information networks for terrorist purposes

The 2008 amendments of the Criminal Code of Republic of Albania (law No. 10023, dated 27.11.2008) added 12 new provisions defining cyber crimes in the field of information technology or criminal offences committed through computer systems. These changes are based on the Budapest Convention on "Cyber Crimes" (ratified by parliament in 2000) and the Protocol of the Convention on Cyber Crimes, with regard to penalizing the racist or xenophobic acts via internet. The provisions of the Criminal Code define procedures of sequestration and fastened safety of computer data, based on the Budapest Convention on "Cyber Crimes".

All e-communication systems operated and used by police structures are monitored and secured based on the special Memorandum of Understanding between the Embassy of United Stats in Albania, ICITAP Programme in Albania, Ministry of Interior of Republic of Albania and Albanian State Police signed in Tirana on 20 November 2006.

All activities and incidents comprising breaches of the Code fall within the jurisdiction of the State Police, which operates through the pertinent central institutional mechanisms: the section against Cyber Crimes. This section was established within the Department for Crimes Investigation of the General Police Directorate of Albania in June 2009. This newly-created structure examines cyber evidences, investigates cyber-crimes and other crimes related to the use of computer and computer networks for terrorist purposes as well for money laundering in order to finance terrorism on the internet. Its staff has steadily increased to meet the growing need of the section. Today it employs 22 police (it was founded with only 6 police officers).

The Albanian Parliament has adopted the Law No. 9699, dated 26.03.2007, "On the ratification of Cooperation Strategic Agreement between the Republic of Albania and the European Police Service (EUROPOL)" which was signed on 05.02.2007. On 1 December 2009 the following documents have been signed in Hague;

- The Memorandum of Understanding on the establishment of secure communication networks between Europol and the Republic of Albania;
- The Action Plan on the Implementation of the Cooperation Strategic Agreement between the Republic of Albania and EUROPOL;
- Technical Document, Bilateral Agreement between Europol and the Republic of Albania on the installation of Computer Networks.

Regarding Europol by DCM No. 566, dated 27.06.2013, it was adopted, in principle, the agreement between the Republic of Albania and the European Police Office for Strategic and Operational Cooperation. Albania signed the Strategic and Operating Agreement with Europol on the 9th of December 2013 and ratified it on 20 March 2014 in the Parliament of

the Republic of Albania by Law no. 28.2014. This is the highest form of cooperation with the agency regarding the safe exchange of data.

Regarding Interpol in relation to extradition matters, we inform you that Albania currently has bilateral extradition agreements with Italy, USA and Kosovo. Based on these agreements, may be arrested in Albania, citizens wanted by these respective countries, with the aim to be extradited to these countries.

✓ Legal co-operation including extradition

According to the Constitution, the extradition of an Albanian citizen without a bilateral treaty in place, expressly providing for the extradition of Albanian citizens, is prohibited. Yet, the Albanian legislation does not require a bilateral treaty for the consent to extradition when the person in question is not an Albanian citizen.

Article 11 "Extradition" of the Criminal Code of Republic of Albania stipulates that "Extradition may be permitted only if it is expressly provided for in international agreements to which the Republic of Albania is a party". Pursuant to the provisions of the Criminal Procedure Code, extradition is permitted only on basis of a request addressed to the Ministry of Justice (MoJ). The request may be addressed directly or via diplomatic channels. If the MoJ accepts the extradition request it conveys the procedure to the appropriate authorities.

The Criminal Procedure Code of Albania devotes special articles (488-503) to the legal relations with foreign states on criminal matters and to the detailed procedures that govern extradition.

The conditions of extradition are specified in article 490, i.e.:

- Extradition is permitted under the express condition that the person subject to extradition shall not be prosecuted, sentenced nor shall he be surrendered to another country for a criminal offence which has occurred prior to the request for the handover, other than the one for which the extradition is provided for;
- The requirements of the paragraph 1 shall not be considered if: a) the extraditing party gives express consent that the extradited person is prosecuted even for another criminal offence and the extradited person agrees thereupon; b) the extradited person, although having had the opportunity, has not left the territory of the country he is extradited after forty five days from his release or after has left is returned voluntarily.
- The Minister of Justice may impose even other requirements it deems appropriate.

Furthermore, Albania is party to several legal agreements regarding the cooperation in the criminal field and part of some Conventions and International Treaties:

- European Convention on Extraditions, entered into force on 17/08/1998.
- European Convention for Mutual Legal Support, ratified on 04/04/2000.
- European Convention on the Transfer of Criminal Proceedings, ratified on 04/04/2000.
- European Convention on International Validity of Criminal Decisions,
- Convention for the Transfer of Convicted Persons, ratified on 04/04/2000.
- Convention on Cyber-crimes, ratified on 20/06/2002.
- Additional Protocol of the Convention on Cyber-crimes, with regard to penalizing the racist or xenophobic acts via Internet, ratified on 26/11/2004.
- Convention of the CoE of the Prevention of Terrorism, ratified on 06/02/2007.

• Convention of the Council of Europe on Laundering, Detection, Seizure and Confiscation of Crime Proceeds and Financing of Terrorism etc.

The communication between Albania and other countries in the area of mutual legal assistance in criminal matters is governed by appropriate international agreements to which Albania is a state party and by the relevant stipulations of Albania's Criminal Procedure Code (Articles 488-503). Albania is party, *inter alia*, to the European Conventions:

- "On Mutual Legal Assistance in Criminal Matters" and its additional protocols, signed on 9.05.1998, ratified on 04.04.2000 and entered into force on 03.07.2000;
- On transfer of proceedings in criminal matters" signed on 19.05.1998, ratified on 04.04.200 and entered into force on 05.07.2000.

Following the entry into force of the Conventions, the Republic of Albania provides proper mutual legal assistance in criminal matters, in conformity with its provisions.

Most recently the Albanian parliament passed Law no. 10193, dated 03.12.2009 "On Jurisdictional Relations with Foreign Authorities in Criminal Matters". The approval of this law marks a significant step forward in the improvement of Albania's legal framework in the area of legal assistance in criminal matters.

The provisions of the new Law comply with EU standards create a new system centered on the authority the Ministry of Justice. However, cases in which local and foreign authorities can send their requests directly to Courts or public prosecutor's offices have also been envisaged.

There are two other positive aspects of the law that are worth mentioning:

- The new system is highly effective due to the presence of precise deadlines for each procedure;
- Clearly defines competences for international arrest warrants for Albanian citizens. In fact, the new Law has attributed to public prosecutor's offices specific competences in issuing the aforesaid warrants both during investigative phases and at the end of trials.

✓ Safe havens and shelter to terrorists and terrorist organizations

The Republic of Albania has taken several measures to prevent the use of its territory as safe haven and shelter to terrorists and terrorist organizations. Among others, the Counter Terrorism Directory of the General Police Directorate in close cooperation with Border and Migration Police controls and monitors suspect individuals that enter end reside in the territory of the Republic of Albania. These tasks are also performed by other state agencies involved in the fight against terrorism, in particular by the Intelligence Service. The latter has no executive powers, but in the framework of the cooperation with other law enforcement institutions, it collects (including the data of informative services of foreign partner countries), assesses and analyses information on the use of Albanian territory for purposes of terrorist activities against other countries and as appropriate, it cooperates with State Police and/or Prosecutor's Office for the prevention of this activity.

BMP is in close collaboration with the sector and sections of counter terrorism to prevent and fight them at the border and in the territory. Exchange of information is continues in this regard. Also, as in the case of the issuance of visas and in cases of issuing residence permits, the cooperation between the MFA, BMP and SIS, continues as provided by law.

In 2013 a new Law has been approved no. 118/2013 "On foreigners" in comply with the directive and recommendations of EU.

The bylaws for the implementation of this law are also in accordance with EU legislation. Even refusing entry form in RA has been approved in accordance with the standard form the Schengen area.

✓ Prevention of violent extremism and radicalization that lead to terrorism

The security threat stemming from violent extremism and radicalization that lead to terrorism has been acknowledged and duly addressed in the "National strategy on the fight against terrorism". In this regard, the prevention of the phenomena that might bring about violent extremism and radicalization is one of the key elements of the Strategy, which aims to "reduce the threat of terrorism to our country and its interests, by improving security and increasing community's confidence in the national measures tailored to prevent terrorist acts".

Responsible institutions are tasked to put in place legal and administrative measures in order to analyze, assess and follow up any signal that might bring about terrorist acts. One of the main objectives of this Strategy is to "Develop and enhance the transparency for community with regard to negative phenomena that might lead to radicalism or extremism" This target will be achieved by strengthening cooperation between all police structures and civil society in order to exchange information in relation to all forms of radicalism and extremism. It also is important that cooperation between the anti-terrorism structures and community police officers who organize meetings with community in order to raise awareness and prevent all forms of radicalism and extremism. These measures have been foreseen in the Action Plan Strategy.

The prevention of terrorist and extremist acts in the Strategy is specified in one of its objectives as follows; "The control of grievances that may lead to radicalism and extremism". The injustices and complaints as a result of lack of tolerance between community groups can have a strong impact on the level in which the individuals will accept radicalism and extremism. It is important also the commitment with the isolated communities in order to efficiently control their differences to reduce pressure and to increase dialogue.

The early identification of conflicts is one of the most important steps to prevent terrorist acts. It is important to support individuals who are judged to be exposed to extremism and radicalism. The main purpose is to identify these individuals at an early stage (in advance) (before they commit a terrorist act), by giving them legal aid and by dissociating them from extremist activity. These measures will be associated by necessary legal and administrative acts that guarantee the permanent phases of cooperation with these individuals.

These preventive measures will be implemented by the Ministry of Education and Science, by the Regional Educational Directorates, High Schools as well as in cooperation with State Police in the framework of the fulfillment of the annual training plan during 2011 has conducted the following trainings related to the fight against terrorism with the officers of the anti-terror structures:

- Training with topic "Criminal Offences against Terrorist Acts" from 08.01.2011 until 01.02.2011 in Cairo, Egypt, with the participation of 20 officers.
- Training with topic "Fight against Terrorism 2011" from 26.09.2011 until 30.09.2011 in Belgrade, with the participation of 2 officers.
- Training with topic "Criminality Regarding Cyber Crime in the Field of Organized Crime, Terrorism and Money Laundering, from 28.09.2011 until 30.09.2011 Police Educational Centre, with the participation of 12 officers.
- Training with topic "Different European Models of the Fight against Organized Crime, White Collar Crimes, Fundamental Cases against Money Laundering and Financing of Terrorism as well as the Investigation Procedures of these Cases", from 24 until

26.10.2011 in the Prosecutors Office with the participation of 7 officers.

• Counter terrorism Training with the UK Embassy

✓ Public-Private Partnerships (PPPs) in countering terrorism

The public institutions involved in the fight against terrorism are: the Ministry of Interior, the Department for Crime Investigation and the Directorate against Serious Crimes/Sector against Terrorist Acts. All these structures have an important impact on the prevention of financing terrorism and terrorist acts. These structures conduct procedural and investigative activities as well as cooperate with other security institutions especially with the Anti-terror Directorate, in the Albanian Intelligence Service. These structures cooperate with the General Prosecutors Office, which is the institution involved in the fight against terrorism. At the same time in the General Prosecutors Office works the Interception and Telecommunication Office.

State Police Directorate in the fight against terrorism and financing of terrorism closely cooperates with the Ministry of Finances with FIU which is a specialized financial unit for the prevention and fight against money laundering and financing of terrorism. This directorate works as a national centre in charge of gathering, analyzing and delivering to the law enforcement agencies of data on the possible activities of money laundering and financing of terrorism.

- In order to prevent the financing of terrorism and terrorist ASP, DCM "On the list of persons designated as terrorist financing," concerned with getting information to individuals involved in these lists made announcements in border monitoring the entry exit in the Republic of Albania. In pursuance of these CMD they are:
- Set checklist Albanian citizens participating in the conflict Syria / Iraq and the suspects, who plan to travel to the Syrian conflict.
- Interviewing returns from specialized structures of the fight against terrorism at the time of entry into Albanian territory, with the aim of providing evidence of the presence in the conflict zones and participating in activities / military training.
- Set checklist foreign nationals, including ethnic Albanians from the region, participants in the conflict, suspected of being affiliated with extremist organizations / terrorists or their financiers.
- Updating the lists of the Security Council for individuals & groups supporting terrorism financing and to 49 individuals of which 34 located in the new checklist and 15 control list derecognised by the NCCP.
- Verification, identification and blocking of assets, accounts, transactions that operate in our country financial transactions or conduct business activities listed entities on the lists promulgated by the UNSC.
 - Protection of energy infrastructure from terrorist attacks

International Cooperation is based on a working agreement on the establishment of operational cooperation between the Ministry of Interior of the Republic of Albania and the European Agency for the Management of Operational Cooperation in the External Borders of the Citizens Members of the EU (FRONTEX) - adopted on 18 February 2009;

During joint operations on BCPs and the Green Border there have been exchanged border officers of participating countries who worked during operations in the Border Unit where the operation has been developed.

During coordinated operations there have been exchanged statistics between the BCPS participating in the operation of the countries involved, in terms of control of persons, vehicles, documents and cross-border crime.

In the framework of international cooperation, it has been signed on 3 October 2008 the Memorandum of Understanding between the Ministry of Interior of the Republic of Albania, Bosnia-Herzegovina, Croatia, Macedonia, Montenegro and Serbia aiming to establish a system for the exchange of statistical information on illegal migration and involvement in a regional system for the early prevention.

- Cooperation with the Italian law enforcement authorities (Guardia di Finanza):

In the framework of the Sea Border Control and Surveillance, the Border and Migration Police closely cooperates with Guardia di Finanza based on the Protocol of Understanding between the Government of the Republic of Albania and the Government of the Republic of Italy regarding the program for the development and support of Albanian Police Forces and between the two countries in the fight against criminality, between the Italian Liaison Office in Albania and the Albanian Liaison Office in Italy.

With this Unit which is located in Durres and Sazan Island, has been established a good tradition and the common activity in the operational framework is based on the following aspects:

- Organization of common measures in order to increase security in ports.
- Pursuant to international agreements the regime of movement of vessels in the internal and territorial maritime area.
- The exchange of information in the investigation-rescue operations.
- Organization of measures for the prevention and defeat of illegal activities via sea. Cross border cooperation

✓ Cross border cooperation

After the adoption of the new IBM Strategy, based on the EU Recommendations for Western Balkans countries on IBM, also pursuant to the Convention for Police Cooperation between SEE Countries signed in Vienna on 5 May 2006, Albania is focused in concrete fields of the cross-border cooperation with foreign countries.

The Council of Ministers of the Republic of Albania and the Government of Montenegro has signed the Protocol "On the conduction of joint activities of Border Control in JBCP Murriqan - Sukobine. The signing of this protocol has guaranteed the functioning of the JBCP according to standards based on the principle "one stop, one check" not only between the agencies of one party but between the agencies of both countries in the JBCP, by facilitating the border control procedures in this JBCP and by reducing the time for the control of individuals and vehicles.

There have been signed and are being implemented the Agreement for Cross Border Police Cooperation with Montenegro, Macedonia and Kosovo through which countries are committed to:

- Organise meetings between Border Police leaders at local, regional and national level;
- Establishment of Contact Persons between Border Policies at national level;
- Establishment of the Liaison Officers Network;
- Construction of joint BCPs, integrated as well as joint offices for exchange of

information;

- Establishment of joint patrols;
- Exchange of Risk Analysis Information;
- Encouragement of joint operations;
- Joint Management of information;
- Coordinate joint investigations;

In particular, "Joint Procedures of Border Control for BCPs of Morinë, Qafë Morinë and Qafe Prush" are in place between Albania and the Republic of Kosovo.

Albania has signed Protocols for Border Joint Patrols with Montenegro and Macedonia, while joint operations aiming to "defeat any type of border trafficking, and to prevent illegal border crossing" have been organised with the Greek Police. This is done by synchronising forces and dividing service sectors. At the end of each operation a joint analysis of the results is conducted.

National Contact Points between Border Police have been established and are operational in Albania.

Technical assistance benefits by border police in the framework of "IPA 2009" are the following:

- Seven vessels for the blue border structures have been delivered.
- The construction of Border and Migration Commissariat of Saranda has started;
- The equipment for the radio-communication system, for the Inter-institutional Operational Maritime Centre have been delivered and have been made all necessary arrangements from the IT specialist.

Besides joint patrols, central and regional meetings as well as co-existing agreements, signed in 2013 and implemented in practice include:

Cooperation with the Republic of Kosovo:

Agreement and Protocol between the Government of the Republic of Albania and the Government of the Republic of Kosovo for the opening of the joint cross border point Borje (Kukes) - Glloboçica (Dragas) between the Republic of Albania and the Republic of Kosovo. Signed in April 2013. The goal is to apply also in this BCP the working method as in the JBCP of Muriqan Sukobine. Approved in principle by the Council of Ministers of Republic of Albania.

Agreement and Protocol between the Government of the Republic of Albania and the Government of the Republic of Kosovo for the opening of the Joint BCP of Orgjost (Kukes)-Orçush (Dragas) between the Republic of Albania and the Republic of Kosovo, signed in April 2013. The goal is to apply also in this BCP the working method as in the JBCP of Muriqan Sukobine. Approved in principle by the Council of Ministers of Republic of Albania.

Agreement and Protocol between the Government of the Republic of Albania and the Government of the Republic of Kosovo for the opening of the Joint BCP of Shishtavec (Kukes) - Krushë (Dragas) between the Republic of Albania and the Republic of Kosovo. Signed in April 2013. The goal is to apply also in this BCP the working method as in the JBCP of Muriqan Sukobine. Approved in principle by the Council of Ministers of Republic of Albania.

Agreement for the establishment of the Joint Police Cooperation Center in Morin-Vermicë with Kosovo. This agreement is part of the implementation of the requirements of the Vienna

Convention which deals with the establishment of Joint Centers of Police Cooperation between countries, with the aim of facilitating information exchange routes. Signed in April 2013. It has started its activity.

Cooperation with FYROM (Macedonia):

Agreement between the Government of the Republic of Albania and the Republic of Macedonia for the opening of the New Point of International Road Border Crossing between the two countries, Xhepisht-Trebisht "Tirana on 16.11.2005.

• This agreement was the basis for the opening of this BCP. With the agreement signed in Tirana on 11.23.2012, this BCP becomes JBCP for local circulation of citizens and vehicles. This BCP has started its activity.

Agreement between the Ministry of Interior of the Republic of Albania and the Ministry of Interior of the Republic of Macedonia for the establishment and operation of a Joint Police Cooperation Center, signed in Skopje on 15.03.2012. This agreement is part of the implementation of the requirements of the Vienna Convention which deals with the establishment of joint centers of Police Cooperation between countries, with the aim of facilitating information exchange routes. This center has started functioning.

Cooperation with Montenegro, under process:

Agreement on the Joint Police Cooperation Center Muriqan with the Police-of Montenegro. This agreement is part of the implementation of the requirements of the Vienna Convention which deals with the establishment of joint police cooperation centers between the countries, with the aim of facilitating information exchange routes.

Additional in the Implementation Protocol "To carry out joint border control activities in the BCP of Muriqan/Sukobine". Protocol "for conducting joint border control activities in the JBCP of Muriqan / Sukobine" signed in Shkodra on 18.06.2009.

2. Stationing of Armed Forces on foreign territory

2.1 Provide information on stationing of your States Armed Forces on the territory of other participating States in accordance with freely negotiated agreements as well as in accordance with international law.

Albania does not have armed forces permanently stationed on the territory of other OSCE participating states. As part of international operations Albania deploys on temporary bases military units in the framework of multinational military formations which carry out activities as part of the UN, EU and NATO.

The temporary deployment of Albanian military personnel on the territory of other OSCE participating States in the context of training and exercises is governed by bilateral agreements with the respective countries.

With reference to the area of application of the Code of Conduct on Politico-Military Aspects of Security, Albania currently contributes with 1 Staff Officer representative of AAF in EU Operation ALTHEA in Bosnia-Herzegovina.

Albania also currently contributes with 14 military personnel (13 staff officers and 1 NCO) in the KFOR Headquarters in Kosovo.

Outside the OSCE area Albania contributes with 43 military personnel in "Train, Advice, Assist Commands West, Capital and North" as part of Resolute Support Mission (RSM) in Afghanistan.

The decision on the participation of troops deployed abroad.

The Law no. 9363, dated 24.03.2005 "The manner and procedure of deployment, and passage of foreign military forces in the Republic of Albania and sending the Albanian military forces abroad", as amended, deals with participation of Military Forces in international military operations organized, authorized or directed by NATO or the European Union.

Council of Ministers with the proposal of the Minister of Defense decides on the participation of the Armed Forces of the Republic of Albania in international military operations organized, authorized or directed by the NATO, or the European Union, case by case, by defining the mission, level of participation, duration of the operation, as well as any other necessary element to conduct of military operations.

Sending Albanian military units under this section applies only to cases where, preliminarily is achieved an international agreement on the status of the Albanian military forces in the place where the military operation is carry out.

3. Implementation of other international commitments related to the Code of Conduct

3.1 Provide information on how your State ensures that commitments in the field of arms control, disarmament and confidence and security-building as an element of indivisible security are implemented in good faith.

The OSCE documents on arms control, disarmament and confidence- and security-building measures constitute an essential pillar of Europe's current security architecture. The faithful observation of the provisions contained therein and the implementation of existing commitments in the spirit of transparency and cooperation - as a tangible contribution to Europe's indivisible and cooperative security system – is ensured in close cooperation by appropriate state structures, in particular by the Ministry of Foreign Affairs and Ministry of Defence.

The Albanian Arms Control and Disarmament policy is based on the principle of undiminished security at the lowest possible level of armament. The Republic of Albania is continuously working toward the effective implementation of all international obligations, including the implementation of international treaties and conventions.

The Republic of Albania fully complies with the commitments and the spirit of the Code of Conduct on Politico-Military Aspects of Security and the Vienna Document 2011, including the provisions of Chapter IX of the VD-11 (Compliance and Verification) on inspections and evaluation visits.

During 2015, Albania has conducted an Evaluation Visit in Republic of Montenegro and has conducted an Inspection Visit in Republic of Serbia with "guest inspector" from German Verification Centre.

According to Vienna Document 2011 (VD-11), Chapter IX "Compliance and Verification" Albania has obligation to accept three inspections of specified area and one evaluation visit during the annual calendar. Meanwhile, for 2015 Albania has received an Inspection visit from Russia Federation Verification Agency in June 2015 and an Inspection visit from Bosnia-Herzegovina in October 2015.

Furthermore, the Republic of Albania has already fulfilled all legal obligations stemming from Conventions on Chemical Weapons, Cluster Ammunitions and Prohibition of Anti-Personnel Mines. With respect to the Convention on the Prohibition of the Use, Stockpiling, and on their Destruction Albania has fulfill all necessary obligations.

Albania exchanges military information, defense planning information and all dates concerning to all arms control agreements with members of OSCE presenting a good will for cooperation, transparency and openness among all OSCE countries.

3.2 Provide information on how your State pursues arms control, disarmament and confidence- and security-building measures with a view to enhancing security and stability in the OSCE area.

Disarmament, arms control, non-proliferation and confidence and security-building measures, are key elements in enhancing security and stability in the OSCE area and beyond. Therefore, Albania has continuously supported initiatives and fulfilled obligation on these fields.

Albania is party to the Chemical Weapons Convention (CWC) and the Biological Weapons Convention (BWC), supports and fully implements the two treaties.

Section II: Intra-State elements

1. National planning and decision-making process

1.1 What is the national planning and decision-making process in determining/approving military posture and defense expenditures in your State?

The basis for the defense planning system is laid down in national legislation. The key institutions of defense planning include the Parliament, the Government's Working and Coordination Body. The Ministry of Defence (MoD) plays a crucial role in overall management of Defence Planning and in co-ordination of measures ensuring the state's readiness for defense. Defence Planning Process includes political objectives, and National Security Policy.

Since the beginning of 2010, Ministry of Defense has assumed overall responsibility for conducting both the medium-term and yearly planning.

At the strategic level, the defense planning consists of long-term development plans and programs, which project the future target force, as well as anticipate the main requirements and priorities of the AAF development.

The Planning, Programming, Budgeting and Execution System is synchronized and in line with the national Integrated Planning System (IPS) of the government. This system will better serve the purpose of program coordination with the resources, and provides a sound decision-making of the government regarding the defense budget.

The budgeting process starts with the Council of Minister decision on budget limits. The Strategic Management Group in the Ministry of Defence sets the budget limits for the expenditure structures according to the Government's Annual Budget Law and their requests for extra funds. After the apposite discussions, the final draft is sent to the Ministry of Finance for approval. The Parliament, at the end of the parliamentarian section, approves the Government's Annual Budget Law. This law includes all the governments' institutions expenditures for the next year.

1.2 How does your State ensure that its military capabilities take into account the legitimate security concerns of other States as well as the need to contribute to international security and stability?

Albania is a law abiding member of the international community of nations and acts in accordance with international law.

Drawing and adoption of policy and planning documents that defines military capabilities of the Albanian Armed Forces, is being conducted in a transparent and open manner and all adopted documents are available to domestic and international public. In that way, all interested states have insight in the current situation and reasons for development of military capabilities.

Albania contributes to international security and stability by engaging in dialogue and cooperation with countries throughout the world, as well as by providing modest contributions in peacekeeping and humanitarian aid.

In the framework of regional security environment and beyond are approved a number of bilateral and/or multilateral agreements in order to contribute and increase the national and international security. Inter alias, emphasis bilateral Memorandum of Understanding (MOU) in defense fields with countries on the region and beyond. In addition, there are approved different agreements as follows:

Agreement between the Council of Ministers of the Republic of Albania and Supreme Headquarters Allied Power Europe (SHAPE) for Air Policing over the Republic of Albania's Airspace.

Note of Accession of the Council of Ministers of the Republic of Albania to participate in the Memorandum of Understand between the Government of the Republic of Poland and Supreme Headquarters Allied Power Europe (SHAPE) and Headquarters, Supreme Allied Commander Transformation (HQ SACT) regarding the provisions of Host Nation Support for the Execution of NATO Operations and Exercises.

Note of Accession of the Council of Ministers of the Republic of Albania to participate in the Memorandum of Understand between the Government of the Republic of Lithuania and Supreme Headquarters Allied Power Europe (SHAPE) and Headquarters, Supreme Allied Commander Transformation (HO SACT) regarding the provisions of Host Nation Support for the Execution of NATO Operations and Exercises.

Note of Accession of the Council of Ministers of the Republic of Albania to participate in the Memorandum of Understand between the Government of the Republic of Latvia and Supreme Headquarters Allied Power Europe (SHAPE) and Headquarters, Supreme Allied Commander Transformation (HQ SACT) regarding the provisions of Host Nation Support for the Execution of NATO Operations and Exercises.

Note of Accession in the Memorandum of Understanding between the Federal Ministry of Defense of the Federal of the Federal Republic of Germany and Supreme Headquarters Allied Power Europe (SHAPE) regarding the provisions of Host Nation Support for the Execution of NATO Operations/Exercises.

Note of Accession in the Memorandum of Understanding between the Ministry of Defense of the Slovak Republic and Supreme Headquarters Allied Power Europe (SHAPE) and Headquarters, Supreme Allied Commander Transformation regarding the provisions of Host Nation Support for the Execution of North Atlantic Treaty Operations/Exercises.

MOU between Ministries of Defence of Republic of Albania, Bosnia & Herzegovina, Croatia, Montenegro and Former Yugoslav Republic of Macedonia related to principals of contribution in Center for warning of situations and operations of rehabilitation in Camp Marmal M-e S, in the mission conducted by NATO "Resolute Support Mission", in Afghanistan.

MOU among Ministry of Defense of Republic of Albania, Bulgaria, Croatia, Estonia, Ministry of Foreign Affair of Republic of Islands, Latvia, Lithuania, Romania, Slovakia, Slovenia and Communication and Information Agency of NATO (NCIA) regarding to the cooperation on implementation of extending of the projects of Air Control and Commanding Systems (ACCS).

Technical Agreement between OSCE presence in Tirana and Albanian Ministry of Defence for the elimination of Chemical Stocks, 16 April, 2012.

MOU between OSCE Presence in Albania and Albanian Ministry of Defence for the elimination of Chemical Stocks, 10 November 2014.

In framework of the regional cooperation, since 2000, Republic of Albania has signed the agreement, with The Regional Arms Control Verification and Implementation Assistance Centre, (RACVIAC). Albania as a member country of this centre has been active and gives a very important role and contribution increasing of security and cooperation in region. With the new agreement, ratified in December 2011 by the member's countries this centre is called Centre for Security Cooperation.

The South-Eastern Europe Defense Ministerial initiative is launched in 1996 to boost cooperation among the countries of South-Eastern Europe. The main goal is to intensify political-military cooperation and security in the region. Albania is member of this initiative from the establishment.

2. Existing structures and processes

2.1 What are the constitutionally established procedures for ensuring democratic political control of military, paramilitary and internal security forces, intelligence services and the police?

- Military Forces

The constitution of Albania and other legal acts on civil-military relations provide a clear delineation of authority and a system of subordination and command and the control echelon of defense structures in times of peace and war. They provide for the civilian democratic control of the Armed Forces at the strategic level, whereas at the operational level the command and control is held by military authorities.

Democratic political control of the Albanian Armed Forces is constitutionally guaranteed through article 12, paragraph 2, which stipulates that the Armed Forces are subject to civilian control.

Article 167 of the constitution stipulates that Military personnel in active duty cannot be elected or appointed in other state offices and cannot participate in political parties or other political activities.

These constitutional principles are implemented through the provisions of the Law No. 64/2014 "On the authorities and powers of commanding and guidance of the Armed Forces of the Republic of Albania". Article 7 of the Law No. 64/2014, stipulates that authorities and powers of command authorities of the Armed Forces have the following hierarchical order: the Parliament (Assembly), the President of the Republic, the Council of Ministers, the Prime

Minister, the Minister of Defense, the Chief of General Staff of the Armed Forces, the General Staff of the Armed Forces, the Commanders of the Land, Navy and Air Forces, the Commanders of the supporting structures and the Commander of the Armed Forces in war time.

As this order shows, the Parliament is clearly vested with the oversight authority. It approves the National Security Strategy, the Defence Policy and Military Strategy, the Defence Laws and Budget and exerts parliamentary control over activities related with the armed forces. The oversight authority is exercised through the standing Security Committee. The competences of the Committee are foreseen in the internal regulations of the Parliament.

In line with the stipulations of the Constitution and above-mentioned law, the President of the Republic of Albania exercises the leadership of the Armed Forces through the Prime Minister and Minister of Defence in peacetime. In wartime the President of the Republic appoints and dismisses the Armed Forces Commander upon proposal by the Prime Minister.

The Prime Minister is responsible for the leadership, development, and the state of the Armed Forces in peacetime. The Council of Ministers is the highest executive body. It proposes laws on defense, executes the laws approved by the Parliament, defines the main approaches of national policy, and issues normative acts with temporary legislative power. The Council of Ministers manages the activity for the accomplishment of the tasks in the defense field, in accordance with the constitution, laws and decisions of the National Security Council.

The Minister of Defence is accountable before the Parliament, President and Prime Minister for the development and execution of defense policies. The Minister of Defence is a member of the Council of Ministers and the National Security Council. The Minister of Defence is responsible for the headship and control of the Armed Forces, the accomplishment of their mission, the management of the defense budget and the fulfillments of defense policy objectives.

- National Intelligence Service

Law no. 8391, dated 28.10.1998 "On national intelligence service" and other bylaws constitute the legal framework for the activities of Albania's Intelligence Service. Article 4 of this law stipulates that the National Intelligence Service operates under the authority of the Prime Minister. In order to control the activities of the Intelligence Service the Council of Ministers appoints a General Inspector who reports to the Prime Minister (article 12 of the, law).

Articles 7 and 8 of the law provide for the parliamentary control of the activities of Albania's Intelligence Service. The control is exercised by the relevant standing parliamentary committee, which can also oversee the use of fund allocated to the Intelligence Service. The director of the Intelligence Service reports to the Committee at least once a year. The Director of the Intelligence Service also reports to the Council of Ministers, as determined by the Prime Minister.

The Director of the National Intelligence Service is appointed by the President of the Republic upon proposal of the Prime Minister.

- The Albanian State Police

Civil and democratic control on the State Police is achieved through the Assembly of Albania, Ministry of Interior and the Ombudsman.

Civilian control of the State Police of the Ministry of Internal Affairs carried out under the following laws:

- Law no. 108/2014 "On the State Police"
- Law no. 70/2014 "On the Internal Affairs Service and Complaints at the Ministry of Interior".

Law no. 108/2014 "On the State Police", Article 7, termed "

1. Minister:

- a) develop and oversee the implementation of policy activity of the State Police, in order to guarantee public order and security;
- b) defines the strategic directions and objectives of the State Police;
- c) requires high performance ASP to achieve the objectives defined;
- d) requires the Director of the State Police report on the exercise of his duties and the State Police in accordance with the law and the Constitution, respecting the rights and freedoms:
- e) supervises the appeals process in the State Police and investigates complaints against the director of the State Police;
- f) prepare and publish an annual report on achieving the objectives of the State Police.
- 2. Minister oversees the management of the budget of the State Police, under the financial legislation.
- 3. The Minister does not interfere with the operational independence of the police service and is not included in its operational direction ".

In Article 8 foreseen "Relations of the minister with the State Police";

The Minister shall not be informed of:

- a) investigative actions, acts or data obtained therefrom;
- b) information concerning the identity, the process of cooperation, protection or location of witnesses, informants or collaborators of justice;
- c) data and information received by the persons referred to in the letter "b" of this article.

<u>In Article 2 of Law no. 70/2014</u> "On the Internal Affairs Service and Complaints at the Ministry of Internal Affairs", provided the scope of this law:

Service Affairs and Complaints exercises its activity to the following structures:

- a) the State Police;
- b) responsible for maintaining the structure of personalities high state and objects of special importance;
- c) the structure of the Fire Protection and Rescue

<u>In Article 4</u> is foreseen the mission Affairs Service and Complaints at the Ministry of Internal Affairs:

"Service mission is to guarantee the rule of law, protection of the legitimate interests of the state and the rights of citizens from unlawful acts and omissions of employees of structures, regardless of position and rank."

<u>In Article 5</u> is foreseen the scope of operations and the Internal Affairs Service and Complaints:

Scope of the Service are:

- a) prevention, detection and investigation of criminal offenses and violations of the law committed by employees while on duty structures and because of it;
- b) the inspection and handling complaints against employees for breach of duty structures, standards approved by normative acts, offenses and other violations of law;
- c) maintaining the integrity of employees structures;
- d) verification of employees' special property structures, to whom refer complaints and charges;
- e) analyzes, studies and generalized recommendations based on inspections and investigations on important aspects of the organization and functioning of structures and public expectations in terms of public safety. "

<u>In Article 8</u> is foreseen the Status of service: "1. The service is a public juridical person, the particular structure of the Interior Ministry, directly subordinated to the minister".

<u>In Article 13</u> is foreseen governing authorities Service Affairs and Complaints; "The minister is the highest authority governing the organization and operation of the Service.

The Minister determines the annual strategic objectives of the activity of the service, in accordance with state policies and public expectations.

The Minister, with the proposal of the Director of Service, shall submit to the Council of Ministers, Rules of Service and other legal acts in compliance with this law.

Minister ensures cooperation between these service agencies and other structures of the Ministry of Internal Affairs, law enforcement institutions and other institutions within the country, as well as similar institutions in other countries, based on mutual agreements.

Minister exercises these powers to the service activity:

- a) approves the structure and organization of the Service;
- b) defines the priorities of the activity of the Service, based on public policy and public expectations;
- c) issues orders and instructions for the implementation of laws and regulations in force for the organization and operation of the Service, protection of information and their sources from unauthorized disclosure, to review the cleanliness of the figure of employees of structures, for whom security clearance required to bear;
- d) is informed of all service activities, except for the identity of associates and records of criminal proceedings ".

- Civilian control of the State Police carried out by Parliament.

In Article 77 of the Constitution of the Republic of Albania, provided: "Assembly elects from its standing committees and may also appoint special committees".

In Article 80 of the Constitution of the Republic of Albania, provided: "Directors of state institutions, at the request of parliamentary committees, give explanations and information on various issues of their activity as the law allows".

One of the permanent commissions of the Parliament's Security Committee, which exercises oversight powers to investigate about important policy issue and administration, as follows:

- Holding hearings or inquiries;
- Call the police personnel, civil servants or experts to testify;
- Measures to question ministers and other representatives of the executive;
- Research documents from the executive;
- Control the transparency and efficiency of public spending;
- Request that the competent authorities to carry out checks;
- Review requests and complaints of police personnel and civilians in connection with the field of safety and security;
- Conducting visits and inspections at the premises of the State Police.

The activity of Albania's State Police is governed by Law no. 9749, dated 04.06.2007 "On State Police". The State Police is part of the Ministry of Interior and reports to the Minister of Interior (article 7 of the law). The budged of the State Police is approved by the Parliament. The Minister of Interior reports to the Parliament and to the Standing Security Committee in regular bases.

The Parliament of Albania has established the Internal Control Service (ICS) in the Ministry of Interior (law no. 10002, dated 6.10.2008) whose mission aims to guarantee to the community a responsible, democratic and transparent police service, in keeping with the relevant legislation in place. The activities performed by the ICS aim at preventing, unveiling and investigating criminal offences committed by police officers. The ICS also inspects the activities of the State Police against the implementation of the legislation in place.

The law places the ICS under the direct authority of the Minister of Interior, who is responsible for its activity.

- The Guard of the Republic of Albania

This is a structure with a special status in the Interior Ministry, which has the mission of preserving and protecting the high state authorities and their residences, as defined by law. The Guard of the Republic of Albania is under the jurisdiction of the Minister of the Interior Affairs.

Guard of the Republic of Albania preserves and protects:

- a) The President of the Republic, the Speaker of the Parliament, the Prime Minister, and their families.
- b) Foreign personalities who come into our country, in the rank of Albanian personalities of the letter "a" and "c".
- c) The Head of the Constitutional Court, the Deputy Speakers of the Parliament, members of the Council of Ministers, the President of the Supreme Court, the Attorney General, the Director of the State Intelligence Service, the Head of the Supreme State Audit, the Governor of the Bank of Albania, the Ombudsman, the Chairperson of the Central Election Commission, the Leader of the Largest Majority Party, the Leader of the Opposition Party and the Mayor of Tirana.
- d) Presidential residences, the Assembly and Council of Ministers, and other residences defined by the Council of Ministers.
- e) Dwellings of the personalities mentioned in the letters "a", "b" and "c" of this article.

The structure of the Guard of the Republic consists of the Headquarter, the Director and other subordinate structures. The structure, organization, chain of command and the staff of the Guard of the Republic of Albania are determined by the Council of Ministers upon the proposal of the Minister of Interior Affairs.

The Guard Commander has the full authority of command and control of all activities of the

Guard. He is accountable before the Minister of Interior Affairs for the training and readiness of the units of the Guard and for the fulfillment of its mission. The Commander of the Guard of the Republic shall be appointed by the Prime Minister, upon the proposal of the Minister of Interior Affairs. He is selected among senior officers of the Guard and State Police.

2.2 How is the fulfillment of these procedures ensured, and which constitutionally established authorities/institutions are responsible for exercising these procedures?

The principle of democratic control over the security forces is enshrined and stems from the Constitution of Albania and other Constitutional principles. It is implemented by specific laws for the Governments and Authorities of Commanding and Strategic Guidance of the Albanian Armed Forces, State Police, and Nationals Intelligence Service.

One of the main purposes of Law No. 64/2014 "On the authorities and powers of commanding and guidance of the Armed Forces of the Republic of Albania" is the application of the democratic principle of civilian command and control over the Armed Forces.

The democratic control over the security forces is exercised by:

a) The Parliament of Albania, through its mechanisms for approving the state budged and performing oversight functions, in particular by the standing Security Committee. According to article 80, paragraph 1 of the Albanian Constitution, the democratic control is exercised over the Ministers through hearing sessions or questions times. In its activities the committee is entitled to draw upon independent and professional expertise. In order to investigate of particular national and public interest the Parliament can also set up ad-hoc inquiry committees.

The constitution defines the main rules concerning functioning and organization of the Parliament. The parliament regulation derives from this provision and is approved by the majority of the members. The Parliament, as the high legislative institution, exercise control over the executive and the constitutional institutions, to verify implementation of the legal framework adopted.

The Constitutional Provisions and the Regulation foresee the instruments to exercise this control. These instruments are as follow:

- 1. Parliamentary motions. Art. 80, point 1 of the Constitution, Art. 96-97 of the regulation.
- 2. Answering to questions in a written/oral/urgent way or in front to a commission. Art. 80, point 1 of the Constitution, Art. 91, 93-95 of the regulation.
- 3. Debate motions (Art. 98 reg.)
- 4. Trust motions (Art. 104 of the Constitution, Art. 100 reg.)
- 5. No-confidence motion (Art. 105 of the Constitution, Art. 101 reg.)
- 6. Reports (Art. 103 reg.)
- 7. Petitions (Art. 104 reg.)

The Parliament of Albania is the highest authority of the strategic command and control of the Armed forces (Art. 8, law nr. 64/2014)

b) The President of the Republic, according to the Constitutions and actual law, is the Commander in Chief of the Albanian Armed Forces. In peacetime it exercises the

- command of the Armed forces through the Prime Minister and the Minister of Defence (art. 9/2, law nr. 64/2014)
- c) The Council of Ministers on cases provided by the constitution and the law nr. 64/2014
- d) The Prime Minister cases provided by the constitution and the law nr. 64/2014
- e) The Ministers of Defense and Interior, who, in their respective areas of activity, are accountable for and control of the armed forces and the police forces. According to article 80 of the Constitution and article 19 of the Parliament's internal regulations, the Ministers report to the Security Committee and to the plenary session of the Parliament.
- f) The Minister of Defence is a person who leads the Armed Forces Activity in fulfilling the constitutional mission within the main direction to the state policy.
- g) Chief of the General Staff, as leader of the Armed Forces activity, responds to the President of the Republic, Prime Minister and Minister of Defence. It is the highest military authority in rank and at the strategic command hierarchy of the Armed Forces of the Republic of Albania.

<u>Legal Control of the Defence Intelligence and Security Agency.</u>

This control is exercised through parliamentary oversight, administrative/financial/legal control in accordance with the Constitution of the Republic of Albania and law 65/2014 for the Defence Intelligence and Security Agency.

The authorities that exercise this control are as follow:

- The Parliament, which exercises parliamentary oversight of the activities of the Defence Intelligence and Security Agency.
- Prime Minister, who exercises control of the Defense Intelligence and Security Agency activities, as well as financial control of specific operational budget.
- Minister of Defense, who exercises directly administrative, financial, and operational control in the Defense Intelligence and Security Agency activities.
- Director of the Defense Intelligence and Security Agency, or authorized personnel.

2.3 What are the roles and missions of military, paramilitary and security forces, and how does your State control that such forces act solely within the constitutional framework?

- Military forces

According to the Constitution of Republic of Albania, the mission of Armed Forces is:

- Protect the territorial integrity of the country.
- Protect the constitutional order as it is determined by law.
- Always be present in areas incurring menace.
- Assist the population in case of natural and industrial disasters and warn the risks of military and non military nature.
- Participate in international operations in composition of multinational forces.
- Prevention and management of environmental damage from military activities

- State Police

State Police operates under Law no. 108/2014 "On the State Police", a law which defines the mission, organization, functioning, duties, rights and status of the State Police in the Republic

of Albania, as well as regulating the activities, labor relations, guaranteeing career, welfare and continuity in office of the police officers.

In Article 2 of this law is provided the mission of the State Police, "State Police mission is to maintain order and public security, protection of high state personalities and objects of particular importance, ensuring the rule of law, in accordance with Constitution and international acts, while respecting the human rights and freedoms".

According to the Constitution the Parliament, the President and the Council of the Ministers have responsibilities and rights, in regards to the national security and defense issues.

The Parliament of the Republic of Albania is the only organism that approves laws in the security and defense field of the country. The Parliament has constitutional competencies to declare the war, emergency state, partial and general mobilization, ratification of the agreements and the scrutiny, management and approval of defense budget.

Parliamentary democratic control is exercised through legal means, directly from the Parliament and respective commissions. In this context, its activity is focused in laws, defense budget and policies execution in order to ensure that the Armed Forces act only within the constitutional framework. Members of the parliament can draw attention to acts of the Armed Forces, which in their view may be contrary to the Constitution.

The President of Republic has the constitutional authority as the Head of the State, who represents the unity of the nation. He is the Head of the National Security Council and the highest authority of the Albanian Armed Forces. All senior officers of the Albanian Armed Forces are appointed by the President who, at any time and as defined by Law, can also dismiss them. In wartime, the President of the Republic is Commander-in-Chief of the Armed Forces and he appoints and dismisses the Commander of the Armed Forces, based on the proposal of the Prime Minister.

The National Security Council is an advisory organ to the President and exercises its activity based on the Constitution, laws and obligations derived by international agreements ratified by the Parliament. This Council advises the President of the Republic for the issues concerning security and defense of the country.

The Council of Ministers is the highest organ of the executive power. It is responsible for the implementation of the National Security Strategy and the state and developments of security instruments and national resources in accordance with the Constitution and laws.

3. Procedures related to different forces personnel

3.1 What kind of procedures for recruitment and call-up of personnel for service in your military, paramilitary and internal security forces does your State have?

Military forces

The AAF consists of military and civilian personnel employed in its structures. As of 1 January 2010 Albania has a volunteer military service system. Policies and practices for

further career development of military personnel are based on their experiences, training and years in services.

The system of management and development of the human resources has at the centre of gravity the training and education of the officers, NCOs, professional soldiers, and civilian personnel with the necessary experience and skills to serve in and out of the country. This system includes the management of the entire life cycle of the personnel, from the identification of the needs, recruitment, education and training of the personnel in service, the economic and financial support, promotion and career development, until their final retirement and support and integration into the civilian society.

The policies and recruiting strategies based on modern marketing which promotes the Albanian Armed Forces (AAF) values, benefits and social guaranties of the personnel and their families, aim at the qualitative growth of the AAF.

The recruitment to become a professional soldier in the AAF offer equal chances, with no racial, ethnicity, color, gender, religion belief discrimination, as well as payment, profits, and other compensations according to specific military services.

Acceptance Criteria:

Nationality: Albanian; Age: 18-30 years old; Education: High School /University degree; Length: Males over 170 cm, Females over 165 cm; Health certificate: By the Military Hospital in Tirana (in good health); Free of law penalties: not being under investigation; To have the right to exercise his/her profession/public administration activity by law; To pass successfully the physical and intelligence tests.

AAF requires the recruited personnel to have the highest qualities for serving in the Armed Forces, as being a complete professional volunteer Force. AF will recruit professional soldiers with necessary knowledge in accordance with work requirements, specific specialties, by improving the procedures and policies of admission, giving priority to individuals with high education, unique abilities and qualities for specific branches.

Professional soldier recruitment will be carried out in a concentrated way to complete the AF structures.

The selection of the most suitable participants will be performed based on medical, physical and intelligence abilities, according to defined standards and procedures. The General Staff review the tests on November, every year, and adapt them in accordance with the Forces' needs for personnel. Since 2012, the categories of the intelligence test will be prepared in order to test the supplementary individual abilities according to the requirements of each branch.

In the Recruitment Center of district, the candidate submits the necessary documentation, fills in the application Form no. 1 and the Questionnaire for a professional soldier in the Armed Forces of the Republic of Albania. After a pre-check verification, the Recruitment Centre of districts send all documentations of the candidates to the Personnel Recruitment Centre. If there are no problems in the application, the Recruitment Centre calls you for the presentation date to continue with the intelligent and physical tests.

Physical and intelligent tests are organized in the Personnel Recruitment Centre. The applicants are recruited as professional soldiers after passing the verification and test process.

In the Personnel Recruitment Centre the candidate will take the intelligent and physical test and will also be interviewed.

Selection of the candidates

Interview is part of the selection procedures, where the Commission evaluates the motivation, experience and inner communication abilities of the candidate. The Personnel Recruitment Centre is led by the motto "Recruiting the best individuals for a professional Force", and candidates are qualified according to the record. After the winners are announced and appointed in a unit of the AF, they will take part in the Basic Training.

The training for the new recruits starts with the individual basic training. During this period the recruits get necessary knowledge's on military regulation, national laws, military equipments and weapons, physical training, military tactics and practicing shooting infantry weapons.

At the end of this 12 weeks training, all the recruits have to pass the tests and get promoted to professional soldier, following the NCO military carrier.

Law No.152/2013, dated 20.05.2013, "On the status of civil servants". Procedures of employment of civil servants in the Ministry of Defense are define according to the above law and bus-laws and executed based on the principles of competition, transparence, impartiality and criteria's of laws under observation of Public Administration Department.

Paramilitary forces

Albania has no paramilitary forces.

3.2 What kind of exemptions or alternatives to military service does your State have?

In the Republic of Albania there is no compulsory military service. Thus, as e consequence, there is no alternative military service.

Unfulfilling the criteria's mention in (point 3.1) comports exemption/exclusion from military services.

3.3 What are the legal and administrative procedures to protect the rights of all forces personnel as well as conscripts?

Principles on the legal status of military personnel

The rights and limitations of the freedom of military personnel in Albania are set by law. According to the Law on "Military Status", the military personnel serving in Albanian Armed Forces enjoy special status and privileges stemming from the nature of their service to the country.

Military personnel enjoys the right to be informed, protection of personality, free medical care, health insurance in case of illness or injury while performing their duty, the right to vote, the right to exercise religion. Military Forces are neutral related to the political parties.

Because of they have a particular duty in service of homeland and society, the military personnel cannot be a member of any political party, cannot participate in political meetings and is forbidden to make political propaganda in interest of any political party.

Active military personnel enjoy the following rights:

- a) his/her job in the Armed Forces is guaranteed in accordance with applicable law;
- b) to get promotion in rank and in his/her responsibilities (career), according to legal acts:
- c) to be protected by the state's laws when performs the military duties;
- d) to train, to qualify and to follow studies in military educational institutions or civilian inside and/or abroad the country, only when receives permission (by order) according to the legislation and in accordance with the profession;
- e) exercise his/her right of belief and religious event, outside of the unit or military institution without military uniform;
- f) to serve inside and outside the territory of the Republic of Albania in various international operations, with the permission of the appropriate authority;
- g) to wear civilian clothes outside working hours of service, or when it's required by type of duties;
- h) to be organized into associations, which are not political or syndicate

Military Personnel of the Armed Forces has the following duties and responsibilities:

- a) to recognize, respect, implement and act in comply with the Constitution and legislation in force;
- b) to keep up the honor and dignity of the military;
- c) to be ready and serve where the interests of the Armed Forces demand;
- d) to be prepared as military, disciplined, for each sacrifice for the defense of the homeland;
- e) to provide for the general public, stakeholders and public institutions required information, except when the information is classified, in accordance with laws;
- f) to respect exactly working time schedule and use it efficiently
- g) to enhance the professional skills and participate in training activities.
- h) do not accept any material benefit on the duties, except the salary and benefits defined by law and other legal acts;
- i) to hold his/her responsibility for the legal actions during the duty;
- i) to follow the rules of ethics.

Article 19 – "Detention because of duty or service"

Military personnel are prohibited to:

- a) be a member of political parties, organizations or associations of a political nature, as well as participate in political activities organized by them;
- b) to organize or participate in strikes; protests and demonstrations
- c) use state's property for personal benefits;
- d) Going abroad without order by authorities defined by law

Summary list of decrees relating to legal assistance of military personnel

Law no. 173/2014 "The discipline in the Armed Forces of Republic of Albania" defines norms and rules for military personnel, violations, penalties and responsible law enforcement authorities.

- Against verdicts on promotion

Law no. 59/2014 on Military Career in the Armed Forces of the Republic of the Albania;

- Art. 28 define the grievance procedures on the Carrier Commission evaluation.
- Art. 30 define the grievance procedures for retiring/reserve procedures.

Legal assistance is given to military personnel in cases as follow:

- Verdicts on exception / exemption from the armed forces

Law no. 59/2014, on Military Career in the Armed Forces of the Republic of the Albania Means and proceedings for dealing with military penal cases are based on Military Penal Code (Law no. 80003, dated 28.09.1995 and no. 8919, dated 04.07.2002).

The Ombudsman role

Ombudsman is a constitutional institution, which protects the rights, freedoms and lawful interests of individuals from unlawful acts or omissions of irregular public administration bodies. The Ombudsman submits an annual report to Parliament.

The Ombudsman has the right to make recommendations and propose actions when violations of human rights and freedoms by the public administration. Office of the Ombudsman is divided into five specialized sections at the top of the Commissioner. One specialized sections is the section for police, secret service, prisons, armed forces and judiciary.

Ombudsman contributes to the preparation of reports of the Albanian state to international organizations in the implementation of conventions ratified by Albania, of human rights and freedoms in the Republic of Albania and can submit parallel reports.

Ombudsman promotes inclusion of human rights and freedoms in the curriculum, as well as the implementation from the educational institutions.

The right to make proposals and appeals (article 15 of the Law no. 9210, dated 23.3.2004 on "On the military status of the Albanian Armed Forces personnel).

Active military personnel have the right to make, as appropriate, proposals, requests or complaints about illegal actions of superiors, when their rights are affected.

The proposals, requests or complaints are directed to the competent authorities, in a written way, according to the legislation. The military personnel is not subject to any disciplinary sanction because of the complaint or request made.

- 4. Implementation of other political norms, principles, decisions and international humanitarian law.
- 4.1 How does your State ensure that International Humanitarian Law and Law of War are made widely available, e.g., through military training programmes and regulations?

Albanian Armed Forces are commanded, manned, trained and equipped in ways that are consistent with the provisions of International Humanitarian Law, obligations and commitments related to the use of Armed Forces in armed conflict, including the Hague Conventions of 1907 and 1954, the Geneva Conventions of 1949, the Additional Protocols of 1977, as well as the 1980 Convention on the Use of Certain Conventional Weapons. Such provisions are included in different field manuals and regulations, published and distributed to all officers and NCOs.

The military education system in all levels of Armed Forces use the manual "Law of the Armed Conflict", approved by order of General Chief of Staff, no. 747, dated 22.09.2009.

Ministry of Defense in cooperation with International Red Cross and Red Crescent Committees have prepared published and delivered a training folder for the instructors. The military personnel before deployment on the mission get knowledge and train how the law on Armed Conflict is implemented. For this purpose, a brochure is prepared and published/printed; it is used as training and learning material titled "Essential Bases of Armed Conflict Law", approved by order of General Chief of Staff, no. 226, dated 30.08.2001.

The Military Education System includes the curricula in all levels which contain topics regarding International Humanitarian Law (IHL) and Law of War (LoW). The number of hours of training devoted to this subject for military personnel is up to 400 training hours, spread out in official training courses.

Law no. 7864, dated 09.29.1994 "Albanian Red Cross".

Law no. 7865, dated 29.09.1994, "For protection of the emblem and name of the Red Cross".

Albanian Armed Forces personnel who are sent abroad for mission, besides usual tests they have a special examination for IHL and LoW. After that, military personnel for the mission is examined and certified for the acknowledgement of the above mentioned laws.

4.2 What has been done to ensure that Armed Forces personnel are aware of being individually accountable under national and international law for their actions?

Albanian armed forces personnel who are vested with command authority are trained to exercise it in accordance with relevant national as well as international law and are made aware that they can be held individually accountable under those laws for the unlawful exercise of such authority and that orders contrary to national and international law must not be given.

All armed forces personnel is trained and instructed in international humanitarian law, rules of engagements, conventions and commitments governing armed conflict and they are aware for their accountability under national and international law for their actions.

Military training system in the Republic of Albania consists of institutional and functional courses for individual and collective training for units or pre-deployment training of particular units. Provisions of International Humanitarian Law are included in the current general training programs.

In the Republic of Albania, military academic education is centralized within the Training & Doctrine Command (TRADOC). This institution provides appropriate education, including

mandatory lectures of International Humanitarian Law to all commanders and members of their staffs. There is a significant amount of these lectures both in Bachelor's curriculum and Master's curriculum.

The International Humanitarian Law in applied through National Law, no. 8003, dated 30.10.1995 "Military Penal Code" - Chapter VIII "Felony in Military Operations"

4.3 How does your State ensure that Armed Forces are not used to limit the peaceful and lawful exercise of human and civil rights by persons as individuals or as representatives of groups nor to deprive them of national, religious, cultural, linguistic or ethnic identity?

Missions and tasks of the Albania Armed Forces are driven based on main documents according to the tasks in and outside of Albania.

According to strict limitation set forth in these documents armed forces cannot perform other tasks. The activities of armed forces are under control of constitutional authorities or authorities to whom such control is entrusted to, by a special article of the National Constitution, thus in case of transgression of competences it is upon civilian authorities to act accordingly.

The constitution of Republic of Albania is the main document ensuring that Armed Forces are not used to limit the peaceful and lawful exercise of human and civil rights by persons as individuals or representatives of groups to deprive them of national, religious, cultural, linguistic or ethnic identity. In this document are stated all procedures for usage of AF and punishment for those that violet them.

Commissioner for protection from discrimination is an institute which exercises of human and civil right by persons. The parliament has approved: - <u>Law no. 10221, dated 04.02.2010</u> "On protection from discrimination"; - <u>Law no. 9970, dated 24.07.2008</u> "On gender equality on society".

Likewise, the free media contribute as an additional element to prevent armed forces actions which might serve to limit the exercise of human and political rights. Human Rights are also part of training programs and curricula's in different courses. In case of this action is on support of the police forces, armed forces units are used for guarding and protection duties of critical infrastructure and constitutional order.

4.4 What has been done to provide for the individual service member's exercise of his or her civil rights and how does your State ensure that the country's Armed Forces are politically neutral?

Human rights of soldiers are embodied in Human Rights Charter no. 2/1993 Coll., (which is applicable for every person under the jurisdiction of the Republic of Albania and is part of its constitutional law). Limits of basic rights and freedoms may be imposed only by enacted law and based on conditions set forth in the Human Rights Charter. As military personnel represents a special group whose rights may be limited to fulfilling their tasks.

The Republic of Albania has institutionalized civilian democratic control over armed forces in its Constitution, and has built by law a command and control system by high civilian authorities at the strategic level, whereas at the operational and tactical levels, command and control is by high military authorities.

According to Article 12 of the Constitution of the Republic of Albania, Armed Forces are politically neutral.

Members of the armed forces are prohibited by Law from being members of any political party and make propaganda in the interests of any political party.

Law no.9210, dated 23.3.2004, "Military Status" (article 15 of this law defines the rights for proposal and grievances of military personnel in Armed Forces.

(Referred in point 3.3 subtitles "The ombudsman role")

4.5 How does your State ensure that its defense policy and doctrine are consistent with international law?

Albanian Defence Policy and Doctrine are consistent with international law related to the use of armed forces, including in armed conflict and the relevant commitments of the Code of Conduct on Politico-Military Aspects of Security. According to the Albanian Constitution any international obligation must be embodied into Albanian legislation.

The Albanian Armed Forces respect the Additional Protocol to the Geneva Conventions of August 1949, and relating to the Protection of Victims of International Armed Conflicts (Protocol I) of June 1977 and the obligations under Article 82. Provisions of the international law which are included in the doctrines and different field manuals derive from these doctrines.

4.6 What has been done to integrate women into conflict prevention, crisis management and post conflict rehabilitation through its activities?

I: Prevention

1. Measures to increase armed forces personnel understanding of the special needs and contributions of women in conflict.

Inclusion of specific matters related to the protection of women's rights in the basic education of armed forces.

Gender issues, protection of women's rights and gender discrimination, sexual violence issues are included in the programs of education for the military personnel in Armed Forces.

Albanian Military troops participating in international peace support operations, conduct a specific training before deployment. Part of this specific training are well acquainted with the costumes, traditions and culture of the country where they will serve and the issues related to the protection of the rights of girls and women in the conflict areas.

Availability plans to address and gather information about culture and costumes from local women populations in areas at risk of conflicts.

The inclusion of systematic analysis for gender in conflict areas includes genderdesegregation, socio-economic indicators and power over resources and decision making process.

Information collected in areas where Albanian troops are deployed, which include gender issues as well, is analyzed and processed through the chain of command of international HQ.

During 2015, up to 31 military personnel of AAF and State Police Office participated in Utility of Gender and Building Integrity in PSO Orientation Course, designed and developed by Peace Support Operations Training Centre (PSOTC). The main aim of this training was to increase awareness and provide a conceptual understanding of gender issues in the security sector. It had a particular focus on Peace Support Operations (PSO) and how successful missions need to communicate with women in the society they are tasked to protect and thus how it is essential that female soldiers, police officers, and civilian staff are involved in the planning and conduct of operations.

2. Measures to address the violation of the rights of women and girls, in line with international standards.

The basic document that protects fundamental individual rights and freedom in the Republic of Albania (RA) is the Constitution. It affirms the principle of equality as a fundamental principle and pre-condition for the functioning of state organs and does not allow any form of discrimination against the individual (Constitution, Article 18, paragraph 1 and 2). Another important document is the "Law on Gender Equality Society", no. 9970, dated 24.07.2008, based on the principle of equality and non-discrimination and other principles enshrined in the Constitution, the Convention on the Elimination of All Forms of Discrimination against Women, as well as all other international acts ratified by the Albanian Parliament (Article 3, paragraph 1).

"National Strategy for Gender Equality and Domestic Violence 2011-2015" aims to improve the position of women in Albanian society and to ensure sustainable development in the gender. Albania is in process of drafting the new National Strategy for Gender Equality 2016-2020 which will address the full spectrum of gender issues, policies and strategies.

The program of new government for 2013-2017 has expressed the commitments for all public institutions in the fight against women violence, reinforcement of justice system for prevention and support of victims of violence. In terms of the AAF, the main policy is to increase women's participation in peacekeeping operations, conflict prevention and resolution. Application of positive discrimination in this area seeks to increase the number of women and girls in the peacekeeping missions. These measures are accompanied with training of staff of peacekeeping missions on gender equality and awareness rising for reduction of gender stereotyping in the peacekeeping mission.

In the framework of National Strategy for Development and Integration 2015-2020, we worked closely with the representative of UN Women to mainstream gender perspective in monitoring indicators of this strategy. In the middle of September we were part of the meeting organized by the Prime Minister Office and UN Women on discussing and finalizing the list of indicators.

The National Council on Gender Equality was established by the Prime Minister, Regulation No. 3, dated 8.1.2009, which is an advisory body for gender issues. This Council is chaired

by the Minister in charge of gender equality, and is composed of 9 (nine) deputy Ministers and three members representing civil society.

Regarding the armed forces, there are no serious gaps that will require immediate action in respect of the legal rights of women who serve in the Armed Forces.

The law "On Military Discipline" which classifies sexual harassment committed by military personnel during and after working hour in the category of serious disciplinary violation is under implementation. The purpose of this law is to prohibit sexual harassment in order to defend human dignity, freedom and privacy and in order to promote equality between the sexes. During 2015, there are not reported cases on sexual harassment committed by military personnel. This issue is monitored closely in order to avoid the gender abuses during the military service.

II: Participation

1. <u>Measures to increase the number of women in general and in decision-making positions in</u> the armed forces and the Ministry of Defence.

Based on the new strategy on "Human Resource Management Strategy in the Armed Forces, 2015-2019", approved in 2015, the professional military personnel that are women in the Armed Forces should be up to 15% of the general number and for every structure one by one, in the function of the mission and tasks according to the required operational levels.

The percentage of military women serving in the Armed Forces of the Republic of Albania at the end of 2015 has reached 13.6 % of the total number of military personnel.

The above indicators shows that female percentage has been increased compared to previous year, due to the intensive recruitment campaign undertaken by the Minister of Defense. The AAF has introduced several measures in support of recruitment process and enhancement of women participation in AAF in order to attract educated females from Albanian Colleges and Universities. Current activities targeting potential female applicants range from local initiatives like spread of leaflets in universities and recruiting open days seminars in MOD, and visits on local colleges of women in senior leadership position like Minister of Defense and other senior military position. They share their experience and provide the young female with important career information about AAF and highlight the significant contribution made by woman in AAF and abroad and increase awareness of career opportunities for women and men in AAF.

Also, in order to attract greater number of qualified applicants from Albanian workforce the Personnel Recruitment Centre has undertaken the initiative for promotion of women and man participation in military throughout National Employment Office. The recruitment campaign also was spread on national/local media and official website of Albanian Armed Forces.

The number of female personnel who have advanced in their ranks and career is 102 or 21.08%, respectively Naval Force (12), the Land Force (36), Air Force (15), others (39).

Enhancement of women personnel presentation in decision-making positions for 2015, in position of Head of Directorates in Ministry of Defense and General Staff are respectively 6

civilian female and 1 female Colonel. Albanian Armed Forces has one female in head position like military representative in our diplomatic mission as well as 10 other female representatives (5 military personnel and 5 civilian) in our military representative's office.

In the Advanced Officer Course, one of the most important institutional courses in Albanian Military Education System for continuing a career in the Armed Forces, a lieutenant (female) was declared the best trainees in the infantry branch.

In Military Police adheres one of the elite athletes of the world Ms. Luiza Gega, who in 2015 has achieved a number of national and international triumphs. Ms. Gega has set up the name of Albania in various European competitions and world.

In the international exercise "Platinum Lion 15-03", conducted in Bulgaria took part three female, as personnel of Military Police, which displayed highest skills and dedication in carrying out their duties, alongside their male colleagues. One female was certified in the Course "Certification of the Military Police for the mission abroad".

13 female part of the Military Police personnel participated at the exercise "Operational Capabilities testing" at the Biza training area.

The Albanian Armed Forces are working to obtain expertise in the field of gender equality and to strengthen our capacity in implementing the UNSCR 1325.

2. Measures to increase the number of women in peacekeeping forces.

There are no regulations in Albanian Army Forces limiting the deployment of women. Deployment is tasked through the chain of command to subordinate organization. For additional positions, or capabilities not provided by an already- formed unit, personnel are selected for deployment positions based on their rank, occupation, and any required special skills sets, with no consideration being a man or a woman. During 2015, Albania Armed Forces had one military female as part of Resolute Support Mission in Afghanistan who was in charge for training afghan military females.

III: Protection

1. Increased access to justice for women whose rights are violated.

Number and percentage of reported cases of exploitation and abuse allegedly perpetrated by uniformed peacekeepers that are referred, investigated and acted upon.

For the reporting period, there was no case involving Albanian peacekeepers.

IV: Other information.

Under the project "Strengthening of Regional Cooperation on Gender Mainstreaming in Security Sector Reform in the Western Balkans" UNDP/SEESAC provides support for: 1) Institutionalization of MOD Gender Focal Points, 2) Reform of the Human Resource Policy to Improve the Recruitment and Retention of Women and 3) Gender Sensitization Program for the Armed Forces. In this framework, 8 representatives from the Albanian Ministry of Defense and Armed Forces have organized a study visit at the MoD and AF of Montenegro (ME) and the Former Yugoslav Republic of Macedonia (FYROM) from 8 to 10 December

2015, to learn more about the results of the Gender Equality in the Military Project. The main purpose of this study visit was information sharing and exchange of experience for better regional cooperation on gender mainstreaming.

Another important activity under this SEESAC support, was training of the representative of MoD in the "Gender Training of Trainers Course" in the Nordic Center for Gender in Military Operations, Sweden (Department Head of all gender curricula on Gender). The aim of this training was to enable trainers to successfully plan, conduct and evaluate education, training and exercises within own functional area with an integrated gender perspective.

The identical course organized by Centre for Security Cooperation (RACVIAC) last year was attended by two representative of the Albanian Ministry of Defence.

In the framework of military cooperation with the countries of the Adriatic Charter (A5), Albania welcomed the Conference for Senior NCOs themed: "Gender Equality, integration and the future of women in the Armed Forces" with the participation of representatives of Bosnia and Herzegovina, Montenegro, Croatia and Macedonia.

In November 2015, with the initiative of the Minister of Defence, the center for the rehabilitation of military's children suffering from autism spectrum was established. The center's goal is to improve the quality of life of children with autism and to facilitate their families in dealing with this issue. Services offered in this center are free.

Section III: Public access and contact information

1. Public access

1.1 How is the public informed about the provisions of the Code of Conduct?

Experts from various state institutions (MOD, MFA, MOI, Parliament, etc.) in charge of implementation of the different sections of the Code of Conduct participate on a regular basis in international and regional events dedicated to the implementation and exchange of information on this document. However, further efforts are needed to improve public awareness on the aims of the Code and its provisions.

Public have the possibility to be informed about the parliamentary debates regarding military issues. Recruitment and Personnel center is organizing meetings and briefings at high schools and universities based on a detailed plan. The public can participate in military events, opendoor days, organized by military structures. Public access to information is available on the official web sites of the Ministry of Defense and General Staff.

1.2 What additional information related to the Code of Conduct, e.g., replies to the Questionnaire on the Code of Conduct, is made publicly available in your State?

As to now, Albania's official replies to the questionnaire of the Code of Conduct have never been made public. However, the Ministry of Foreign Affairs is considering the possibility to post the current questionnaire on the official website of the Ministry of Foreign Affairs or Ministry of Defense, in a special link, dedicated to Albania's relations with the OSCE.

1.3 How does your State ensure public access to information related to your State's armed forces?

Public access to the information related to the Armed Forces is becoming easier. The Law on the Transparency and Access to Public Information that ensures the rules of public access to the information regarding the state administration in general includes, as well as, the Albanian Armed Forces.

The Ministry of Defense provides transparency and public access to information related to the Armed Forces. The information centre is operational in the Ministry of Defense. Albanian Parliament approves the defense expenditures and exercises constrains and limitations in military expenditures. All documents of strategic level such as: the National Security Strategy, the Defense Policy, the National Military Strategy, the Long Term Development Plan, etc. are open to the public opinion.

Ministry of Defense offers a wide spectrum of information from military magazine which is published monthly and military newspaper which is weekly publication (electronically).
