

### **Overview - EMEA**






- Vision

- Work as a parallel organization with TAPA US/ APAC.




# **Current Membership**

## Freight Security Standards





#### Freight Security Standards (FSR)

- Introduced 2001, revised 2005, 2007 & 2009
- Worldwide minimum standards for freight forwarders' facilities handling high tech / high value products.
- now covers 650 + facilities worldwide
- Levels A,B,C decided in partnership between shippers and logistics service providers
- A and B certification from independent audit bodies
- Accepted by US Customs CTPAT program as BKM (Best Known Method)
- Recognized in some countries by AEO (Authorized Economic Operator) auditor bodies
- 2010 will see work of the Change Control Board work towards the 2011 FSR

### TSR and TACSS





#### • Truck Security Requirements

- Rolled out on a global basis in 2006 & revised 2008
- Level 1,2,3 (1 is highest level)
- Self assessment process- required level agreed between buyer and supplier
- 2010 will see a pilot scheme looking at certification of TSR

#### TAPA Air Cargo Security Standards (TACSS)

- Mid term project ongoing
- Evaluation / discussion with airport industries ongoing
- 2010 will see further consultation and development of the standards

## Briefing note to accompany the TAPA EMEA presentation on the Wednesday $26^{\rm th}$ May 2010

Plenary Session VI - "Specific transport security aspects and the role of the OSCE"

#### Background

TAPA was founded in the United States of America in1997, when 37 companies, all victims of cargo/freight crime, came together to discuss and find solutions concerning the causes of this crime. In 1999 TAPA Asia and TAPA EMEA (Europe Middle East and Africa) were formed, creating a global forum whose vision is:

'to affect the reduction of losses in the manufacture, transportation and distribution of high value and theft of attractive products, the organization will also provide a forum for other areas of concern in the loss prevention area.

TAPA Worldwide now boasts over 600 members throughout the world, and although governed by three regional autonomous entities, TAPA Americas, TAPA ASIA and TAPA EMEA, they work together through their World Wide Council to fulfil the objectives of its members as laid down in its mission statement

To protect the assets of the high tech industry in the supply chain by:

Exchanging information on a global basis

Co-operating on preventive security

Increasing support from the logistics and freight industry and where appropriate, from law enforcement and governments

During its earlier years, to assist its members and gain international recognition, TAPA introduced its **Freight Security Standards** (**FSR**), a worldwide minimum standards for freight forwarders' facilities handling of high tech / high value products. To date over 650 facilities worldwide have gained either an A or B certification, with the sites being assessed and approved by independent audit bodies.

In recent years the **FSR** has been accepted by US Customs CTPAT program as BKM (Best Known Method) and recognized in some countries by AEO (Authorized Economic Operator) auditor bodies.

Some years later, TAPA introduced its **Truck Security Requirements** (**TSR**) to introduce further security measures in the supply chain. TSR, originally a non certificated scheme, is currently being adapted to enable participants to become a certificated partner, in recognition of their efforts to increase security in the supply chain and reduce loses. Currently TAPA is working on **TAPA Air Cargo Security Standards** (**TACSS**
