#### **GENERAL INFORMATION**

The OSCE Mission to Georgia (hereinafter referred to as the "OSCE") invites Bids (hereinafter referred to as "Bids") from eligible, qualified and capable companies for the **supply and delivery of Apple Rootstocks and Scion Bud Sticks** in accordance with the Technical Specification and Requirement sheet (Section III) for the Economic Rehabilitation Programme (hereinafter referred to as the "ERP").

#### It is intended to purchase for the farmers Apple Rootstocks and Scion Bud Sticks:

- Lot 1. Apple Rootstocks M 9 Dwarf Rootstocks
- Lot 2. Apple Rootstocks M 106 and/or M 7 Semi-Dwarf Rootstocks
- Lot 3. Scion Bud Sticks, 11 different types. Offered quantity should be 60% "red" colour and 40% "yellow" colour.
- Lot 4. Paraffin Wax
- Lot 5. Grafting Tape

### Partial bid by lots will be accepted. But, please, note that the quantity within the lots should be as required in the specification in section III.
