**10:30 – 11:45**    **PLENARY 1: Safety of journalists: The costs of reporting the facts**

Journalists in the South East Europe region are increasingly exposed to safety risks, ranging from physical and online violence to digital surveillance and legal harassment, particularly when investigating and reporting on sensitive public interest issues. Meanwhile, women journalists continue to face even greater risks due the intersectionality of the attacks. This panel will feature first-hand testimonies highlighting the gendered dimensions of journalist safety, along with the legal harassment and other tactics used to silence investigative journalists and discredit their work. The discussion will also address the physical, psychological, and financial toll these threats take on journalists. Panellists will review existing safety measures, including legal protections and other mechanisms, and propose solutions to close the gap in current safeguards to protect journalists' safety.
