# Combating Trafficking in Human Beings for the Purpose of Forced Criminality

Vienna, Hofburg (Neuer Saal)

11-12 April 2016

Efforts to prevent and combat trafficking in human beings often entail complex ethical and legal dilemmas. Government authorities and civil society organizations increasingly need to have clear guidelines on the application of national legislation.

The 16<sup>th</sup> OSCE *Alliance against Trafficking in Persons* conference will draw attention to the social and legal implications of human trafficking for forced criminality. The event will provide an excellent forum for discussing the wide range of unlawful activities that this form of exploitation entails, the national and international challenges related to the prosecution of the crime, as well as victims' rights, identification and assistance. A special focus will be given to children as they are one of the most vulnerable groups forced to commit criminal activities.

In addition to enhancing the coherence of national and international efforts, this year's high-level event aims to develop recommendations to respond to trafficking in human beings in a more comprehensive and expert manner that is respectful of human rights. Moreover, the conference will gather multidisciplinary expertise and knowledge on the phenomenon, while distinguished speakers will deliver thought-provoking presentations with the objective of generating concrete recommendations. Each panel will consist of presentations followed by an interactive discussion with the participants on current practices and lessons learned. Moderators and rapporteurs will elaborate the recommendations of each session and present them during the last panel discussion.

Finally, the conference strives to raise the profile of this complex and increasingly widespread form of human trafficking. It will also further promote the full and effective implementation of relevant OSCE commitments including the 2013 Addendum to the OSCE Action Plan to Combat Trafficking in Human Beings: One Decade Later (PC.DEC/1107/Corr.1), as well as regional and international obligations.

16.45 – 18.00 Panel 1 - Trafficking for forced criminality: forms and implications

The first panel will provide an overview of the phenomenon in the OSCE region. It will focus on the different types of unlawful activities that this form of human trafficking currently entails as well as recall States' obligations when facing this crime. Speakers will also discuss the social and legal implications of this form of exploitation and its impact on society. The profile and the specific situation of minors involved in delinquency will be described using case studies and analyzed from a sociological point of view.
