9.30 – 11.00 **Panel 3: Economic, social and political costs of trafficking in human beings**

The panel will highlight the economic, social and political costs of modern-day slavery both in terms of the violation of the human rights and dignity of trafficked persons including gender based violence, and in terms of disruption of healthy and legitimate businesses, massive tax evasion, corruption, and erosion of the rule of law. Speakers will also explore how the approach of global justice can contribute to define a comprehensive strategy to tackle trafficking in human beings as an increasingly structural component of our societies and economies, to promote the rule of law and a fairer distribution of resources at the national and international levels.

Roundtable Discussion: Towards full protection of the rights of trafficked and exploited persons

Building upon the outcome of the Ukrainian OSCE Chairmanship Conference “Strengthening the OSCE Response to Trafficking in Human Beings”, the OSCE Action Plan to Combat Trafficking in Human Beings and related commitments, speakers at the roundtable will identify and discuss a range of priorities and actions aimed at ensuring full protection of the rights of trafficked and exploited persons including legal empowerment, restitution and compensation to trafficked and exploited persons. The roundtable will explore innovative ways to address the whole spectrum of exploitation, to ensure access to justice and individualized assistance measures and, finally, to promote social inclusion in the country of destination or of origin as the final outcome of the support mechanism.
