The main and biggest Port in Albania and the gateway of Corridor VIII


It is situated in SW part of the city of Duress and 36 km East of Tirana.

DPA is a joint stock Company Where 100% of shares belong to the government.




#### Cargo volumes port of Durrës (000 tons)




