EU statement on the death penalty in the USA (Mr Davis' and

Mr. Alderman's cases)

The EU opposes the death penalty in all circumstances and calls for a global

moratorium on its use as a first step, in line with the resolution adopted by the

United Nations General Assembly on December 18, 2007.

The EU has learned with deep regret that Mr. Troy Davis is scheduled to be

executed in the State of Georgia on September 23. The EU, like many others,

had urged the Georgia State Board of Pardons and Paroles to commute Mr.

Davis' sentence to life imprisonment. However, at its meeting on September

12, the Board decided to deny clemency to Mr. Davis.

Convinced that, throughout the proceedings, many serious doubts were raised

on his culpability and recalling that any miscarriage of justice in the application

of the death penalty represents an irreparable and irreversible loss of human

life, European public opinion and members of the European Parliament in a

resolution dated July 10, 2008 have solemnly called on the competent

American authorities not to execute Mr. Troy Davis and to grant him a retrial.

The EU reiterates its urgent appeal to the Georgia State Board of Pardons and

Paroles to commute Mr. Davis' death sentence and to the relevant courts to

grant him a retrial.

The EU has also learned with deep regret that Mr. Jack Alderman was executed

in the State of Georgia on September 16. Where States insist on maintaining

the death penalty, it should be based upon clear and convincing evidence. The

EU has noted that various groups had raised grave concerns over Mr.

Alderman's conviction. We particularly regret that Mr. Alderman was executed

after 33 years on death row, in conditions of anguish and uncertainty.

While the EU is aware of the suffering of victims of violent crime and their

families, we believe that the abolition of the death penalty is fundamental to

the progressive development of human rights.

The EU trusts that the government of the United States of America will ensure

that the competent authorities be informed of this statement.
