Instructions

Petitions for requesting modification of court protection orders

The OSCE Presence in Albania and the Council of Europe have developed pre-printed petitions for modification of court protection orders.

The sample forms have been modelled to reflect requirements of petitions for protection orders under the law no.9669, dated 18 December 2007, "On Measures against Violence in Family Relations" that entered into force on 1 June 2007.

The petition forms can be downloaded and filled out by victims of domestic violence, their legal representatives, the prosecutor (if he/she has participated in the process), and then submitted to the civil district court to request court protection orders.1
