STATEMENT BY THE DELEGATION OF IRELAND

Mr. Chairperson,

Thank you for giving me the floor.

Following a historic vote on Friday, 22 May, the Irish people decided overwhelmingly to change their constitution to ensure that Ireland would become the first country in the world to vote, by referendum, for marriage equality.

The referendum proposition that “Marriage may be contracted in accordance with law by two persons without distinction as to their sex” was carried by a decisive majority – in broad figures, 62 per cent to 38 per cent on a turnout of over 60 per cent of the electorate.

The spirit in which the vote was carried is captured in the following brief quotations from the Taoiseach (Prime Minister) and Tánaiste (deputy Prime Minister).

The Taoiseach said: “With today’s Yes vote, we have disclosed who we are – a generous, compassionate, bold, and joyful people. Yes to inclusion. Yes to generosity. Yes to love, and Yes to equal marriage.”

The Tánaiste described the campaign as “profoundly uplifting” and said: “When I think back on this campaign ... most of all, I’ll think of the children. The children in every town, village, and schoolyard who will now grow up knowing their country accepts them – whoever it is they one day grow to be, and whoever it is they one day grow to love.”

While expressing respect for opponents and satisfaction at the dignified conduct of the debate, the Tánaiste described the vote as a “massive blow against discrimination” which proved that “a compassionate and well-informed electorate can and will extend civil rights when asked in a popular ballot.”

Ireland will take as inspiration the Tánaiste’s hope that “that spirit, that torch, is carried abroad,” and will work with renewed vigour to promote the values of compassion and equality reflected in this referendum result in our ongoing international engagement in multilateral organizations such as the OSCE.

The Irish parliament will now enact legislation to bring the decision of the people into effect within a matter of months.

I ask that this statement be attached to the journal of the day.

STATEMENT BY THE CHAIRPERSON

Dear colleagues,

As you all know, Basel Ministerial Council Decision No. 5/14 on prevention of corruption tasked the Economic and Environmental Committee (EEC) to provide a report on options for strengthening the current OSCE capacity in the area of combating corruption and present it to the Permanent Council no later than 1 June. After extensive deliberations in informal meetings of the group of friends created by the EEC chairperson, within the Economic and Environmental Committee and bilateral consultations, in the view of the chairperson of the EEC, that even though there is a wide support for the creation of this report, within such a limited timeframe it would be impossible to provide a consensual report of the EEC by 1 June. However, these deliberations showed the importance that participating States give to this topic, which also represents one of our priorities in the second dimension.

Therefore, the Chairmanship has decided to continue with consultations in order to provide the report on options for strengthening the current OSCE anti-corruption capacity, followed by a CiO perception paper to be presented to the Permanent Council in due course, with an aim of providing a basis for further deliberations among all 57 participating States.

**STATEMENT BY
