Payment method:

Payment for the services provided shall be made against purchase document.

There are two forms of purchase document:

- a simplified bill (a single amount, without separate VAT item)
- VAT invoice.

The following information is required for us to make out a VAT invoice:

- 1. Full name of the Institution or Organization
- 2. Detailed address of the registered office
- 3. Fiscal Code (NIP) if assigned to the Institution or Organization
- 4. Full name of the person authorized to sign and accept the invoice
