LETTER OF THE CHAIRPERSON

Ambassador and Chairperson of the Permanent Council, Kairat Abdrakhmanov

Vienna, 28 July 2010

In connection with the Permanent Council decision on the agenda, organizational framework, timetable and other modalities of the OSCE Summit in Astana on 1 and 2 December 2010, the Chairmanship-in-Office guarantees that the costs of the OSCE Summit shall be handled in full accordance with the OSCE rules and procedures, including the 1992 Helsinki decisions.

Furthermore, the Chairmanship hereby submits a preliminary projection of those expenses subject to reimbursement by the participating States, in accordance with paragraph (6) of the Helsinki Decision XII, and guarantees that the total amount of these expenses shall not exceed 1.5 million euros.

According to the 1992 Helsinki decisions, the actual expenses subject to reimbursement by the participating States shall be subject to external auditing after the Summit and the relevant bills to the participating States shall be issued in the year 2011.

STATEMENT BY THE CHAIRPERSON

Dear Ambassadors,

I am pleased to inform the Permanent Council that, following broad and intensive consultations in the Human Dimension Committee and other informal formats, the participating States have closely approached consensus on the draft Indicative Work Programme for the human dimension parts of the Review Conference.

The latest version of this document, which was circulated on 29 July 2010 as document CIO.GAL/133/10/Rev.3, enjoys broad support of delegations, and is ready for adoption by the participating States.

The Chairmanship's perception is that open-ended informal consultations among the participating States in Vienna on the human dimension part of the Indicative Work Programme of the Review Conference are therefore concluded. There is an understanding that this part of the Programme can be set aside and considered as informally finalized by all the participating States.

Therefore, pending finalization of indicative work programmes for the other three thematic areas of the Review Conference, the Chairmanship calls on the participating States not to reopen discussions on the Indicative Work Programme for the Human Dimension between now and formal adoption of the whole programme.

The Chairmanship intends to finalize the three other parts of the entire Indicative Work Programme of the Review Conference as soon as possible, taking also into account the upcoming summer recess, and will propose the full programme for adoption by consensus either before the Review Conference, through a separate Permanent Council decision, or at the opening of the Review Conference, as stipulated in paragraph 4 of the Permanent Council decision on the agenda, organizational framework, timetable and other modalities of the 2010 Review Conference, which hopefully will enter into effect next week.

The Chairmanship assures all the delegations that it will not miss any proposals and take them onboard while preparing the annotated agenda of the human dimension segment of the Review Conference.

This statement by the Chairperson will be attached to the journal of this meeting of the Permanent Council, in accordance with paragraph 7 of section IV.1(B) of the Rules of Procedure.

In accordance with the OSCE Rules of Procedure, the Permanent Council requests the Chairperson of the Permanent Council to forward this draft agenda to the Chairperson of the Summit for formal adoption by the Summit Meeting at its opening.

II. Organizational framework, timetable and other modalities

1. The Astana Summit Meeting will begin on Wednesday, 1 December 2010, at 9 a.m. and end on Thursday, 2 December 2010, at approximately 1 p.m. The Meeting will be held at

the Palace of Independence in Astana. The Meeting will be held in accordance with the OSCE Rules of Procedure (MC.DOC/1/06 of 1 November 2006).

- 2. The morning session on 1 December 2010 will be held from 9 a.m. to 12.30 p.m. The afternoon session on 1 December 2010 will be held from 3 to 5 p.m. The morning session on 2 December will be held from 9 a.m. to 12.30 p.m. The closing ceremony will take place on Thursday, 2 December 2010, beginning at approximately 12.30 p.m.
- 3. The Chair at the opening and closing plenary sessions and the session dealing with item 4 will be taken by the Head of State or Government of the host country or the Chairperson-in-Office. The Chair at the other plenary sessions dealing with items 2 and 3 of the agenda will be taken by Greece and Lithuania.
- 4. The statements by Heads of State or Government under agenda items 2 and 3 will be made in the order established by the drawing of lots (to be determined). The delegation of the European Union, as the successor of the delegation of the European Commission, may take the floor immediately after or immediately before the participating State holding the EU Presidency without setting a precedent and without altering the existing Rules of Procedure of the OSCE.
- 5. The statements under all agenda items should not exceed five minutes. The speakers are encouraged to distribute their statements in writing, for the record.
- 6. The Secretary-General of the United Nations will be invited to address the Summit Meeting under agenda item 1.
- 7. The President of the OSCE Parliamentary Assembly will be invited to address the Summit Meeting under agenda item 1.
- 8. The following international organizations, institutions and initiatives will be invited to attend the Meeting and, if they so wish, make written contributions: Adriatic-Ionian Initiative; African Union; Asian Development Bank; Association of Southeast Asian Nations (ASEAN); ASEAN Regional Forum; Barents Euro-Arctic Council; Central Asian Regional Information and Coordination Centre for Combating Illicit Trafficking of Narcotic Drugs, Psychotropic Substances and their Precursors; Central European Initiative; Collective Security Treaty Organization; Commonwealth of Independent States; Commonwealth of Nations; Community of Democracies; Community of Portuguese Speaking Countries; Conference on Interaction and Confidence-Building Measures in Asia; Council of the Baltic Sea States; Council of Europe; Economic Cooperation Organization; Energy Charter Secretariat; Eurasian Economic Community; European Bank for Reconstruction and Development; European Investment Bank; Europol; Financial Action Task Force; International Atomic Energy Agency; International Committee of the Red Cross; International Criminal Court; International Criminal Police Organization; International Criminal Tribunal for the former Yugoslavia; International Energy Agency; International Fund for Saving the Aral Sea; International Labour Organization; International Monetary Fund; International Organization for Migration; League of Arab States; North Atlantic Treaty Organization; Non-Aligned Movement; Organization of American States; Office of the United Nations High Commissioner for Human Rights; Office of the United Nations High Commissioner for Refugees; Organisation for Economic Co-operation and Development; Organization for Democracy and Economic Development – GUAM; Organisation

- 9. The Meeting will be open to the press and the public. Proceedings of the Summit Meeting will be broadcast live (in all six languages of the OSCE) to the Media Centre and NGO Centre by closed-circuit television, including all statements by Heads of State or Government.
- 10. Arrangements for access to the premises of the Summit Meeting will be decided on by the Executive Secretary subject to the availability of seats. In principle, each OSCE participating State and OSCE Partner for Co-operation will have one seat at the main table and ten seats behind. The delegation of the European Union, as the successor of the delegation of the European Commission, will have one seat next to the participating State holding the EU Presidency.
- 11. In conformity with paragraph 74 of the 1973 Final Recommendations of the Helsinki Consultations, the Government of the host country has designated Director of the Task Force, Ambassador-at-Large, Mr. Serzhan Abdykarimov, as Executive Secretary of the OSCE Astana Summit Meeting.
- 12. The Standard Scale of Contributions of the OSCE will be applied to the Astana Summit Meeting in respect of those costs to be met by the participating States. The maximum costs to be met by the participating States are stated in the letter issued by the Chairperson of the Permanent Council on 29 July 2010 (CIO.GAL/138/10/Corr.1).
- 13. This decision will enter into effect as from the date of adoption of the Ministerial Council decision on the time and venue of the next OSCE Summit and Review Conference.

INTERPRETATIVE STATEMENT UNDER PARAGRAPH IV.1(A)6 OF THE RULES OF PROCEDURE OF THE ORGANIZATION FOR SECURITY AND CO-OPERATION IN EUROPE

"Mr. Chairperson,

I would like to make an interpretative statement relating to the meaning of the phrase 'In principle, (...)' at the beginning of the second sentence of paragraph 10 of the decision contained in document PC.DEC/951, dated 29 July 2010.

Mr. Chairperson,

In our view, that phrase will mean that our country – due to its unique traditional institutions – will be allocated two seats around the conference table in order to accommodate the two Captains Regent composing the institution of the Head of State of the Republic of San Marino.

I trust all countries will support this interpretation in order to allow our country to be represented at the level of Head of State at the OSCE Summit in Astana.

I am particularly confident in your support, Mr. Chairperson, as tradition is part of the Kazakh Chairmanship 'motto'.

II. Organizational framework, timetable and other modalities

1. The Review Conference shall be held in accordance with the OSCE Rules of Procedure (MC.DOC/1/06 of 1 November 2006), in particular its Section (A) OSCE meetings, and will be governed by the following provisions. The modalities of annual Human Dimension Implementation Meetings (HDIMs), as set out in PC.DEC/476, will be, *mutatis mutandis*, reflected in the human dimension parts of the Review Conference in Warsaw and Astana as outlined below. In case of contradiction between provisions of PC.DEC/476 and provisions of this decision, the latter shall take precedence.

Under agenda item 3, at the Review Conference in Vienna, the Chairperson of the Joint Consultative Group (JCG) and the Chairperson of the Open Skies Consultative Commission (OSCC) may provide information on the functioning of the CFE regime and the functioning of the Open Skies Treaty, respectively. Similarly, the Chairperson of the Forum for Security Co-operation (FSC) will be invited to report to the plenary on Monday, 18 October 2010.

2. All items of the agenda of the Review Conference, except for item 6 of the agenda in Warsaw and Vienna and item 2 of the agenda in Astana, will be dealt with in plenary sessions. Item 6 of the agenda in Warsaw and Vienna and item 2 of the agenda in Astana will be dealt with in working sessions, arranged in parallel working sessions in Vienna and in consecutive working sessions in Warsaw and Astana. The working hours of the Review Conference: from 10 a.m. to 1 p.m. and from 3 to 6 p.m.

Those making reports or contributions under any agenda item are encouraged to submit them in writing. Oral presentations under any agenda item should not exceed five minutes.

- 3. The OSCE Parliamentary Assembly and the OSCE Partners for Co-operation may attend all sessions of the Review Conference and make both oral and written contributions under item 6 in Warsaw and Vienna and item 2 in Astana. All OSCE executive structures, in particular field operations, are encouraged to designate representatives to participate in the Review Conference.
- 4. An indicative work programme for the working sessions under item 6 in Warsaw and Vienna and item 2 in Astana will be agreed upon by the participating States before, if possible, or at the first plenary session of the Review Conference in Warsaw, after open-ended informal consultations among the participating States in Vienna that are to be concluded prior to the opening of the Review Conference. For practical and organizational reasons, the deliberations at the Review Conference will be organized according to the three traditional areas of OSCE activity; at the same time, sessions will be organized in such a way as to permit a discussion of OSCE structures and their activities:

Politico-military dimension

Agenda item 6(c): Review of the implementation of all OSCE principles and commitments relating to the politico-military and non-military aspects of security (PMS)

Chair: Representative of Greece (8 sessions)

Economic and environmental dimension

Agenda item 6(d): Review of the implementation of all OSCE principles and commitments in the economic and environmental dimension (EED)

Chair: Representative of Lithuania (7 sessions)

Human dimension

- 5. The plenary sessions of the Review Conference will provide direction to the deliberations in the working sessions and will conclude each part of the Review Conference.
- 6. In keeping with the increasing openness of OSCE activities, representatives of non-governmental organizations (NGOs) with relevant experience in the area under discussion are free, on the basis of the procedures set out in the Annex, to attend and contribute to the working sessions of the Review Conference dealing with the human and the economic and environmental dimensions (EED, HDR and HDF) and the part of working sessions on OSCE structures and their activities dealing with lessons learnt from field activities (part of OSA).
- 7. The plenary sessions of the Review Conference will be open unless otherwise agreed upon by the participating States at a plenary session.
- 8. The plenary sessions and working sessions of the Review Conference will be held in accordance with the schedule of sessions contained in this document. This schedule will be subject to constant review and possible readjustment by the participating States at a plenary session.
- 9. The following international organizations, institutions and initiatives will be invited to attend and make written contributions at all sessions of the Review Conference: Adriatic-Ionian Initiative; African Union; Asian Development Bank; Association of Southeast Asian Nations (ASEAN); ASEAN Regional Forum; Barents Euro-Arctic Council; Central Asian Regional Information and Coordination Centre for Combating Illicit Trafficking of Narcotic Drugs, Psychotropic Substances and their Precursors; Central European Initiative; Collective Security Treaty Organization; Commonwealth of Independent States; Commonwealth of Nations; Community of Democracies; Community of Portuguese Speaking Countries; Conference on Interaction and Confidence-Building Measures in Asia; Council of the Baltic Sea States; Council of Europe; Economic Cooperation Organization; Energy Charter Secretariat; Eurasian Economic Community; European Bank for Reconstruction and Development; European Investment Bank; Europol; Financial Action Task Force; International Atomic Energy Agency; International Committee of the Red Cross; International Criminal Court; International Criminal Police Organization; International Criminal Tribunal for the former Yugoslavia; International Energy Agency; International

Fund for Saving the Aral Sea, International Labour Organization; International Monetary Fund; International Organization for Migration; League of Arab States; North Atlantic Treaty Organization; Non-Aligned Movement; Organization of American States; Office of the United Nations High Commissioner for Human Rights; Office of the United Nations High Commissioner for Refugees; Organisation for Economic Co-operation and Development; Organization for Democracy and Economic Development – GUAM; Organisation internationale de la Francophonie; Organization of the Black Sea Economic Cooperation; Organization of the Islamic Conference; Organization for the Prohibition of Chemical Weapons; Preparatory Commission for the Comprehensive Nuclear-Test-Ban; Regional Cooperation Council; Shanghai Cooperation Organisation; South-East European Cooperation Process; Southeast European Cooperative Initiative; Union for the Mediterranean; United Nations Alliance of Civilizations; United Nations Children's Fund; United Nations Conference on Trade and Development; United Nations Development Fund for Women; United Nations Development Programme; United Nations Economic and Social Commission for Asia and the Pacific; United Nations Economic Commission for Europe; United Nations Educational, Scientific and Cultural Organization; United Nations Environment Programme; United Nations Institute for Disarmament Research; United Nations Office of the High Representative for the Least Developed Countries, Landlocked Developing Countries and Small Island Developing States; United Nations Office on Drugs and Crime; United Nations Regional Centre for Preventive Diplomacy for Central Asia; World Bank and the World Customs Organization.

The above international organizations, institutions and initiatives will be invited to make their contributions to plenary sessions and at appropriate working sessions of the Review Conference in the context of relevant agenda items.

10. The Chair at the plenary sessions of the Review Conference will be a representative of the Chairperson-in-Office, except for the plenary session in Warsaw to conclude discussion of agenda item 6(a), which will be chaired by the Director of the ODIHR, in accordance with PC Decision No. 476. The discussions during the working sessions in Vienna will be chaired by representatives of the other two OSCE Troika countries: Greece and Lithuania. The discussions during the working sessions in Warsaw and Astana will be chaired by moderators as stipulated in PC Decision No. 476, who will be appointed by the Chairmanship.

The representative of the Chairperson-in-Office will, after consultations with the participating States, appoint appropriate number of rapporteurs for the working sessions. The reports of the rapporteurs, which will not be regarded as binding documents, will be presented in the last plenary meeting of each part of the Review Conference, and will serve as a basis for subsequent deliberations at the Astana part of the Review Conference.

11. This decision will enter into effect as from the date of adoption of the Ministerial Council decision on the time and venue of the next OSCE Summit and Review Conference.

All NGOs wishing to attend the working sessions of the Review Conference dealing with the agenda items 6(d) – EED, 6(a) - HDR, 6(b) – HDF (item 2 in Astana) and the part of working sessions dealing with lessons learnt from field activities under agenda item 6(e) – OSA will be admitted subject to the provisions contained in Chapter IV, paragraphs 15 and 16 of the Helsinki Document 1992. Prior to the meetings, the OSCE Secretary General, in consultation with the ODIHR, will distribute to all participating States a list of the NGOs intending to participate. The Secretary General, in close co-operation with the ODIHR, will keep participating States regularly informed of additional NGOs wishing to attend the working sessions and plenary meetings. Should questions arise concerning the application of Chapter IV, paragraph 16 of the Helsinki Document 1992, the Secretary General, assisted by the ODIHR, will undertake consultations to ensure that any decision on the matter is in conformity with the said provisions and is based on the views of the interested participating States.

DECISION No. 953 ELECTION SUPPORT TEAM TO AFGHANISTAN

The Permanent Council,

Recalling the UN Security Council resolution 1917 (2010), which underscores the importance of the upcoming national legislative elections to Afghanistan's democratic development, calls for all efforts to be made to ensure the credibility, safety and security of the elections and further calls upon members of the international community to provide assistance as appropriate,

Taking note of the letter of 24 July 2010 of the Independent Election Commission of the Islamic Republic of Afghanistan, in which the OSCE/ODIHR is invited to support the National Assembly elections to be held on 18 September 2010,

Taking into consideration the status of Afghanistan as a Partner for Co-operation of the OSCE, which has an important impact also on neighbouring regions of the OSCE,

Underscoring the importance of democratic elections for fostering democracy and human rights and for furthering stability in Afghanistan and contributing to international efforts to combat terrorism,

Taking note of Permanent Council Decision No. 622 of 29 July 2004 on sending an OSCE Election Support Team for the Presidential elections in Afghanistan on 9 October 2004 and the recommendations issued by that Support Team on 18 October 2004,

Taking note of Permanent Council Decision No. 686 of 7 July 2005 on sending an OSCE Election Support Team for the National Assembly and Provincial Council elections in Afghanistan on 18 September 2005 and the recommendations issued by that Support Team on 6 October 2005,

Taking note of Permanent Council Decision No. 891 of 2 April 2009 on sending an OSCE Election Support Team for the Presidential and Provincial Council elections in Afghanistan on 20 August 2009 and the recommendations issued by that Support Team on 8 December 2009,

Taking into account conditions in Afghanistan, in particular the security situation,

Decides, as an extraordinary measure, in response to the specific request of the Government of Afghanistan, to send an Election Support Team to be organized by the ODIHR to assist government and international efforts on the National Assembly elections in Afghanistan scheduled for 18 September 2010;

Tasks the Election Support Team to prepare a report, to be distributed to participating States, on the electoral process, based on its findings, including a set of recommendations to the Government of Afghanistan for implementation as appropriate in the post-election period, with a view to enhancing the conduct of future elections and improving Afghanistan's legal framework and procedures;

Requests that the ODIHR closely co-ordinate with relevant national, regional and international actors involved in electoral processes in Afghanistan, including the Independent Election Commission of Afghanistan, the United Nations Assistance Mission in Afghanistan (UNAMA), the United Nations Development Programme (UNDP) and the European Union;

Tasks the ODIHR to determine the appropriate size of the Election Support Team, which is not to exceed ten election staff; and

Tasks the Secretariat, together with the ODIHR, to conduct consultations with the Government of Afghanistan, international military forces and international actors, including the United Nations, in order to spell out clearly in the appropriate form and put in place the necessary security arrangements for the Election Support Team.

Expenses for the Election Support Team will be covered by extrabudgetary contributions.

This decision does not set a precedent for OSCE activities beyond its geographical area of responsibility.
