A Technical Proposal and a Financial Proposal shall be submitted in two separate, sealed envelopes, clearly marked as such. In addition, the envelope for the Financial Proposal should have a warning note "FINANCIAL PROPOSAL: DO NOT OPEN WITH TECHNICAL PROPOSAL" printed on it. The Technical Proposal shall not include any financial information. Both envelopes shall be placed into an outer envelope and sealed. This outer envelope shall bear the submission address and clearly marked with "Proposal for the Provision of Vehicle Maintenance Services for OSCE Mission in Kosovo, RFP No. OMIK/VEHICLE MAINTENANCE/AS/2007/04 - Do Not Open Before 30 July 2007 12:00hrs".

Proposals sent by facsimile or e-mail will not be accepted. The prices shall be quoted in EURO.

Partial bids submitted for a complete range of services per vehicle make shall be accepted.

All Proposals shall be accompanied by a Bid Security of EUR 6,000.00

The OSCE reserves the right to accept or reject any proposal, and to annul, in whole or in part, or to suspend the bidding process and to reject all Proposals, at any time and without reason prior to award, without thereby incurring any liability to the affected Bidder or Bidders.
