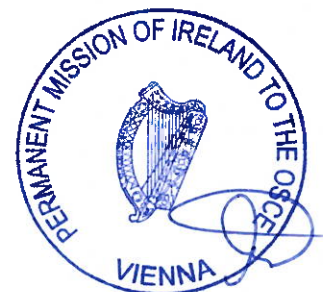
## NOTE VERBALE
