Report of Chairman of Kyrgyz committee for human rights Dyryldaev R.O.

The majority of citizens of Kyrgyzstan leave in search of living on existence or simply to work as they are not satisfied with the economic situation developed in the country. Our citizens do not have confidence of tomorrow's day, there is no opportunity to earn for a life for themselves and for the relatives, many are concered with hope for the future of children. That is why by old tradition the majority leave to Russia where they face with set of problems including lawlessness, an arbitrariness, elementary rights of citizens frequently are not observed. Because of the high level of cortuption is very difficult to receive allowing documents on the right of residing and realization of labour activity, the majority of such citizens constantly pays off from the militiamen checking time registration who frequently use illegal methods of influence on the Kirghiz migrants.

The big problem of the migrants - citizens of KR are registration and official registration of papers on reception of the sanction to residing and to permit residence. During the period from January 1 till September 30, 2005, 812 citizens of Kyrgyzstan living in Russia, have been punished for infringement of clause 327 Criminal Code of Laws of the Russian Federation (use of the false documents). According to consular service of embassy of KR in the Russian Federation which in turn refers to the Ministry of Foreign Affairs of the Russian Federation, it is almost 38 percent from the general number of all Kirghiz citizens who have been instituted by criminal proceedings in territory of the Russian Federation.

According to the criminal legislation, term of punishment for purchase of the false migratory card and registration of illegal time registration makes from three till 6 months of imprisonment. For the same nine months 46 thousand 927 people, that is 72 % from the general number of the Kirghiz citizens involved with the Russian authorities to the administrative responsibility, have undergone to penal sanctions for infringement of rules of stay in territor of the Russian Federation and absence of time registration. Position of our citizens still remains heavy. The accepted interstate agreements do not provide an equal legal protection to our citizens. Therefore all of them become more often victims of various crimes. Which in a consequence are not investigated properly, or affairs stop, not reaching a stage of punishment the guilty. For the last couple of years in Russia our 400 citizens were lost.

Mainly they become victims of crimes on ground of race and nationality. Only for 9 months in 2005 in Russia more than 20 people were killed (including first half of September - 4 people). Not all of them were lost from hands of the Skinheads, b't on the other hand, it is known, that not each case of violence become, known even to fellow countrymen of victims (we shall

remind, that by the beginning of 2005 in territory of the Russian Federation officially disappeared 112 citizens of Kirghizia were registered). And according to the Russian rating of crimes on ground ethnic break a set: has suffered more than ten citizens of Kyrgyzstan. The Russian site « New Regions » has published results of press conference which was carried out in Moscow by representatives of the Moscow bureau under human rights. « For the last couple of years the number of crimes on ground of ethnic hatred in Russia has grown in some times. By amount of the offences accomplished in 2006, the dangerous tendency will proceed further », - have declared the human rights defenders. On their data, only January - June of 2006 on ground of ethnic hatred it is fixed about 100 attacks on citizens as a result of whom 18 people were lost and about 160 have received wounds. For comparison - in the first half-year of 2004 seven murders and about hundred beatings, in the first half-year of 2005 - 10 murders and 200 victims have been accomplished.

Among the most unsuccessful cities where activity of national-radicals was most of all showed, on the first place Moscow (5 killed, 50 victims). Further goes Saint Petersburg (3 killed, 37 victims), Kaliningrad (more than 10 victims), Kostroma (5 victims), Volzhsk (2 killed, 2 victims), the Voronezh area (killed, 3 victims), the Tula area (1 killed, 2 victims), Krasnoyarsk (4 victims), Cheboksary, Vladivostok, Ekaterinburg (3 victims), Sujensk area, Elista (2 victims), Kaluga, Nizhni Novgorod and Yaroslavl (2 victims). Closes the list Orel, Petrozavodsk, Rostov - na-Donu, Ryazan and Surgut where it is fixed one victim. Recently from Moscow ten corpses of our fellow countrymen have been delivered.

The Kirghiz politics declare, that specific "cargo - 200" acts to Kyrgyzstan on a regular basis. For the last two weeks of December, 2005 only from Moscow to Bishkek it has been delivered ten dead men. The facts about injured citizens of KR who became victims of crimes on ground of race and nationality:

1. In the evening on February 24 in area Kalinin of Saint Petersburg the group of young people has attacked two women citizens of Kirghizia and Azerbaijan who were coming back home after work. Both victims have received plural knife wounds from which one of them has died on the place. Some young people with shouts "Russia is for Russians! "Have attacked women from behind, rendering to both impacts by a knife. Physicians have counted on a body of the lost citizen of Kirghizia of the Kazakh origin Ainur Bulekbaeva ten knife wounds, one of which was necessary in area of heart. 2. In the city of Sevalozhsk (Russia) has been killed 32-year old native Zhajyl area of Chui Ramis Soodaliev.

However the formal notice of the Russian law enforcement bodies as assert in JK, it did not act on us at all. In investigation of cases of a violent death of our compatriots there are engaged superficially. The court is reached only with the tenth part of criminal cases. 3. In Kaliningrad security guards have beaten Kirghiz migrant worker. In Svetlogorsk the Kaliningrad area employees of private security enterprise (PSE) have beaten the migrant worker from Kyrgyzstan, informs the Interfax http://www.interfax.ru/ referring to the press-service of the regional

Department of Internal Affairs. "People in masks have put traumas and mutilation to ten builders then have taken away money and mobile phones from them. In result several injured people have been hospitalized", - informed in the press-service of the Department of Internal Affairs.

Not looking on that there was such horrifying situation, and our citizens perish in tens on foreign land literally, the Kirghiz Government does not undertake any effective measures on protection of our fellows citizens in Russia. On the similar facts practically there are no official references of our government to authorities of Russia, with the requirement to observe and protect the right of our citizens on them in territory, in an equal measure with the right of Russians. Can be even concerns more closely and scrupulously to the rights of migrants, in fact such social layer as migrants is very open to injury in every respect. All this testifies to arrogance and pressure on the part of the Russian government of Kyrgyzstan, and to other countries of CIS the similar relation. The Russian government supports only despotic governments under the pretext of a choice of people though they perfectly know as is carried out elections to such countries, during time the Russian government accepts huge efforts that, to deprive with OSCE, ODIHR the right of supervision over elections. As these democratic institutes make truthful reports as is carried out elections to the despotic countries.

During that time frequently our citizens are used as slaves. In a question of regulation of Libour relations set of our citizens become victims of indifference of the Russian employers where at all do not observe the requirement of the safety precautions of workplaces. Therefore our citizens perish: 1. Tragical stepped July for two our labour migrants who have gone on earnings to Russia. The first misfortune happened in Moscow during reconstruction of hotel " Intourist ". Here from 11-th floor has fallen 23-year old native Toktogul area of Dzhalal-Abad Abdikaliev was broke to death. And it is literally next day, also in the morning, on a building site of an apartment house in Saint Petersburg from height of 16-th floor the lift has unexpectedly failed downwards. In it there were four people, one of them - the native of Kyrgyzstan Vyacheslav Vasilitsyn. He and two of his colleagues have died, the fourth one is in a heavy condition getting hospitalized. On a place of both incidents on migration and employment employees of representation of our State Committee at once have visited Russia, together with workers of law-enforcement structures finding out circumstances of tragedies.
