Envelopes should be delivered to our office (4<sup>th</sup> floor, 12b, Afrosiyob str., 700015, Tashkent). Bids will be accepted until **18.00, 25 September 2006;** late submissions will be void. Only successful bidder(s) will be notified on the bid award and actual sales price. Bids that are not in compliance with the above specified requirements will be rejected.

#### Payment

Payment should be preferably made by bank transfer or by cash in **EURO** (bank details will be corresponded to the successful bidder later). Payment in USD or UZS will be accepted based on the OSCE official exchange rate at the date of transaction.

Should the successful bidder fail to transfer the money to the OSCE within 5 working days after the notification on the bid award, the item will be awarded to the next successful bidder.

**View of Items**

The item can be viewed and inspected at the OSCE office on 13 and 14 September 2006, from 14:00 to 17:00.

**Collection of Items**

Buyers will be invited to pick up the items from the premises of the OSCE upon receipt of evidence of payment from the Treasury Unit, and after signing the sales contract and handover document.

**Restrictions**

1. The Bid Opening Board Members are not allowed to participate in the auction.
2. The Bid can be retracted at any time before its opening by the bid opening board. Bids are binding and refusal of the successful bidder to pay after being awarded the sales is not allowed. Failure to pay may result in barring from future invitations for bid.
