Assistance in organization of systematic preventive work in schools, boarding schools, shelters, social and rehabilitation centers etc.

- Estimation of the situation

- Effectiveness estimation



Seminars, conferences, round tables for specialists

- Seminar on counteraction against trafficking in human beings for representatives of Embassies, law enforcement structures, representatives of system of social protection of population etc. (2004, with financial support of Nordic Council of Ministers)
- Seminar “About the measures which are undertaken by government, international and Non-Governmental organizations in sphere of child trafficking prevention” (2005, on the request and with financial support of Committee on Law, Order and Safety)
- International conference “Cooperation in sphere of combating trafficking in human beings in North-West Russia, Baltic and Northern countries” (2008, in cooperation with St. Petersburg Government and Nordic Council of Ministers)
- Seminars for stakeholders in several St. Petersburg districts (since 2005 till now)

Organization of study visits of officials to European countries

- Representatives of law enforcement structures, of Committee on Law, Order and Safety, Committee on Labor and Social Protection of Population, Committee on Education, municipalities etc.
- Study visits to Norway, Sweden, Iceland etc.
- Financial support of Nordic Council of Ministers

Cooperation with Accor

Accor in CIS and Russia

- Has signed the Code of Conduct;

- Has developed and published postcards for guests with information that children should be protected from CSEC including child trafficking

Mass media representatives are regularly invited to the events aimed to combating trafficking in human beings




Prevention of secondary involvement into trafficking

- “Prevention of CSEC and protection of children who are victims of commercial sexual exploitation” (2008-2009, in cooperation with Shelter “Transit” with financial support of OSCE)
- “Improvement of the quality of care, protection and rehabilitation services for children who have been commercially sexually exploited in Russia” (2008-2010, in cooperation with Defence for Children International (DCI) - ECPAT The Netherlands, with financial support of Ministry of Foreign Affairs of Netherlands)

Development of social partnership in sphere of combating CSEC

- Initiation of Russian Alliance against Commercial Sexual Exploitation of Children
- Taking part in the activity of Working Group on Counteraction against Commercial Sexual Exploitation of Minors under Commission on Minors Affairs and Protection of Their Rights under St. Petersburg Government
- Collecting proposals from regional specialists on combating CSEC including proposals on prevention of child trafficking

- From our point of view prevention is important direction of work in sphere of combating trafficking in human beings
- We believe that only together we could work effectively in sphere of prevention of trafficking in human beings
