

Goal and direction


- Reduce corruption in the customs sphere by streamlining regulations, raising the administrative standards, and bringing transparency through the use of an inter-state information sharing system
- > A way to eliminate opportunities for corruption:
 - Modernization of customs procedures and business processes
 - Use of Information technologies
 - > Risk management
 - > Audit based controls
 - Cooperation between the Customs and other Authorities

Steps for reaching goals


- Assessment

- Development and testing of software




Legal framework

- Council Regulation (EC) No 837/2005
 - Transit declaration shall be lodged using a data-processing technique
 - The use of a written transit declaration shall be subject to the approval of the customs authorities
- Council Regulation (EC) No648/2005
 - Customs controls shall be based on risk analysis using automated data processing techniques

5.6 Do you believe that the new computerized transit system will reduce opportunities for corruption between businesses and customs authorities?

- •About one-third of surveyed companies are aware of the State Customs Service of Ukraine's (SCSU) aspiration to join the NCTS system (since 2007, there was a significant growth in the share of companies aware of this initiative- from 20% in 2007 to 31% in 2009).
- •Over 70% believe that corruption will be reduced as a result of adopting the NCTS. This percentage remains relatively unchanged since 2007.

Future plans

- Join to Common Transit Convention
- International data harmonization and standardization
- Identification of agencies' requirements for paper documents and IT systems
- Paperless procedures and simpification
- Facilitate trade in the Black sea to Baltic sea trade corridor
