### About OSCE Local Dialogue Academy for Young Women

The OSCE Local Dialogue Academy for Young Women provides a platform for young women to overcome barriers in communication, deconstruct stereotypes and sets a baseline for dialogue through peer-to-peer learning, coaching and mentoring activities. It aims at enhancing network communication between communities focusing on common issues of concern, in particular related to gender equality and women empowerment.

### Qualifications

The call is open to young women between the ages of 16 and 19<sup>3</sup> from Kosovo with interests in participating in policy and decision-making processes, voluntarism, community work, and advocacy. English language skills are not mandatory.

### Structure and topics

The OSCE Local Dialogue Academy for Young Women envisages five days of team-building exercises, peer-to-peer learning, interactive training on leadership, and coaching on practical skills.

Through interactive learning modules, participants will expand their knowledge in women empowerment, leadership and building communication bridges for a resilient society.

The topics include:

- Confidence building measures;
- Women empowerment and participation in public and policy making processes;
- Dialogue and conflict resolution;
- Practical skills on how to write a motivation letter and a CV.

### Arrangements

All expenses related to participation in the OSCE Local Dialogue Academy for Young Women will be covered by the OSCE Mission in Kosovo, including transport, meals and refreshments, accommodation, and course module costs.

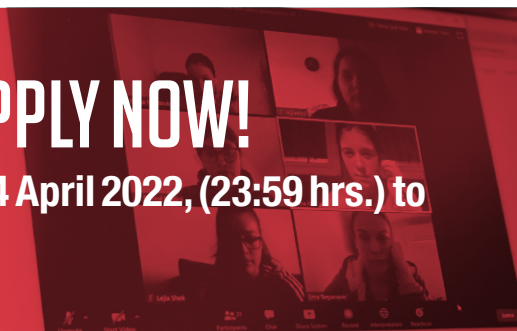

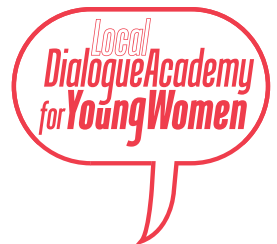
