The Organization for Security and Co-operation in Europe (the OSCE) has received the requests for clarifications from some bidders with regard to RFP No.10/2005.

In accordance with paragraph 4 "Amendments to RFP Documents" the OSCE hereby amends the bidding documents as follows:

#### Question and Answer Batch 1

In accordance with paragraph 3 "Clarification RFP Documents" of Instructions to Bidders, the OSCE would like to provide the following clarifications to all prospective bidders:

#### **Question 1:**

As we are an insurance broker: Do you have a preference for the involvement of a broker in this procurement process or would you rather prefer direct contact with insurance carriers?

#### **Answer to Question 1:**

In line with the Organizational policies, we would like to involve the Insurer/Underwriter into the contractual relations by establishing a tri-partite agreement to which all three parties would be bound. Hence, the relevant Insurer/Underwriter shall accept and agree to legally bind itself to any and all terms and conditions offered by a broker, who is submitting a proposal on behalf of such Insurer/Underwriter.

## **Question 2:**

Who are the carriers that have insured the risks in question previously?

Please note that the OSCE cannot accommodate this question albeit the OSCE has worked with well reputed international companies and all relevant and material information on the subject matter has been disclosed in the RfP documents.

## **Question 3:**
