**DECISION No. 1123
APPROVAL OF THE 2014 UNIFIED BUDGET**

The Permanent Council,

I. Acting in accordance with the relevant provisions of the Financial Regulations and Permanent Council Decision No. 553 of 27 June 2003,

1. Approves the 2014 Unified Budget contained in Annex I;
2. Approves the Post Table contained in Annex II;

II. Recalling relevant Ministerial Council Decisions, *inter alia*, No. 18/06 on further strengthening the effectiveness of OSCE executive structures and No. 19/06 on strengthening the effectiveness of the OSCE,

Taking into account Permanent Council Decision No. 705 of 1 December 2005 on the Common Regulatory Management System (CRMS), and striving to contribute to strengthening the efficiency, effectiveness and transparency of the Organization,

Underlining the importance of the oversight of the OSCE's administrative and financial activities exercised by the participating States, and recalling Permanent Council Decision No. 552 of 27 June 2003, setting out the responsibilities of the Advisory Committee on Management and Finance (ACMF),

Taking into consideration financial constraints faced currently by the participating States and reiterating that any request for a supplementary budget during a financial year shall be met, wherever reasonable, by reallocating existing resources, and

Taking note of the Report of the Secretary General to the Permanent Council on local staff income taxation, SEC.GAL/122/13 of 28 June 2013,

1. Tasks the ACMF, in co-ordination with the Secretary General, to continue efforts to improve further the programme and budget planning process within the OSCE;
2. Undertakes to continue efforts, including throughout the Unified Budget cycle in 2014, to focus, streamline and prioritize the work of the Organization across the three dimensions in those areas where it has comparative advantage, and tasks the fund

managers to ensure the coherence of their programme activities, in accordance with the body of the OSCE principles, commitments and decisions as well as their respective mandates;

3. Decides that the period for in-grade movement between consecutive salary increments shall be two years, and tasks the Secretariat to implement this measure by formulating amendments to relevant provisions of the OSCE Staff Regulations and Staff Rules which shall be subject to approval by the Permanent Council by 31 July 2014;
4. Tasks the Secretary General to request the International Civil Service Commission (ICSC) to exercise greater vigilance with regard to increases in staff costs across the Common System, particularly within the context of the ongoing comprehensive review being undertaken by the ICSC, and tasks the ACMF to continue discussions on Staff Standard Costs issues with a view to ensuring the financial sustainability of those costs;
5. Requests the ACMF and the Chairmanship, in co-ordination with the Secretary General, to continue discussions on local staff income tax with a view to achieving full compliance with the OSCE Staff Regulations and Staff Rules.

**INTERPRETATIVE STATEMENT UNDER
PARAGRAPH IV.1(A)6 OF THE RULES OF PROCEDURE
OF THE ORGANIZATION FOR SECURITY AND
CO-OPERATION IN EUROPE**

By the delegation of the Russian Federation (also on behalf of Belarus):

“In joining the consensus on the Permanent Council decision on approval of the 2014 Unified Budget, the Russian Federation and the Republic of Belarus do not undertake any commitments regarding the change to the procedure for financing the Augmentations Fund established by Permanent Council Decision No. 827 of 21 December 2007.

We take the position that similar questions, if they arise, should be examined in the Working Group on the Scales of Contributions, which was established to ‘comprehensively review all elements and criteria with regard to the scales of contributions’.

Any attempts to force unilateral approaches through the budget will only make it more difficult to adopt decisions on the budget in the future. We shall not tolerate them.

We request that the text of this statement be appended to the decision adopted and included in the journal of the day.”

**INTERPRETATIVE STATEMENT UNDER
PARAGRAPH IV.1(A)6 OF THE RULES OF PROCEDURE
OF THE ORGANIZATION FOR SECURITY AND
CO-OPERATION IN EUROPE**

By the delegation of the United States of America:

“Thank you, Mr. Chairperson.

The United States wishes to make the following interpretative statement under paragraph IV.1A (6) of the Rules of Procedure of the Organization for Security and Co-operation in Europe.

The United States sincerely thanks the Chairmanship, and particularly the efforts and hard work of the ACMF Chairs Alexander Hoffet and Mathew Quinn on helping us to achieve the adoption of the 2014 Unified Budget. This is an extraordinary year for the OSCE. As the crisis in Ukraine continues to capture much of our attention, your focus and dedication made it possible for the budget to be adopted today.

The United States has agreed to join consensus on the 2014 Unified Budget not because we are satisfied with the budget we have just passed, but because we are now more than five months into 2014, and the Organization needs a budget to allow it to move forward with its operations and implement programmes and activities. The United States, along with the majority of the participating States, were in fact prepared to accept the Chairmanship’s budget proposal of January 2014, but due to the unwillingness of very few participating States to engage in constructive negotiations, the adoption of the budget was delayed until now.

We regret that consensus was not found on funding a number of important activities that would position the OSCE to more effectively address today’s challenges and to move the Organization in a direction that would promote the comprehensive security of its participating States. Most disappointing is the exclusion of funding for the Border Management Staff College (BMSC) from the budget, blocked by one participating State despite repeated appeals from the host country, the fund manager, a large number of participating States, the Secretary General, and the Swiss Chairmanship to secure long-term financial sustainability for the college. The BMSC is a valuable OSCE institution, and we should secure its future, particularly ahead of the security challenges that are likely to come with Afghanistan’s security and political transitions in 2014. It is imperative that participating States come together and move to include the BMSC in the Unified Budget.

In the Western Balkans, which currently represents more than 60 per cent of total field missions' budget, we believe that further reductions should be sought. As the countries in the Balkans make progress towards greater Euro and Euro-Atlantic integration and consolidate democratic reforms, the logical evolution of OSCE operations in the region would be to work toward the handover of successful reform programs to other international and local actors. To this end, Western Balkans missions as well as field missions should look to the Mission in Bosnia and Herzegovina as a model to rightsize their funding and resource usage. Further funding reductions in South-Eastern Europe, where the security situation has improved significantly over the years of OSCE engagement, will make way for necessary budgetary increases in Central Asia, where challenges continue to grow.

Of serious concern are the inadequate funding levels for institutions – the Office for Democratic Institutions and Human Rights, the High Commissioner on National Minorities, and the Representative on Freedom on the Media – to properly carry out much needed work in line with their mandates. The ODIHR, in particular, is now at zero nominal growth, that is to say real cuts, for the fourth year in a row. This is unacceptable, and the trend cannot be sustained. Particularly for those who are critical of the ODIHR, they should see reason in resourcing it properly, or else silence their criticisms. These institutions need the appropriate funding and resources to effectively carry out their work, which grows each year while their funding does not. We must, as responsible members of this important Organization, help them achieve the work in the human dimension, as well as in the other dimensions, that we have tasked them to do.

We stress our deep disappointment with the dramatic reduction in the funding and staffing levels for the new office in Baku, which has severely limited the Project Co-ordinator in Baku's (PCB) ability to carry out its activities, and also undermined the mandate that participating States worked so hard to reach consensus on last year. We hope the PCB can still continue to conduct meaningful programmatic work in important areas of democratic development and greater governmental transparency.

We will continue to press for these priorities as we prepare for the 2015 Unified Budget negotiations, which will begin in just a few short months. We urge all delegations and their capitals to take a sincere look at the future of this Organization and the resources it needs to accomplish what we all know it can and must do to ensure our comprehensive security.

The United States requests that this statement be recorded to the journal of the day.

By the delegation of Armenia:

“Thank you Mr. Chairperson.

In regard to the adoption of the decision on approval of the 2014 Unified Budget the delegation of Armenia would like to state the following:

The delegation of Armenia was actively and constructively engaged in the discussions of the Unified Budget and we appreciate the co-operation that we received from almost all interested delegations. However, on various occasions we were faced with the reality that the controversial changes were made on revisions of the Unified Budget not on the merit of their wider acceptance but as a result of the position of one delegation. Therefore, it requires considerable efforts for the delegation of Armenia to join the consensus at this late stage of the adoption of the Unified Budget.

We reiterate that the issue of the illegal practice of non-refundable compensation of the local staff income tax should be abolished through joint efforts of the Chairmanship, the ACMF and the Secretariat. This issue cannot become a hostage of one participating State which does not present any arguments in favour of maintaining the current practice of compensation of local staff income tax, but does its utmost to get both taxation and compensation. The Armenian side looks forward to the discussions on addressing this issue. Without significant progress on this issue my delegation will not be in a position to endorse a budget envisaging compensation of local income tax.

The delegation of Armenia expresses its disappointment on the changes made on budget of the Personal Representative of the OSCE Chairperson-in-Office. We reiterate our principled position that the Office should be strengthened both in terms of staff and financial resources and have proper operational capacities, corresponding to the evolving needs on the ground.

We would like to request that this interpretative statement be attached to the decision adopted and included in the journal of the day.”

**INTERPRETATIVE STATEMENT UNDER
PARAGRAPH IV.1(A)6 OF THE RULES OF PROCEDURE
OF THE ORGANIZATION FOR SECURITY AND
CO-OPERATION IN EUROPE**

By the delegation of Canada:

“Canada wishes to make an interpretative statement in connection with the PC decision just adopted under paragraph IV.1(A)6 of the OSCE Rules of Procedure.

We would first like to thank the Swiss Chairmanship for its tireless efforts during the long negotiations on the 2014 Unified Budget.

While Canada joins consensus on this decision, we would like to make two comments.

First, we are concerned about the resources available for our three institutions, in particular the ODIHR and the HCNM, which will both remain at their 2013 levels. With their increasing workload and recognized expertise, it is essential that the institutions receive the resources necessary to carry out their mandates. It is disappointing that we continue to be unable to agree to do so, due to the opposition of a very small number of participating States.

Second, we take note of the minor increase in the budget of the Project Co-ordinator in Ukraine (PCU). We welcome the approval of security improvements to the office premises recommended by the Secretariat’s Security Management section. The safety and security of OSCE staff is our primary concern.

However, we are deeply disappointed to see cuts to the PCU’s programmatic activities. The OSCE is playing a key role in helping resolve the crisis in Ukraine, and has taken significant steps to that end, notably with the deployment of the Special Monitoring Mission. A decrease in programmatic activities sends contradictory signals about the commitment of all participating States to assist Ukraine.

In particular, we continue to believe that it is deeply misguided to cut back on programmatic activities at the current time in the areas of democratization/good governance and rule of law/human rights.

Mr. Chairperson, we request that this statement be attached to the decision adopted and reflected in the journal of the day.

**INTERPRETATIVE STATEMENT UNDER
PARAGRAPH IV.1(A)6 OF THE RULES OF PROCEDURE
OF THE ORGANIZATION FOR SECURITY AND
CO-OPERATION IN EUROPE**

By the European Union:

“The Member States of the European Union thank the Swiss Chairmanship for its tireless efforts which have made it possible to adopt the 2014 Unified Budget in a difficult economic and political context.

We deplore the delay in the adoption of the budget. A lack of co-operation on the part of some delegations, which have shown neither willingness to compromise nor a constructive commitment to finalize these negotiations in time, can only strengthen our belief that this budgetary process would benefit from being completely revised.

The work of the three independent institutions of the OSCE at the very time when violations of commitments are increasing requires unwavering support. On this point, we reluctantly joined the consensus while being convinced that the human and financial resources in this area are not sufficient to meet the current challenges. For the next budget, we shall call for the Unified Budget resources for the Office for Democratic Institutions and Human Rights, the Representative on Freedom of the Media and the High Commissioner on National Minorities to be sufficient to allow the complete fulfilment of their mandate. The persistent attempts by some participating States to use the budget negotiations to challenge the mandates of these institutions are unacceptable.

The failure to reach a consensus on a more ambitious budget for funds for the resolution of protracted conflicts or the implementation of Ministerial Council Decision No. 3/11, adopted in Vilnius, in particular the part concerning early action, sends a bad signal. This goes against the needs identified, especially this year with the events taking place in Ukraine showing that the OSCE should be provided with appropriate resources to respond quickly and effectively to crises.

Savings made by the field missions in South-East Europe thanks to significant reorganization efforts, particularly with regard to administrative costs, should be applauded and continued. The Secretariat's share of the budget should not increase at the expense of the budget for the missions and independent institutions. Despite the savings identified, we note with concern that some participating States continue to oppose significant reallocations of human and financial resources in Central Asia and places where they would be needed. We regret that the Border Management Staff College in Dushanbe was not included in the

Unified Budget as originally proposed. We appreciate the work of the College, which should benefit from a more sustainable financial basis.

The budget negotiations this year revealed the need to find a solution to the Augmentations Fund within the 2015 budget cycle respecting the Financial Regulations and the commitments undertaken by the participating States on their level of contribution.”
