DECISION No. 179

The Permanent Council,

Recalling its Decision No. 174 concerning the "concept for future ODIHR action" as presented in REF.OD/45/97 Restr..

- Approves the following amendments to the OSCE Post Table for ODIHR:
- 1. Upgrading of the post of Deputy Director (P5) to First Deputy Director (D1)
- 2. Establishment of a post of Second Deputy Director for Administration and Conference Services (P5)
- 3. Establishment of a post of Head of the Elections Section (P5)
- 4. Establishment of a post of Head of the Human Dimension Section (P5)
- 5. Establishment of a post of Elections Adviser (P3)
- 6. Deletion of the post of Conference Services Adviser (P2)
- 7. Establishment of one G7 post and two G5 posts for general support
- Decides that all posts shall be subject to a review of the classification of posts, as foreseen in PC Decision No. 150 (paragraph 3) and in line with Staff Regulation 3.01. This review shall be undertaken at the earliest possible date after submission by the Secretary General of his restructuring proposals for the Secretariat;
- Welcomes the intention of the Director of ODIHR to focus on operational topics as much as possible in the future planning of ODIHR Seminars;

- Approves, accordingly, the required supplementary funds for the following subprogrammes under the ODIHR budget for 1997:
