STATEMENT BY THE DELEGATION OF KYRGYZSTAN

Mr. Chairperson,

Allow me to thank Mr. Tesoriere, Head of the OSCE Centre in Kyrgyzstan, for his informative report.

The Kyrgyzstan Republic values highly the level of fruitful co-operation with the OSCE that has been attained. We take a positive view of the activities of the mission in Bishkek in strengthening collaboration between Kyrgyzstan and the OSCE under the terms of the Centre's mandate. One example of successful co-operation with the OSCE can be seen in the implementation of the programme to assist the internal affairs agencies in their work and the programme to reform the country's Ministry of Internal Affairs. We are interested in continuing this project in the light of the ongoing reforms of the country's law enforcement and judicial systems. We support the activities of the OSCE Academy in Bishkek, which has become one of the important educational projects in Central Asia.

We note that the information presented in the report deals not only with a number of current problems but also certain events that took place last year. These events were the subject of an exchange of statements, and we do not believe there is any need to return to them at this time.

As priority areas for future co-operation with the OSCE, we call attention to Kyrgyzstan's involvement in the rehabilitation of Afghanistan and the opening of a customs centre in Bishkek. We consider it important that there be international assistance in reforming the prison system. Kyrgyzstan especially needs help in solving the problem of renovating tailings storage facilities for radioactive and toxic waste, which pose an environmental threat to the entire Central Asian region. There must be a stronger focus on this subject with a view to identifying sources of funding.

In conclusion, we note that Kyrgyzstan is prepared in every way to strengthen and expand further co-operation with the OSCE.
