STATEMENT BY THE DELEGATION OF AUSTRALIA

Thank you, Mr. Chairperson.

The Australian delegation welcomes and supports the comments made by our colleague from the Netherlands marking the second anniversary of the downing of Malaysian Airlines flight 17.

Today, our thoughts remain with the families and friends of the 298 people on board MH17, especially the 38 people that called Australia home. We, like they, will never forget this terrible tragedy.

Our key priority now is bringing those individuals responsible for the downing of MH17 to justice, in accordance with the demand for accountability expressed in UN Security Council resolution 2166.

We echo our colleagues' call for the co-operation of all States in a position to do so to assist with the investigation and prosecution of those responsible.

A thorough and robust investigation will be crucial in securing justice for all of the victims.

We will continue to work with our partners in the Joint Investigation Team – Belgium, Malaysia, the Netherlands and Ukraine – on a prosecution mechanism to ensure those responsible are held to account.

In closing, I would like to reiterate Australia's appreciation to the OSCE and the Special Monitoring Mission for their critical role in facilitating access to the site immediately following the tragedy.

I request that this statement be included in the journal of the day.

INTERPRETATIVE STATEMENT UNDER PARAGRAPH IV.1(A)6 OF THE RULES OF PROCEDURE OF THE ORGANIZATION FOR SECURITY AND CO-OPERATION IN EUROPE

By the delegation of the Russian Federation:

"In connection with the adoption of the Permanent Council decision on the dates and agenda of the 2016 OSCE Economic and Environmental Dimension Implementation Meeting, we should like to make the following statement.

We take the position that the Meeting should provide a framework for enhancing dialogue and co-operation on key thematic areas within the economic and environmental dimension, as provided for in Permanent Council Decision No. 995 of 31 March 2011. The development of co-operation in the field of energy remains at the focus of this OSCE dimension. We expect that a substantive discussion on the aspects of energy co-operation set out in the relevant Ministerial Council decisions will be organized during the Meeting. We believe it useful to focus on the important questions for all participating States of increasing energy efficiency and reducing the negative impact on the environment of energy production, transportation and consumption. We trust that the discussions will be depoliticized and oriented towards strengthening confidence and developing good-neighbourly relations.

I request that this statement be appended to the Permanent Council decision adopted, and included in the journal of the day."

Decides to hold the 2016 OSCE Mediterranean Conference on the topic "Youth north and south of the Mediterranean: facing security challenges and enhancing opportunities";

Vienna, 5 and 6 October 2016

I. Indicative agenda

Introduction

Recent and current developments demonstrate the inextricable link between comprehensive security of the OSCE area and the Mediterranean region. Violent extremism, radicalisation and terrorism as well as current migration trends are amongst the most pressing challenges as is witnessed also in current OSCE discussions. Youth is the population group most widely affected by these trends, be it north or south of the Mediterranean. Youth is the present and the future of our societies and thus needs the continued attention of policy makers.

The 2016 OSCE Mediterranean Conference will therefore focus on the topic of challenges for comprehensive security and youth north and south of the Mediterranean, adopting a cross-dimensional approach to the issue.

The two sessions on the first day will delve into this issue to look at lessons learned and best practices as well as ways to shape constructive future perspectives. The session on the second day of the Conference is aiming at high-level participation and shall allow a broader, political discussion on the challenges related to comprehensive security and youth.

The Conference will provide space to exchange views from north and south of the Mediterranean. OSCE participating States and Mediterranean Partners will have the opportunity to share experiences as well as formulating forward-looking recommendations in order to strengthen dialogue and enhance concrete co-operation for the sake of common security with a special focus on youth.

Representatives of non-governmental organizations may be invited by the host country to attend and may be invited to contribute to the Conference in accordance with the relevant OSCE provisions and practices (advance registration required).

Other countries may be invited by the host country to attend and may be invited to contribute to the conference.

III. Organizational modalities

The Conference will begin at 9.30 a.m. on the first day, and end at 1 p.m. on the second day.

Each session will have a moderator and a rapporteur appointed by the Chairperson. The consolidated summary will be forwarded to the Permanent Council for further consideration.

Appropriate arrangements for press coverage will be made.

The working languages will be English and French. These arrangements will not constitute a precedent that can be relied upon in other circumstances.

The Rules of Procedure of the OSCE will be followed, *mutatis mutandis*, at the Conference. Also, the guidelines for organizing OSCE meetings (Permanent Council Decision No. 762) will be taken in account.
