STATEMENT BY THE DELEGATION OF MALTA

Mr. Chairperson,

I take the floor today to update the Permanent Council and the OSCE Representative on Freedom of the Media on an important development in the investigation into the murder of Maltese journalist Daphne Caruana Galizia, who was killed by a car bomb as she was driving away from her home on 16 October 2017.

On 16 July 2019, Malta's Attorney General issued a bill of indictment bringing formal charges against the three men accused of having committed the murder. The compilation of evidence before the Court of Magistrates sitting as a court of criminal inquiry has been ongoing since their arrest on 4 December 2017, 49 days after Ms. Caruana Galizia's murder. The three co-accused will now stand trial, with the proceedings to be presided over by a judge whose name was drawn by lot.

The 18-page bill of indictment lists six charges against the co-accused, including wilful homicide, detonation of an explosive causing the death of a person, possession of explosive material, and membership of a criminal organization. The three co-accused are facing the prospect of life imprisonment, since two of the offences they stand accused of are punishable with the maximum penalty under Maltese law.

The fact that the three co-accused have been served with a bill of indictment means that they are not eligible for bail anymore.

The Government of Malta welcomes this positive development, and further reiterates its determination that there will be no impunity in this case, and that justice will be done.

As in the past, we remain willing and ready to provide both the Permanent Council and the OSCE Representative on Freedom of the Media with further updates on any developments in this case.
