## Police reform initiatives in Armenia discussed at OSCE Office meeting

co-ordination meeting hosted by the OSCE Office in Yerevan on 14 May brought together the Deputy Head of the Armenian Police, Artur Osikyan, representatives of state and international bodies and experts to discuss police reform proposals and possible areas for co-operation.

The participants of the event discussed improving police services, co-operation with civil society on draft legislative initiatives and ways to make international assistance for police reforms more effective.

Ambassador Sergey Kapinos, Head of the OSCE Office in Yerevan, said that the Office aims to contribute to the process of police reform in the country to further develop modern democratic policing practices.

"We look forward to assisting in addressing structural challenges as well as continuing to help build public trust," he said.

Mr. Osikyan presented a comprehensive package of police reform initiatives in such areas as public order management, police educational reform, traffic police, visa and passport procedures, combating organized crime and internal oversight and anticorruption. The proposals incorporate the community based policing approach, which has been put into practice in the Arabkir Police District since 2008.

The OSCE-supported police education reform package was presented at the event for inclusion in the country's reform strategy. The Office also presented its publications on democratic policing practices in Armenia.

Mr. Osikyan and Ambassador Kapinos went on to present Armenia's police reform to the OSCE participating States at the OSCE Secretariat in Vienna in the beginning of June.

In 2003, the OSCE Office in Yerevan initiated a comprehensive police assistance programme aimed at building trust and confidence between the police and the society through introduction of community-oriented policing model and improved training standards.

## Head of Office discusses judicial reforms with Justice Minister, Prosecutor-General

At his meeting with Prosecutor General Agvan Hovsepyan on 4 May, the Head of the OSCE Office discussed the implementation of recommendations contained in the OSCE Office for Democratic Institutions and Human Rights (ODIHR) report on the trials that took place in the aftermath of the March 2008 post-election violence in Yerevan.

Ambassador Kapinos noted the Prosecutor General's constructive approach to the recommendations.

"We were glad to learn that some of the ODIHR recommendations were immediately accepted, and we understand that certain recommendations will need time to be implemented," he said.

He also welcomed the Prosecutor General's pledge to investigate cases of alleged violence against journalists and to boost the Prosecutor's role in police accountability mechanisms, a challenge addressed in a recent report by the OSCE Office.

Hovsepyan, in turn, said that his office highly

appreciates the support from the OSCE to reveal shortcomings and find compre-hensive solutions to help advance the rule of law and efficiency of the justice system in Armenia.

ODIHR's trial monitoring report was also brought up at the meeting with Justice Minister Gevorg Danielyan on 1 June.

Ambassador Kapinos commended the Justice Ministry for the co-operation in implementing the recommendations included in the report. He also expressed willingness to contribute further to the ongoing judicial reforms and offered international legal expertise for Armenia's draft Criminal Procedure Code.

The Ambassador and the Minister also discussed the penitentiary reforms, an important topic for both the Ministry and the Office

Lastly, Ambassador Kapinos noted the importance of ensuring the right to freedom of assembly as that right represents one of the most important human dimension commitments of the OSCE.

### OSCE Office helps Armenia fight corruption

YEREVAN, 23 April - An OSCE-supported project that aims to address corruption risks related to traffic regulation by monitoring traffic registrations and drivers' license examinations concluded with a presentation in Yerevan.



The project, implemented by non-governmental organization Achilles with support from the OSCE Office in Yerevan, included monitoring of the testing procedures for obtaining drivers licenses at the Police Registration and Examination Departments. It also included activities to inform drivers about their rights through television and radio programmes and the distribution of information materials as well as legal consultations. Another outcome of the project is a set of recommendations on traffic regulation improvements.

### OSCE Office assists in experience exchange by the Ombudsman institution

YEREVAN, 27 May - Representatives of Armenia's Human Rights Defender's Office concluded a three-day study visit to Slovenia organized by the OSCE Office in Yerevan to strengthen the institution's capacity to prevent torture and ill-treatment.

The Armenian experts met Slovenia's Deputy Ombudsman and colleagues, as well as representatives of non-governmental organizations and visited a police station and a prison in Ljubljana. They discussed the experiences of the Slovenian Human Rights Ombudsman as the country's designated National Preventive Mechanism (NPM).

## OSCE Office supports Armenia's efforts in fostering competitive business environment

YEREVAN, 2 June - The OSCE Office in Yerevan and the State Commission on Protection of Economic Competition signed a co-operation agreement to strengthen the legal framework and practice in this area and to support sustainable socioeconomic development.

Under the agreement, the OSCE Office in Yerevan will support competition strategies in line with international good practice. It will also help develop and introduce a comprehensive system of indicators to foster efficient competition policies, and it will support Armenian partnership with the International Competition Network.

#### Environmental challenges discussed at **Model OSCE Conference in Kapan**

Applying OSCE mechanisms to solve environmental security problems in the hypothetical countries of Valouchistan, Dakastan and Abrala was the purpose of a student Model OSCE conference held in Kapan, in Syunik region on

The two-day event brought together 24 students from various cities of the region. The topics on the agenda of the simulated OSCE Permanent Council session included environmental and economic challenges relevant to the situation in Syunik.

"Enabling young people to learn about the OSCE structures and decision-making processes is vital in promoting their awareness on international mechanisms to address security-related problems. Hopefully, this experience will also motivate them to get involved in civic activity in their localities," said Grzegorz Michalski, Politico-Military Officer at the OSCE Office in Yerevan.

Satenik Baghdasaryan, Political Science student from Yerevan State University who participated in the event said: "The event gave us an opportunity to use our negotiation, problem solving and argumentation skills in situations close to real life. We realized that only by joining efforts and enhanced cross-border co-operation is it possible to counter global environmental challenges in today's interconnected world."

The conference was preceded by lectures on the OSCE structure, a training session on environmental matters, public speaking and negotiation skills, as well as presentations on the OSCE work in the economic-environmental dimension.

The event was the third regional conference of the kind held by the OSCE Office in Yerevan to promote OSCE principles and values among young people in Armenia.

#### OSCE supports education for disadvantaged children in Syunik region

n extracurricular education centre for children from socially and economically disadvantaged families, supported by the OSCE Programme Implementation Presence in Syunik was founded in the town of Kapan.

Representatives of local authorities, civil society organizations and educational institutions, as well as the children and their parents attended the opening ceremony held on 19 March.


"We hope that the centre will help support better integration of the children and develop their skills and talents to safeguard children's rights," Christoph Opfermann, the OSCE Office Economic and Environmental Officer, said at the ceremony.

The school was refurbished and equipped by the Syunik Diocese of Armenian Apostolic Church and the local authorities and is run by the OSCE-supported Women Resource Centre in Kapan.

The school is open four days a week to provide support to 65 to 70 disadvantaged children from Kapan and surrounding villages, including child beggars.

The specially designed arts and crafts programme provides children with an opportunity to develop their talents in this area, with the school premises serving as a showroom for the children's artworks.

The Kapan Public Environmental Information



(Aarhus) Centre supports the school with courses and lectures on environment, biodiversity and environmental protection and organizes local tours to nature reserves and places of cultural and historical interest.

The project was financed by contributions from the OSCE participating States at the annual OSCE Charity Ball.

#### Diplomatic school established with OSCE support

Armenia's new diplomatic school opened its doors to its first students in February. The school, set up by the Armenian Foreign Ministry with the support of the OSCE and the European Union, is the first initiative in Armenia to provide comprehensive professional training for future diplomats. Targeted at postgraduate students, the 9-month course is taught by prominent local and international trainers. It is expected that the top students will be offered employment by the Armenian Foreign Ministry.

In addition to helping identify trainers for the school and assisting in developing the curriculum, the OSCE Office provided equipment for the computer lab. It also provided support in the process of selecting applicants.

The idea to establish a diplomatic academy in Armenia goes back to 2006 when the OSCE Office organized a targeted training for the staff of the Ministry of Foreign Affairs within the framework of a training programme for parliamentary staff. The project initially moved forward as periodic short-term training courses for the Ministry's staff. To address the needs of

the Armenian Foreign Ministry, the Office proposed to institutionalize the training by creating a formal school that would prepare a pool of qualified potential diplomats.

As a next step, in 2008 the Office in Yerevan commissioned a needs assessment which was conducted by a team of scholars from the Hamburg-based research institute CORE (Centre for OSCE Research).

The team came up with a number of recommendations and suggestions, including on the status and functions of the school, identification of the training and professional capacity-building needs, potential courses and management schemes.

The curriculum covers Armenian foreign policy, the theory and history of diplomacy, international law and trade regulations, and concepts of international relations. The course also includes European integration, Armenia's relations with its neighbours, as well as the workings of international organizations. Global challenges, like poverty, ecological threats and terrorism will also be in the focus of discussions in the school.

The second part of the course develops practical skills, and includes simulation exercises on international negotiations, political analysis, diplomatic protocol, public speaking and presentation skills as well as study visits to state institutions and foreign embassies.

#### OSCE supported publication highlights violence and legal cases against journalists in Armenia

compilation of articles discussing violence, intimidation and legal cases against journalists in 2008-2009, published with support of the Office in Yerevan, was presented on 3 March.

The publication was supported by the OSCE and produced by the non-governmental organization Investigative Journalists. It looks at seven cases of violence and intimidation against journalists and analyzes seven libel and slander cases involving journalists, noting that the perpetrators in several of the violent attacks remain unknown. A collection of scientific and practical commentaries to the Armenian Constitution was presented at the National Arts Gallery of Armenia on 16 June as this year marks the 15th anniversary of the Armenian Constitution and the Constitutional Court.

**Commentaries to Armenian Constitution published** 

The publication, made possible with the support of the OSCE Office in Yerevan and Germany's Gesellschaft für Technische Zusammenarbeit (GTZ Armenia), was elaborated by 68 Armenian legal experts, lawyers and scholars. It provides interpretations of the fundamental values of the Armenian Constitution, as well as the constitutional and legal nature of its goals and principles.

The book offers guidance and practical examples of the Constitutional Court rulings that should be applied by the country's state institutions, courts, lawyers and other relevant parties in their daily work; it could be also useful for the public in general.

Armenian President Serzh Sargsyan and Prime Minister Tigran Sargsyan were among those attending the event that brought together representatives from state bodies, scientific institutions, the civil society organizations, foreign diplomatic missions and international organizations.

#### Other publications

Study on religious tolerance in Armenia

The study was conducted in 2009 by the Collaboration for Democracy Centre NGO, with the support of the OSCE Office. The report includes interviews, review and analysis of press, reports and studies, analysis of legislation and recommendations to the authorities.

Manuals on how to register a business in Armenia and small and medium enterprise (SME) support programmes

The updated version of a guide on how to register businesses in Armenia and the reference book on support programmes for small and medium enterprises are a part of the Office's attempts to support business owners, policy makers and business associations in expanding the SME sector.

A guide and a brochure on the rights of detained, arrested and convicted persons

These two publications have been elaborated and updated by

the Civil Society Institute NGO. The publications aim to serve as a source of reference and guidance for the staff of penitentiary and detention facilities and to provide the persons deprived of their liberty with detailed information on their rights.

#### Manual on combating human trafficking

The manual examines international and national legal frameworks, methods of prevention and victim protection, challenges in investigating and prosecuting trafficking cases and is designed to train prosecutors, police, judges, border guards and labour inspectors. The book was developed jointly by the OSCE, the International Labour Organization and the UN Development Programme (UNDP).

A survey on the awareness of labour rights and the role of trade unions among youth

The aim of the research is to form a framework for discussion on labour rights and employment issues. It also aims to promote awareness of labour rights among Armenian youth and to increase the role of trade unions in promoting these rights for better working conditions for the Armenian youth.

### Photo exhibition in Yerevan marks World Press Freedom Day



'Freedom of Press: the Right to Know' photo exhibition to mark the World Press Freedom Day opened in Yerevan on 3 May.

The one-week event was organized by the Freedom of Information Centre of Armenia, a non-governmental organization, in co-operation with the OSCE Office in Yerevan and the UN Department of Public Information, and was funded by the US Agency for International Development (USAID). The exhibition on free speech and information featured more than 30 photos selected from among 300 submitted.

Free access to information is a key to the respect of human dignity and it enables citizens to take an active part in public life as well as exercise their other human rights. This exhibition is a good opportunity to highlight these issues and stimulate discussion.

Journalists, representatives of state institutions and the civil society attended the opening ceremony.

Shushan Doydoyan of the Freedom of Information Centre said that the exhibition was special since everyone journalists and professional photographers in particular - were invited to present their work illustrating freedom of information and freedom of expression. "These basic rights are intrinsically linked to freedom of press, which in turn contributes to strengthening democratization, good governance and human development," she added.
