

	A regional Informal Working Group (IWG) provides a forum for Passenger Information Units (PIUs) and the policy makers involved in the establishment of such units to support the implementation of UN Security Council resolutions 2178 (2014), 2396 (2017), and 2482 (2019). It fosters the widest possible co-operation and exchange of information between PIUs based on reciprocity or mutual agreement and following commonly agreed principles and rules. The OSCE has launched the Eastern European IWG in co-operation with UNOCT and will work with the OSCE pS that are not part of the EU IWG. The EE IWG will be a platform for discussing the latest developments and challenges for air and maritime passenger information. Therefore, Session 1 will focus on the recent launch of the EE IWG and present the forthcoming steps.
