## Conference “The Public-Private Partnership in the Fight Against Human Trafficking”

**Moscow, 20-21 July 2017**

A report of the International Trade Union Confederation indicates that the 50 top global companies, having combined revenue of 3.4 trillion USD, may have a hidden workforce of 116 million people. According to a recent report of the Ethical Trading Initiative, a leading alliance of companies, trade unions and NGOs that promotes respect for workers' rights around the globe, 71% of global companies surveyed in the United Kingdom believe there is a likelihood of modern slavery occurring in their global operations. Despite 20 years of efforts, the sexual exploitation of children in travel and tourism (SECTT) has expanded across the globe and out-paced every attempt to respond at the international and national level. The results of the first comprehensive global study on SECTT confirm that no region is untouched by this crime and no country is ‘immune’.

These statistics allow us to conclude that the risks of human trafficking in the private sector are real, as it is difficult for buyers and consumers to be sure that the goods or services that they purchase or procure were not produced by child, forced or trafficked labour, and they have to be addressed in a comprehensive way.

The Moscow Conference will discuss the relevant international frameworks and instruments, the incidence/magnitude of trafficking for labour exploitation in the private economy, the roles of governments and private sector, the OSCE projects and activities and prevention of human trafficking in the private sector, building on existing experience and lessons learned in other countries around the world, promising prevention methods and measures to minimize the risk of human trafficking, especially for labour exploitation.

The Conference will strive to increase awareness about the partnership between governments and private sector in fighting THB, establish networks and communities of practice in the OSCE area comprised of government experts and private sector representatives on the issue of combating THB, take stock of promising practices how to address the gaps and challenges in policy and implementation in the OSCE area and raise awareness and provide recommendations to state authorities in the OSCE area on helping businesses to prevent and combat THB.

14:00 – 15:30 **Panel 2 - International and national norms and practices. The government role and responsibility to prevent and combat THB**

*The second panel will discuss how state authorities in the OSCE area are responding to trafficking in human beings in the private sector.
