STATEMENT BY THE DELEGATION OF THE UNITED KINGDOM

Thank you, Madam Chairperson.

Delegations will recall that the decision made by ministers in Vilnius (MC.DEC/6/11) encouraged participating States to provide extrabudgetary contributions in support of OSCE SCA projects. In demonstration of the United Kingdom's ongoing commitment to these activities, I am very pleased to inform you that the United Kingdom is donating a sum of 50,000 GBP (approximately 59,000 euros) to the OSCE-UNDP Capacity Development Programme for Conventional Ammunition Stockpile Management in the Republic of Serbia.

Having discussed this donation with colleagues in London, the Conflict Prevention Centre, Serbia and the FSC co-ordinator for SALW/SCA projects, it is the United Kingdom's wish that this money is spent primarily on the destruction of Class H ammunition, which contains phosphorous, owing to its particularly volatile and dangerous nature. The United Kingdom is delighted to be able to support this important project and is confident that it will make a meaningful difference to safety and security in the area affected.

STATEMENT BY THE DELEGATION OF SERBIA

Thank you, Madam Chairperson.

Ladies and gentlemen,

We would like to express our gratitude for the valuable contributions that the Kingdom of Spain and the United Kingdom intend to make to the practical implementation to the OSCE-UNDP Capacity Development Programme for Conventional Ammunition Stockpile Management in the Republic of Serbia.
