I. Opening and Closing Sessions

At the opening and closing sessions, only the delegations of OSCE participating States can make statements.


To sign up, delegates can approach the back table in the plenary hall, as of 1 hour before the session. Delegations will also have the option to sign up via the back table during the opening and closing sessions.

II. Thematic Plenary Sessions


Instructions for participants:

1. At thematic plenary sessions, all participants may request the floor on behalf of their delegations/organizations.
2. To request the floor, participants must sign up for the Speakers' list for the relevant sessions at <https://meetings.odihr.pl>.
3. There will be 40 slots on the speakers' list and 20 on the reserve list. The list of speakers, including the reserve list, will be published on meetings.odihr.pl and shared on the doors of the plenary hall.

Regarding Rights of Reply:

OSCE participating States wishing to exercise their Right of Reply (RoR) regarding a statement made by another participant during plenary sessions must submit their RoR in writing (a maximum of one per participating State for a given session). Delegations should notify the head table during the session if they intend to submit an RoR. The moderators of the thematic sessions will inform participants about the announced RoRs before the end of the session. The RoRs will be made available to all participants on the meetings.odihr.pl platform, where they should be submitted electronically by participating States within 24 hours from the end of the respective session.
