





# **Advanced Course on Gender Equality in Politics**

A specialised course for staff of governmental bodies for gender equality

July-August 2025 (online learning)
Tuesday-Friday, 9-12 September 2025 (four-day, in-person training in Stockholm, Sweden)
October-December 2025 (online learning and consultations)

Why this Course? In 2025, states in Europe and Central Asia, together with the rest of the globe, are marking the 30<sup>th</sup> anniversary of the Beijing Platform for Action, a central set of international norms on women's rights and gender equality. The Beijing Platform for Action sets women's full and equal participation in politics and decision-making as one of twelve priority areas and calls upon UN member States to set up or strengthen their institutional mechanisms/governmental bodies for the advancement of women and of gender equality (IMGEs). Reflecting on the last 30 years, Europe and neighbouring regions have seen a farreaching development. To name a few of the major achievements: states have tripled the average number of female parliamentarians (31.6%), they adopted revolutionary gender equality laws, and set up stronger ministries, government agencies and councils that lead on gender equality policy. 26 states also introduced legislative gender quotas and dozens of parliamentary political parties committed to voluntary representation targets and measures, all aiming at decreasing male over-representation and targeting gender balanced politics in the long run.

Nevertheless, advancing gender equality in politics in many countries is still not a governmental national policy priority. While the majority of states have adopted some form of multi-year national gender equality strategy, programme or action plan, aiming at addressing key policy issues, like violence against women, women's economic participation or gender-based discrimination, a lot of them have not committed to comprehensive approaches in order to advance women's political participation and gender equality in politics. In fact, governmental bodies in charge for gender equality policy often refrain from engaging with political parties, considering them as non-state actors and in that way beyond the scope of work of the executive. At the same time, Europe is facing partial stagnation in women's political representation. While the percent of female ministers is still gradually increasing, the number of women parliamentarians is standing on the same level for the last five years. The 2024 General Recommendation No 40 of the CEDAW Committee is a reminder and call for action towards all actors, including governments, for a renewed commitment towards gender parity (50/50).

Thematic and specialized learning opportunities on gender equality in politics are limited, especially for staff and leadership of IMGEs. In order to fill this gap, the *Advanced Course on Gender Equality in Politics*, provides to those who complete it with necessary knowledge,

qualifications and skills to contribute to fostering the advancement of gender equality in politics and of gender-responsive governance through policy, legislation and programming.

**Course objective:** The course aims to equip selected staff of IMGEs with knowledge, skills, and competences to understand, critically assess, and apply concepts, methods and tools of gender equality in politics. The aim is to contribute towards successful leadership, gender analysis, and IMGEs policy development and programming in this area.

Specifically, the course aims for following **learning outcomes**:

- Good understanding of concepts, tools, and methods of advancing women's political participation, gender equality in politics and gender-responsive governance;
- Ability to integrate gender equality in politics as a policy issue in IMGE policy development and programming;
- Demonstrate skills in presenting, communicating, and influencing on gender equality in politics.

Course duration and format: The course will be implemented in three phases, starting with online learning in July and August 2025. In the second phase, participants will attend a four-day in-person training, 9-12 September 2025 in Stockholm, Sweden. Finally, after the in-person training, in the third phase participants will have to complete another online learning exercise and apply the learning from October to December 2025. All sessions will be run in English language. After completing all phases, participants will receive a certificate.

Course target audience: The course is designed for IMGE leadership (senior and middle management) and staff that work on the broader policy issue of 'gender equality in politics' in Europe and Central Asia. Specifically, the course is open for IMGE staff that are a) heading departments/units/sections, b) conducting analysis/advising management and political leadership, and/or c) directly involved in conceptualising, overseeing, and/or implementing policies/programmes/projects on advancing women's political participation, gender-responsive governance and/or gender equality in politics in general.

Course partners: The Course is a collaborative initiative of the OSCE Office for Democratic Institutions and Human Rights (OSCE/ODIHR), the UN Women Europe and Central Asia Regional Office (UN Women ECARO), and the Government Offices of Sweden – who act as host and co-organizer for this training. The training is also kindly supported by the Riksdag – the Swedish Parliament.
