



A silent war on women – ending femicides in the OSCE region

In 2021 approximately 45,000 women were killed across the world by an intimate partner or other family members.¹ In the OSCE participating states, the number of femicides (or gender-related killings of women and girls) has also seen an alarming increase in recent months sparking growing concerns and protests against the failure of current mechanisms to prevent femicides and end this ‘Silent War’ against women and girls.

Number of OSCE participating States are collecting separate administrative data on femicide, while some of them have also established national preventive mechanisms such as Femicide Watch, Observatories or Homicide Review Panels. At the same time, reports note number of challenges such as the incoherent approach to terminology, sometimes even within the same country. This translates to a lack of legal definitions and tools, limited ability to collect relevant data, and general lack of accountability.

The OSCE has a strong commitment in fighting violence against women and girls, firmly anchored in the 2004 OSCE Action Plan for the Promotion of Gender Equality and three key Ministerial Council Decisions on eliminating violence against women (MC.DEC 15/5, 7/14 and 4/18). They note harmful and deadly consequences of violence against women (VAW), provide specific commitments concerning protection and urge for the improvement of data collection, as key element in measuring the scope of violence and its consequences.

In line with the OSCE framework, in 2016 the OSCE Gender Issues Programme (GIP) organized a conference *Combating Femicide in the OSCE region*, discussing the importance of a systematic collection and documentation of data on gender-related killings of women and girls, which constitutes an important part of tackling the root causes of this issue. In 2020, the OSCE/GIP also commissioned study on *Capacity of National Stakeholders to Combat Femicide in the OSCE region*. The study mapped good practices and trends in participating States on the prevention of femicide and provided recommendations on establishing or improving national and sub-national mechanisms to collect data and to combat femicide and other forms of violence against women. Since then, number of actions have been taken to address the violence against women across OSCE region, aiming to support policy development, raise awareness and strengthen data collection.
